That this Synod asks that a Canon amending Canon B8 be introduced to give Ministers discretion by agreeing with Church Councils to dispense with the provisions relating to the vesture of ordained and authorised ministers during the time of divine service.'

ELECTION OF CHURCHWARDENS AND PAROCHIAL CHURCH COUNCILS

to move on behalf of the Sheffield Diocesan Synod

- 807 'That this Synod ask that legislation be introduced to
 - (a) enable elections at the annual parochial church meetings and the meeting for elections of churchwardens to be conducted on numbered voting papers such as are

used in national and local government elections; and

(b) remove, in cases where that practice is followed, the requirement that voting papers used be signed by the voter on the reverse thereof.'

REPRESENTATION OF RETIRED CLERGY

to move on behalf of the Manchester Diocesan Synod

- 'That this Synod believe that the restriction on the election or choice of retired non stipendiary Clerks in holy Orders including Ordained Local Ministers as members of the House of Clergy of a Deanery Synod contained in paragraph 24(2)(e) of the Church Representation Rules should be removed and request that the following amendments to Rule 24 are made:
 - (a) in paragraph 2(e) **delete** the words "who are in receipt of a pension in accordance with the provisions of the Clergy Pensions Measure 1961 at the relevant date" and the words "in receipt of such a pension, are";

(b) in paragraph 4, (i) **delete** the words "the relevant date shall be" and **insert** the words "as soon as possible after" and (ii) **delete** the words "and as soon as possible after that date"."

MARRIAGE IN CHURCH AFTER DIVORCE

The Revd David Houlding to move on behalf of the London Diocesan Synod

809 'That this Synod

- (a) accept that there are exceptional circumstances in which a divorced person may be married in church during the lifetime of a former spouse;
- (b) believe that the recommendations of the working party as summarised in chapter 9 of the Report *Marriage in Church After Divorce* will lead to remarriage in church becoming normative, and on a par with first time marriage, rather than an exceptional provision, and therefore reject those recommendations;

- (c) reaffirm its commitment to Canon B30.
- (d) request the House of Bishops to bring forward proposals for the establishment of diocesan, regional or provincial panels, along the lines of those established by the Anglican Church of Canada, to review all applications for remarriage;
- (e) request the House of Bishops be to draw up pastoral guidelines for the diocesan, regional or provincial panels to reflect the understanding that the Church regards remarriage as an exceptional provision and to take into account all known circumstances of the breakdown of the applicants' previous marriage(s);
- (f) request the Archbishop of Canterbury to permit the grant of special licences to make provision for those suitably recommended to be married, if not in their parish church, to be married in a church within their deanery, by the clergy using their right under civil law to act as registrars; and
- (g) request the Standing Committee of the Convocation of Canterbury to bring

forward proposals to amend the 1957 Act of Convocation in line with (f) above.'
