CHURCH STATISTICS

Although, in the interests of economy, publication of the comprehensive statistical survey the Church 'Facts and Figures about the Church of England' ended with the third in the series in 1966, the demand continues for up to date and frequent information about all aspects of the life and work of the Church. Within the limited scope of the Year Book it is not possible either to publish all the statistical information collected and compiled by the Statistics Department of the Central Board of Finance, or to produce such information as a model of statistical presentation. This section of the Year Book has therefore been restricted to those tables and diagrams which are known to be of major interest and value, and which are also fundamental to the much wider store of information obtainable from the Statistics Department.

Clergy Statistics are included to compare the actual numbers of clergy in the dioceses in 1977 with the numbers expected to be available in 1981/82 distributed in accordance with the deployment formula contained in the Sheffield Report (GS 205). The 1981/82 predictions are based on current loss trends, and in this context attention is drawn to those tables showing the age structure of the existing clergy, the pattern of retirement, and the numbers of ordinands and ordination candidates.

Parish Returns Returns of membership and finance for the year 1976 were collected from the parishes in all dioceses. Statistics for 1976 included in the foregoing tables are estimates based on a sample of those returns. The full statistics evaluated from the returns will be sent to dioceses early in 1978, and will be published in the 1979 edition of the Year Book.

Membership With the fall in the birth rate fewer infant baptisms were to be expected. There was, however, an increase in the number of adult baptisms. The increase in the number of confirmations in 1975 was not maintained in 1976. Over a three year period there was very little change in the numbers of Easter and Christmas communicants, but persons attended Sunday services. Reports from the parishes clearly suggest that statistics relating to church attendance and communicants are no longer an indication of the full support the Church is now receiving. It is intended that the changing patterns of worship and church-going shall be the subject of a pilot survey in 1978.

Finance There was a 68 per cent rate of inflation, as measured from the Retail Price Index between 1973 and 1976. In the same period parish incomes increased by less than 50 per cent. Ordinary expenditure increased at almost the rate of inflation, but there was a severe cut in expenditure on capital projects, resulting in an increase in total expenditure of about 40 per cent.

Provinces of Canterbury and York



DIAGRAM II.—PLANNED GIVING INCOMES OF PAROCHIAL CHURCH COUNCILS, 1964-1976




DIAGRAM III.—TOTAL VOLUNTARY INCOMES OF PAROCHIAL CHURCH COUNCILS, 1964-1976




DIAGRAM IV.—ORDINARY ANNUAL INCOMES OF PAROCHIAL CHURCH COUNCILS, 1964-1976




DIAGRAM V.—TOTAL INCOME OF PAROCHIAL CHURCH COUNCILS, 1964-1976







POPULATIONS

1. The ensuing tables and diagrams are produced to meet an increasing demand for up-to-date and reliably based population data which is required for planning purposes.
2. At the request of the Central Board of Finance and the Church Commissioners, the Office of Population Censuses and Surveys (O.P.C.S.) as a special exercise compiled 1971 Census population figures for each of the Church of England diocesan areas.
3. O.P.C.S. publishes mid-year estimates and forward projections for the populations of the local authority areas which, except in a few cases, are not co-terminus with diocesan areas. The Statistics Department converts the populations of local authority areas into those for diocesan areas, taking into account any diocesan boundary changes.

Projections

4. The first diocesan population projections were calculated from O.P.C.S. projections for the Standard Regions only. Subsequently O.P.C.S. published projections for each of the counties, and it has now been possible to project diocesan populations with greater precision. The next O.P.C.S. projections will be down to district level, based on the mid-1975 estimated populations, and these will be used for the next revision of diocesan population figures.
5. Projections are made by the demographic component method. This involves taking the number of people at each single age and estimating how many will survive to be one year older next year. The age structure of people entering and leaving each area is taken into account. It is therefore necessary to make assumptions on the future numbers of births, deaths and migrants.
6. Projections made in 1964 suggested that the population of England as a whole would grow from 44.7 to 51.5 million by 1981. The birth rates were then at their highest level since the end of the last war, and the increase in fertility that had gone on since 1954 was expected to continue. However, since 1964 the situation has changed dramatically. Today, because of the fall in the birth rate (which has been continuing for almost twelve years), the numbers of births and deaths in England are almost in balance. The part currently played by natural change (births less deaths) in the growth of population is very small in each of the regions. In fact some regions are experiencing a natural decrease (more deaths than births), particularly in the retirement areas of the South West and Outer South East. Only in the Outer Metropolitan Area and the West Midlands are the numbers of births still appreciably higher than the numbers of deaths. Consequent to the virtual balance between births and deaths, migration has become the main determinant of population change.
7. The most recent national projections suggest that by 1981 the population of England will be 46.5 million, about 5 million (almost 10 per cent) below the figure projected in 1964, and less than 0.1 million (0.2 per cent) above the 1974 population. After 1981 a slightly faster growth is projected resulting in a population for England in 1991 of 48 million, still only 3 per cent above the present level.
8. With a national population which will grow only slowly in the future some regions are likely to decline in population. Of the eight English regions the projections suggest that four will have lower populations in 1981 than they had in 1974 (Northern, Yorkshire and Humberside, North West and South East). These four are assumed to lose population through migration in the future, and in the first three a natural decrease is also expected to occur. The drift to the South East, which has traditionally been among the fastest growing areas in the country, appears now to have ended. Of the regions assumed to lose population because of migration the West Midlands is the only one to grow continuously throughout the projection period. This is due to the high level of natural increase expected in the area which more than offsets an assumed annual out-flow of some 10,000 people. The growing regions of the future are expected to be East Anglia, and, to a lesser extent, the South West and East Midlands. East Anglia stands out as the region with the fastest growth.

Notes. 1. Maintained primary and secondary schools are of two kinds, those established by Local Education Authorities called *County Schools*, and those established by voluntary bodies, mainly the religious denominations, called *Voluntary Schools*.

2. A department is a portion of a school which normally has a separate head teacher.

3. Primary schools—consist mainly of infants' schools for children aged 5 to 7, junior schools for those aged 7 to 11 and junior and infant schools for both age groups. In addition, first schools cater for ages from 5 to 8, 9 or 10. They are the first stage of a three-tier system.

Middle schools—take children from first schools. They cater for older junior and younger senior pupils. The age ranges of these schools are 8 to 12, 9 to 12, 9 to 13, 10 to 13 and 10 to 14. Those for pupils aged 8 to 12 and 9 to 12 are deemed primary, those for ages 10 to 13 and 10 to 14 are deemed secondary, and those for ages 9 to 13 may be deemed either primary or secondary according to the choice of the Local Education Authority. Pupils from these schools generally go on to comprehensive upper schools.

Secondary schools—Secondary education is provided mainly in three types of school—secondary modern, secondary grammar and comprehensive. A school is classified as comprehensive when its admission arrangements are without reference to ability and aptitude. There is a small and decreasing number of technical schools. Schools which do not fall into these four categories are classified as other secondary schools.

4. In the table above Middle schools deemed primary are included with Primary schools, and Middle schools deemed secondary are included with Secondary schools.
