**B. Application for inclusion on the register of electors**

I apply to have my name included in the register of electors for the electoral area comprising the universities and theological education institutions maintained under Regulation 12 of the Clergy Representation Rules 1975 to 2014.

I declare that I meet the conditions for inclusion of my name in the register for the following reasons:

- The first condition is that the person concerned is a priest or deacon of the Church of England who is authorised by a bishop to officiate in a diocese in either province.

- The second condition is that the person concerned —
  - (a) is employed to teach and research by a university in one of the provinces or by a college<sup>1</sup> of such a university,
  - (b) is the head<sup>2</sup> or a fellow<sup>3</sup> of a college of such a university, or
  - (c) is employed, on at least a half-time basis, to teach and research by a theological education institution in one of the provinces that is recognised by the House of Bishops as an institution for training candidates for ordination as ministers of the Church of England.

  - (a) where the university in question is Oxford University, the person is a member of Congregation;
  - (b) where the university in question is Cambridge University, the person is a member of the Regent House;
  - (c) where the university in question is Durham University, the person is a member of Convocation.
