Erection of a temporary marquee to the north of Manchester Cathedral.

Summary of the nature of the work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

- The proposal is to erect a temporary marquee to the north of the Cathedral, for a duration of five years.
- The main body of the marquee would be 25m x 10m with a 7.5m x 5m kitchen to the east and a 2.5m x 2.5m WC to the west. A 10m x 4m deck would extend to the north. The marquee walls would be 3m high on top of a steel substructure to account for the gradient of the ground.
- The substructure would be fixed to the ground with 600mm long metal pins. A level floor and aluminium marquee structure would be fitted on top. The marquee would have glazing to the north elevation and pale grey 40mm thick metal insulated sandwich panels to all other elevations. The marquee would have a pitched roof covered in a waterproof canvas to match the walls.
- Main access would be via new temporary steps to the west and a new temporary ramp to the east. Additional doors to the north and south of the marquee allow access to the deck and Regimental Chapel.

To conserve two polychrome sculptures currently displayed in the Eastern Crypt, of St Anne and the Virgin (15th century) and the Virgin and Child (c. 12th century).

Summary of the nature of the work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

The significant polychrome sculptures of 'St Anne and the Virgin' and 'The Virgin and Child' are displayed in the Eastern Crypt, affixed to the eastern wall. Both are of identified as of 'outstanding' importance on the Cathedral Inventory. 'The Virgin and Child' was discovered in the eastern wall of the Lady Chapel following renovations after the 1827 fire: it had been defaced, presumably at the Reformation. 'St Anne and the Virgin' was purchased by Dean Milner White in 1953, and donated with support from the Friends of York Minster.

Both sculptures have suffered damage and losses, especially to the important remnants of polychrome paintwork, exacerbated by unsuitable conditions in the Crypt, particularly high relative humidity and fluctuations in r.h. levels. Salt efflorescence from the eastern Crypt wall, to which the sculptures are attached, is also accumulating on these important works. Conservation and consolidation is required to stabilise them and prevent further damage. Conservation reports have been obtained, and a conservator and methodology selected. Following conservation, they will not be returned to their current location, in which they were placed in the 1970s, as the environmental conditions there are unsuitable for the preservation and care of these important objects. In the short to medium term, the intention is to display them in controlled environmental conditions in the Undercroft Museum, where these magnificent sculptures will be interpreted with reference to research and conservation work. In the longer term, they will be displayed in the Minster with reference to the Liturgical Plan and to their continued care and conservation.

To conserve the category "A" inventory item known as the Frosterley marble slab and associated tomb chest and seek the commissions advice on the relocation, once returned, to the Memorial Chapel in the north nave aisle of the cathedral. It is the Chapter's intention that it will be brought back into liturgical use for the ablutions after the Eucharist services each Sunday and for the Eucharist services during remembrance in November.

Summary of the nature of work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

St Albans Cathedral Chapter wish to conserve and represent the Frosterley marble altar slab and most importantly, to bring it back into liturgical use. Advice from the Commission is sought about the proposal to relocate the monument to the Memorial Chapel which is in the north nave aisle. The top slab is of Frosterley 'marble', a stone found in Weardale, in the North East of England. The bottom "chest" is formed of Purbeck limestone panels. The dimensions of the slab are 1770 x 120 x 860mm. Incised into the slab surface are 5 crosses indicating that this is a consecrated altar piece, also evident are crinoid fossils and other marine fauna. The Stone base measures 1555 x 790 x6 30mm. On the panels are shield shaped indents on east and south faces, the west face has indents thought to have contained three brasses, the poor condition does not allow them to be identified. There is graffiti on the surface of the slab which appear to be 17th or 18th century in character. The proposal is that the whole is removed from its existing location and taken to the Skillington workshop for expert conservation and investigation, which may provide further detail on the history of the slab and chest enabling the cathedral archive to be updated. Once back into the cathedral this can be brought back into liturgical use and can be once again become part of the life of the cathedral and add to the historical context of the building.
