Conservation of the damaged early 19th century frame surrounding the portrait of Dean William Friend

Summary of the nature of work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

Inventory No. 02275.2- Early 19th century frame (Georgian style, probably George IV reign), frame of the oil painting 'portrait of Dean William Friend' (Inventory No. 02275.1), circa 1760, attributed to Thomas Hudson.

The frame is considered as part of the oil painting and is therefore part of the collection of portraits of Deans kept in the Deanery which has been deemed as outstanding on the Cathedral's Statutory Inventory.

All work will be undertaken by a freelance frame conservator. Proposed treatment involves:

- re-attaching loose plaster parts that have fallen off during the fall
- toning losses with watercolour
- casting missing mouldings from the frame
- lining out of the frame with brown gum strip tape/ felt
- fitting brass plates to hold the painting in place and replacement of the hanging system.

The proposed work includes casting some missing mouldings which are structurally necessary. It is proposed that further missing mouldings could be recast, and that the decision on this should be delegated to the Cathedral's accredited D&C Conservator (Ariane Langreder) who will oversee the work of the external frame Conservator. Conservation work to the frame will be undertaken at Canterbury Cathedral in the Reading Room, Conservation hub and studio located in the Archives building in the Precincts.

The installation of an Echo Organ Division in the south-east triforium bay 2 above the Sanctuary as envisaged in the original specification for the Grand Organ in 1911 and using pipework from a contemporary Willis III organ.

The proposed Echo Organ is a free-standing, self-contained instrument which will be integrated into the existing control systems of the main organ. As well as the instrument itself, associated services will be fitted in access routes and the triforium area. Additional lighting will be installed for safe passage along access routes. The triforium area is a large, unused space which will require no modification to accommodate the instrument and associated equipment.

The Proposal

The removal of temporary City of London removable bollards on the public highway at what is known as the Queen's Entrance to the forecourt of St Paul's Cathedral on Ludgate Hill, directly to the southwest of the Cathedral's west steps. This will be followed by a new installation of three PAS-rated removable security bollards of the same appearance as the temporary installation. The new bollards will be on Cathedral land, on the boundary of the precinct, in alignment with the late nineteenth century granite bollards placed at regular intervals around the forecourt perimeter.

Summary of the nature of work and its extent

Removal of the existing bollards and making good the public highway. Creating new foundations for the three new bollards on the edge of the forecourt to an approximate depth of 600mm and installing three new removable PAS-rated bollards of the same appearance as those currently installed. The archaeological sensitivity of the site is reflected in the Cathedral Archaeologist's desk based assessment and written scheme of investigation, and works will be subject to an archaeological watching brief and recording.
