### The Proposal

To conserve the damaged early 19<sup>th</sup> century frame surrounding the portrait of Dean William Friend (inventory number 02275.2

# Summary of the nature of the work and its extent

Early 19<sup>th</sup> Century frame (02275.2) frame of the oil painting 'portrait of Dean William Friend' (02275.1), circa 1760, attributed to Thomas Hudson.

The frame is considered part of the oil painting and is therefore part of the collection of portraits of Deans kept in the Deanery which has been deemed as Outstanding on the Cathedral's Statutory Inventory.

All work will be undertaken by a freelance frame conservator. Proposed treatment involves:

- Reattaching loose plaster parts that have fallen off during the fall
- Toning losses with watercolour
- Casting missing mouldings from the frame
- Lining out of the frame with brown gum strip tape / felt
- Fitting brass plates to hold the painting in place and replacement of the hanging system.

The proposed work includes casting some missing mouldings which are structurally necessary. It is proposed that further missing mouldings could be recast, and that the decision on this should be delegated to the Cathedral's accredited conservator (Ariane Langreder) who will oversee the work of the external frame conservator. Conservation work to the frame will be undertaken at Canterbury Cathedral int eh reading Room, Conservation hub and studio located in the Archives building in the Precincts.
