The Alteration of the North Porch with the use of metal and glass.

- 1. To create a threshold with the Cathedral Close that beckons people, rather than discourages them.
- 2. To extend the area of glass in the wooden inner doors, allowing pilgrims and visitors to see clearly into the nave.
- 3. To review the awkward single person entry/exit restriction of the internal doors.
- 4. To introduce a draught lobby to prevent heat loss from the building, thus improving our carbon footprint and creating a more hospitable environment at the entrance/exit, where a Cathedral a welcomer could greet pilgrims and visitors, and where people might linger to the read the notice boards.
- 5. To gain permission for the relocation of gates into Cannons' Garden as part of a further Access project.

The temporary loan of *Textus Roffensis* to the Supreme Court, London

Summary of the nature of work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

The *Textus 900* celebrations are a series of exhibitions and events over the period 2023-2024 highlighting the significance of this manuscript, considered Britain's greatest hidden treasure.

The Chapter of Rochester Cathedral is seeking fresh settings, new audiences, and future sponsors for *Textus Roffensis* as vital medium to long-term conservation interventions are required to preserve the manuscript. In seeking sponsorship for *Textus*, the manuscript is to be exhibited on the first-floor lobby of the Middlesex Guildhall, home of the UK Supreme Court, from 31 July 2023 to 20 October 2023 as part of the planned *Textus* 900-year celebrations.

Other than historic water damage to edges of leaves throughout, *Textus Roffensis* is considered to be in fine condition. A condition assessment by Sussex Conservation Consortium, in advance of the *Textus Roffensis: Legal Roots* exhibition, has highlighted the short, medium, and long-term risks to the manuscript posed by the exhibition, together with measures to address these. This includes a new bespoke support cradle for the intended opening, recommendations as to handling and checks, and

Textus will be transported to and from the Supreme Court in a made-to-size packing case by a fine art removals firm with appropriate insurances. Sussex Conservation Consortium will be employed to oversee the transportation process, including packing, handling, and installation at the Supreme Court where Textus will be displayed in a high-security conservation-grade table display case, conditioned with ProSorb cassettes, very close to 53% RH, similar to its current display conditions in Rochester Cathedral's Crypt.

Ecclesiastical Insurance has confirmed it is satisfied with the details of the security and fire protections of the exhibition site and how Textus is to be displayed and has confirmed insurance cover for the duration of the loan.

Loan of the Horn of Ulf to the Bodleian Libraries, University of Oxford, for temporary exhibition.

Summary of the nature of work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

Display of the Horn of Ulf in a temporary exhibition, 'Gifts and Books', in the S.T. Lee Gallery, Weston Library, University of Oxford. The exhibition dates are 15 June to 29 October 2023. This exhibition charts the symbiotic relationship between gift-giving, writing and story-telling, from early myths and legends to contemporary cultures.

The Horn of Ulf is an eleventh century oliphant. It is said to have been presented to York Minster about 1030 by a Norse nobleman named Ulf (or Ulph), as a horn of tenure, representing the lands and property in ancient kingdom of Deira (northern England) that he was presenting to the cathedral.

The horn is particularly striking, being of great size and weight, and intricately carved with plant and animal motifs. A lion preys on an antelope or deer, while a unicorn and other mythical beasts pace round the rim. Silver mounts were added in 1673.

It was probably made in southern Italy, in or around Salerno or Amalfi, which had strong trading connections with Africa and with the Islamic world. The design of its carved decoration has been influenced by this exchange of artistic ideas.
