Executive Summary

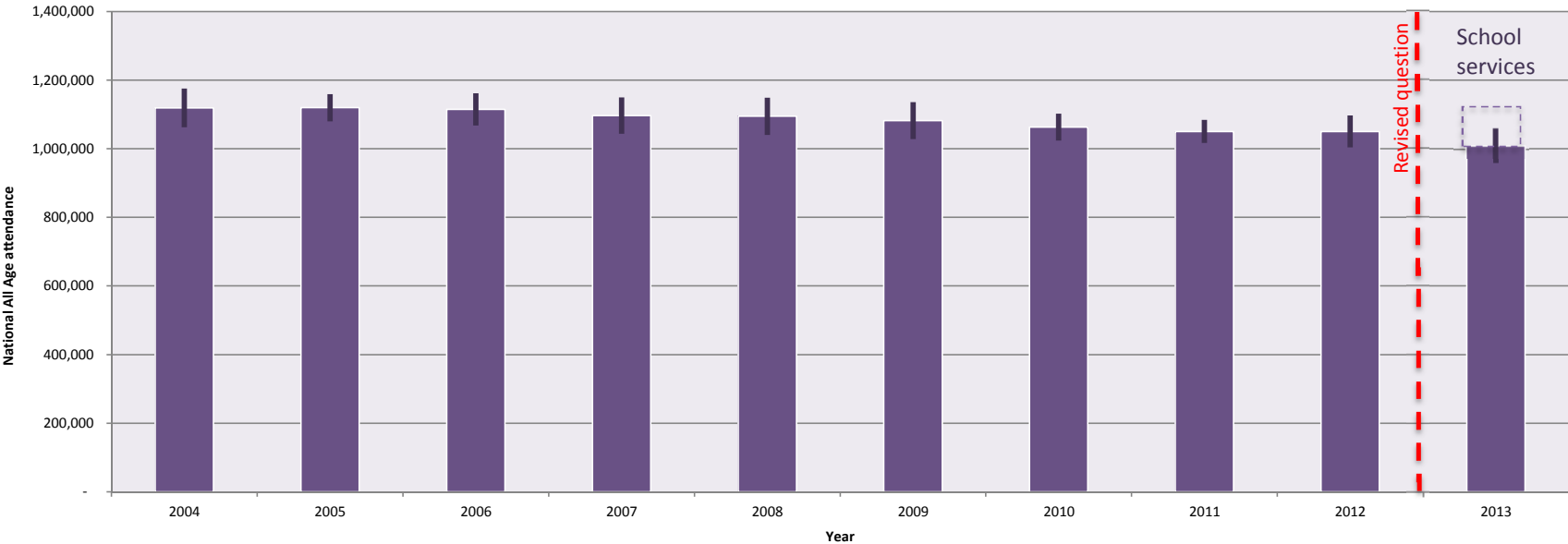
Summary

These statistics are derived from the annual Statistics for Mission returns provided by Churches. In 2013 80% of churches provided a return. Where data were missing an estimation process has been used based on data from previous years.

On average, 1 million people attended church each week in October 2013. There has been around a 1% decline year on year over the decade (Figure A).

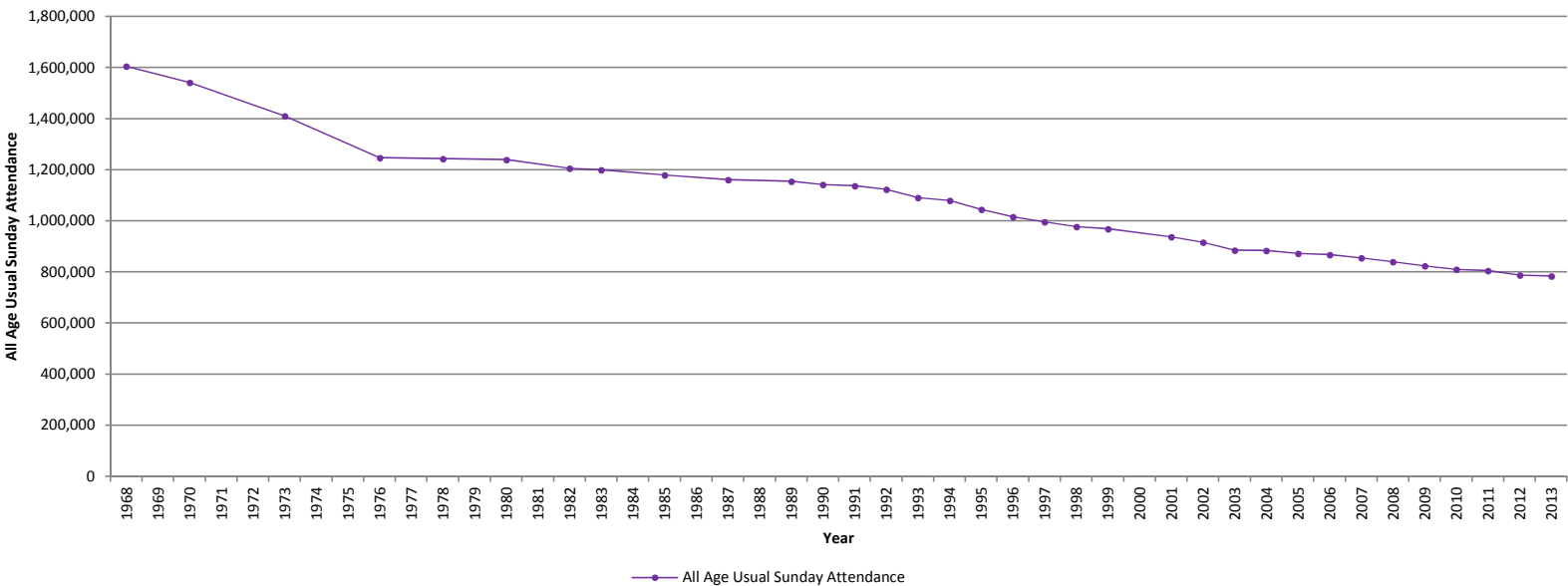
For the first time in 2013 the form separated out attendance at school services from attendance at church and fresh expressions. This was in response to feedback about some variation in how people were counting attendance in October, and in particular child midweek attendance. This means that the midweek child component of All Age Average Weekly Attendance is likely changed as a result of this clarification. Combining the attendance from AWA in church and school services gives us some idea of the reach of churches in their parishes. However, it is not advisable to compare this aggregated figure with previous years since we cannot know what proportion of churches previously did include school services in their October Count. For trend analysis other measures such as Average and Usual Sunday and Adult weekly counts should be used.

On a usual Sunday in 2013, 785,000 people attended church, with an average of 6 adults for every child attending.

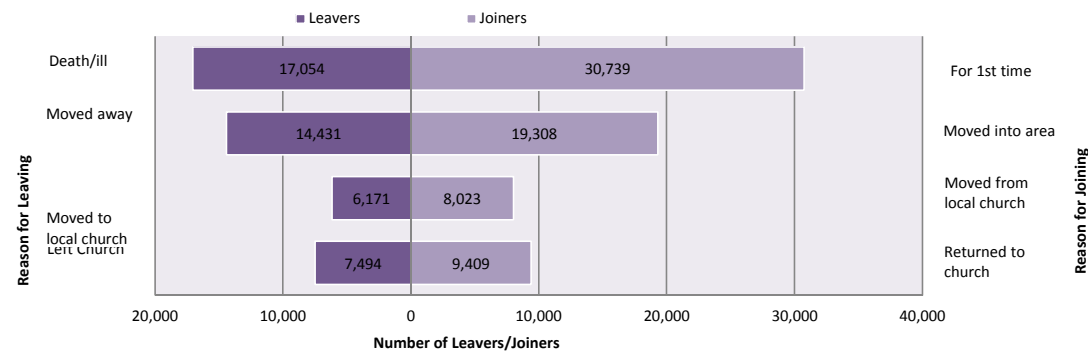
Figure B: Total Church of England All Age Usual Sunday Attendance 1960 - 2013



The Worshipping Community measure is in its second year of running and the total Worshipping Community in the Church of England in 2013 was reported to be 1.06m. One in five people in the worshipping community are 17 or under and 29% are 70 or over.

For the first time in 2013 a new split was introduced in the joiners and leavers part of the question to measure those moving to or from other local churches. Whilst there does seem to be a fair amount of local churn, nearly half of joiners (46%) reported by churches were coming for the first time.

Figure C: Total Church of England Joiners and Leavers by reason 2013

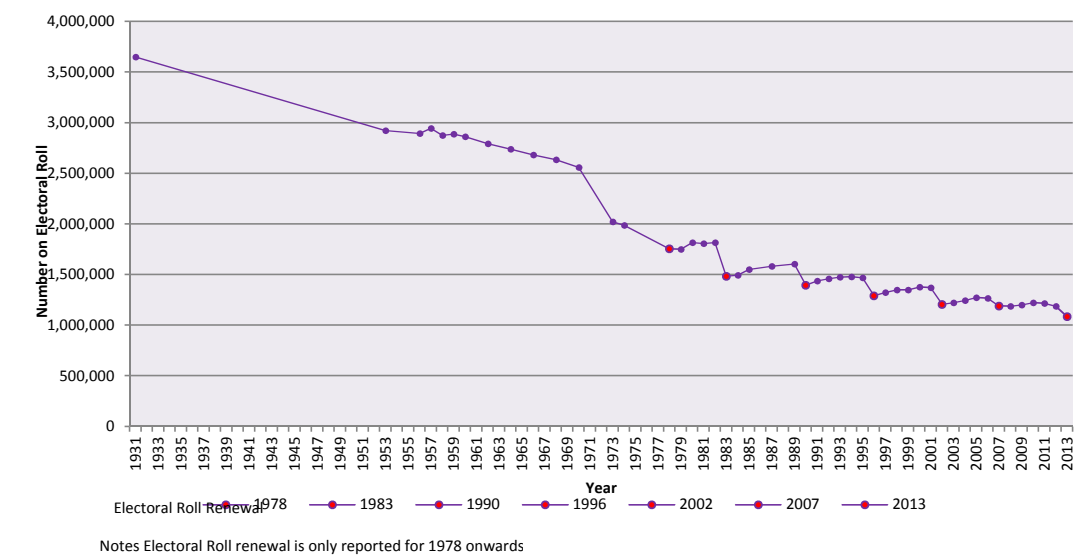

The total Church of England worshipping community exceeded the average Sunday attendance, most notably for children. As in 2012, on average in 2013, All Age Average Sunday Attendance was 80% of the size of the worshipping community. This shows that on average people continue to attend worship just over three times each month.

The number of people on the Electoral Roll for the Church of England (excluding the Diocese of Europe) in 2013 represented 2% of the adult population of England. 2013 was a renewal year for the electoral roll and the total electoral roll has seen a 9% drop since the last renewal year in 2007 (Figure D).

Services on Christmas Eve and Christmas Day in 2013 attracted around 2.4 million people. Following feedback from churches who wanted to share more about the numbers of people attending services in advent such as nativities and carol services, attendance at advent was a new question in 2013 and just over 9,000 churches gave some advent attendance figures. For those that did, advent figures were around 2.3 times larger than Christmas attendance figures.

Figure E: Total Church of England Christmas Attendance and Communicants 2003 - 2013

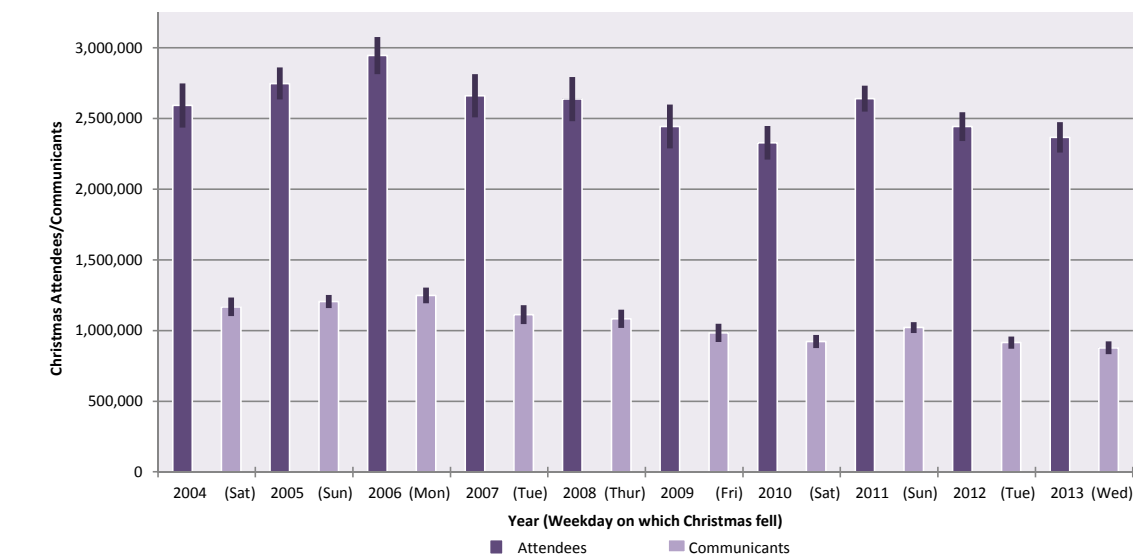
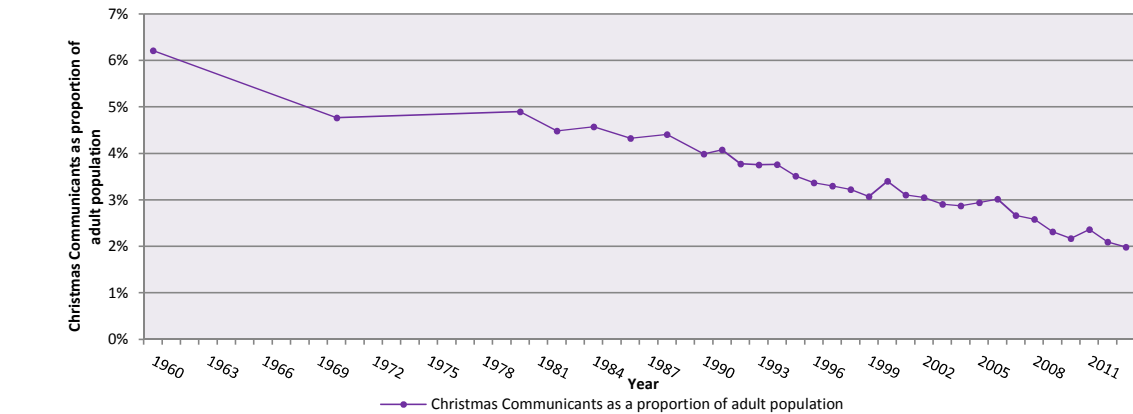


Figure F: Total Church of England Christmas Communicants in a Population context 1960 - 2013

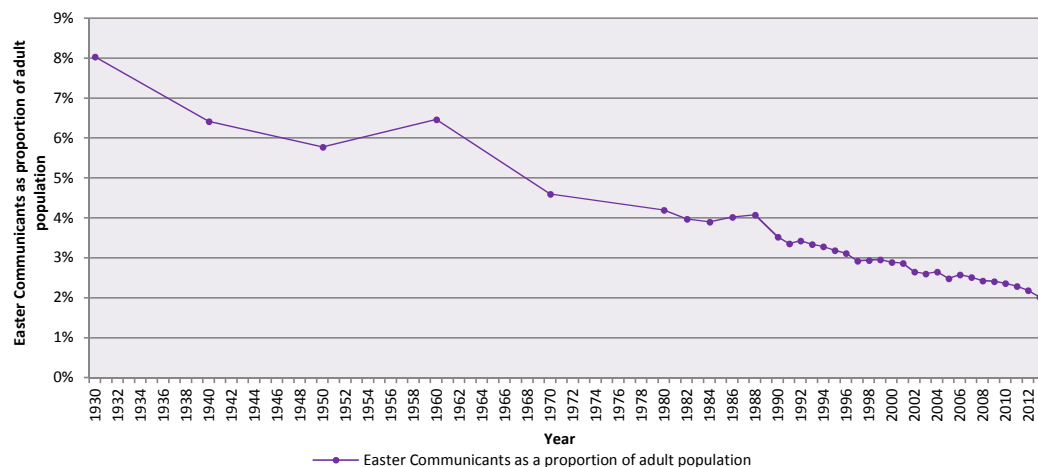

Around 1.3 million people attended an Easter service in 2013. The number of communicants at Easter in 2013 was almost 900,000. When Easter falls in March the number of attendees and communicants is slightly lower than when it falls in April.

Church Growth

The Church Growth Research Programme report 'From Anecdote to Evidence' presented the key findings from the several research teams that had conducted the research (<http://www.churchgrowthresearch.org.uk/report>).

One major finding from the Church Growth Research Programme related to the need for the Church to retain its young people if it is to thrive. One of the researchers, David Voas said 'If people belong in their 20s, they will probably stay for the rest of their lives ... But if they don't, it will be hard to bring them in. And unfortunately the Church of England has not done well in keeping young people.'

Keeping young people is essential for the Church as a whole, but the research also showed that the presence of young people is correlated with all measures of growth. Youth retreats, conferences or camps make a difference to growth –but no more than a fifth of churches offer them. Also, of all of the many types of paid staff, youth workers are most likely to be associated with church growth.

From the 2013 Statistics for Mission, the proportion of churches that have shown signs of decline (24%) is slightly greater than the proportion that have shown signs of growth (19%)

Figure H: Proportion of Churches in All Age Average Weekly Attendance Growth and Decline October Count 2013

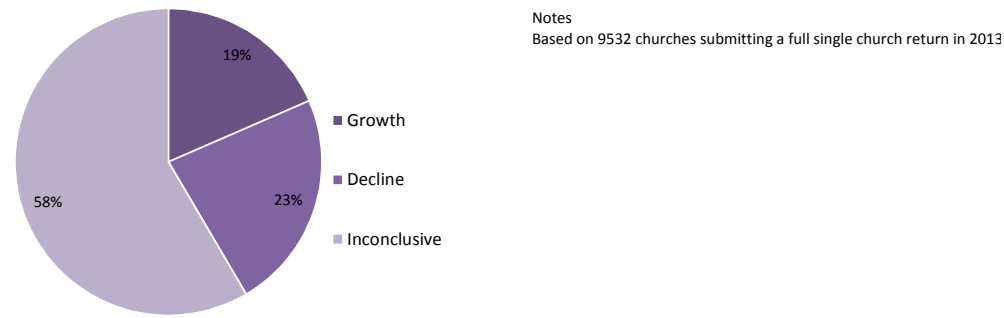
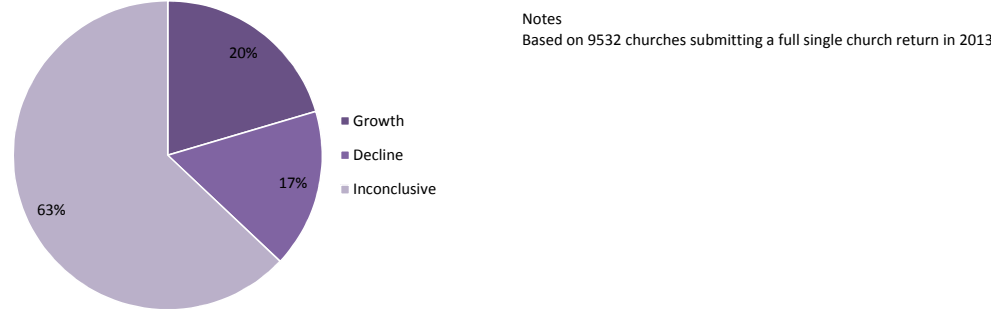


Figure I: Proportion of Churches in Child Average Weekly Attendance Growth and Decline October Count 2013



To further explore how churches are working with children and young people, in their annual Statistics for Mission return, churches were asked to report on the provision of activities and support to children, young people and families in 2013. 7,500 or 47% of churches responded to this question. The vast majority (85%) of individuals reported to be working with children and young people were volunteers, with 80,000 volunteers and 2,700 paid staff reported. Volunteers were most likely to spend their time at parent/care and toddler groups, church led children's activity groups and Sunday primary school groups. Paid staff were most likely to spend their time at Church led youth groups.

Occasional Offices

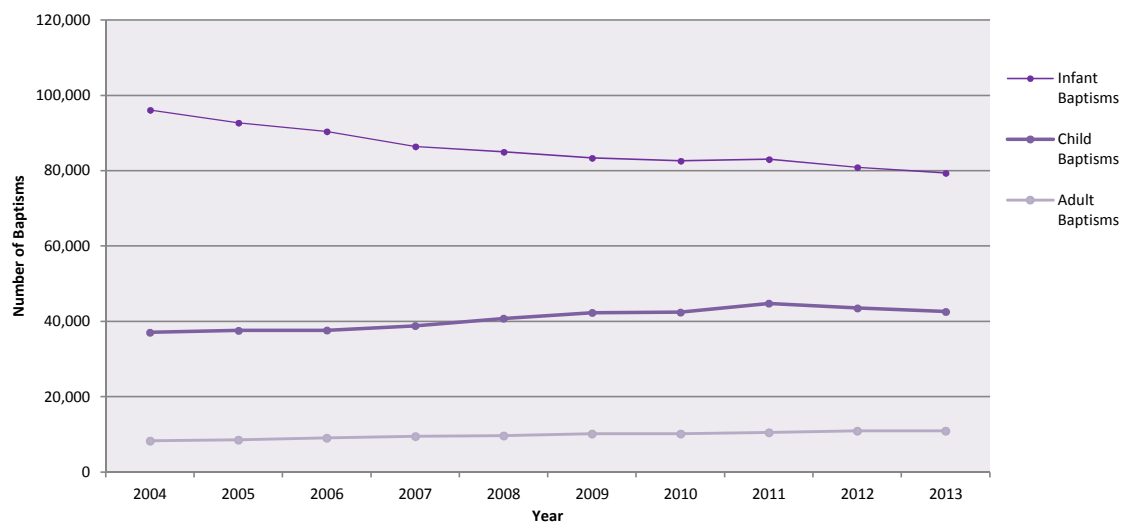
Occasional Offices have been the subject of research funded by the Archbishops' Council. The weddings project was tasked to develop and support the Church of England's wedding ministry. A report was published in July 2012 'The Church Weddings Handbook: The Seven Pastoral Moments That Matter' which emphasised how the project aimed to see a "measurable difference" as a "church growth project".

Subsequent projects are now seeking to understand how baptisms and funerals can also be opportunities for growth.

In 2013 the Church of England baptised over 130,000 people (2,500 per week), of which 80,000 were infants and 42,000 were children aged 1-12. For the first time in 2013 churches were able to split their juvenile baptism figures into two age groups: 1-4 and 5-12. Where churches could do this, 77% of juvenile baptisms were of children aged 1-4. In 2013, 120 infants were baptised for every 1,000 live births.

There are signs that for the Church of England as a whole, the relative popularity of baptism at different ages has changed over the decade 2004 to 2013 (Figure J). Infant baptisms have fallen from 96,000 to 79,000 (a 17% decrease) while child baptisms have increased from 37,000 to 43,000 (15% increase) and adult baptisms have increased from 8,000 to 11,000 (32%). Overall, infant and child baptisms combined have decreased from 133,000 in 2004 to 122,00 in 2013.

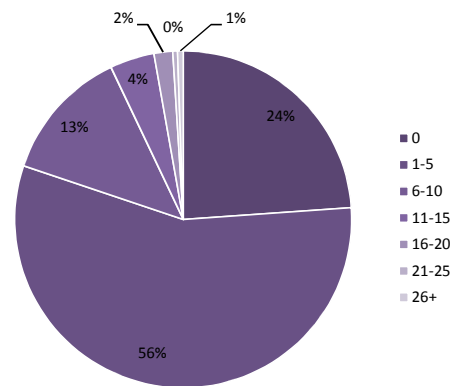
Figure J: Total Church of England Baptisms 2004 - 2013



The total number of Church of England confirmations has declined since the early 1900s with 20,000 taking place in 2013 compared with 221,000 in 1901. In 2013 8,000 males and 12,000 females were confirmed. Confirmations of females continue to outnumber confirmations of males overall and for all age groups.

In total, in 2013 the Church of England performed 50,000 marriages. Most churches conduct between 1 and 5 weddings each year (Figure K)

The Church of England conducted around 160,000 (3,000 per week) funerals in 2013. A third of deaths (33%) in 2013 were marked by a Church of England funeral or by a service held in a crematorium/cemetery.

Methodology

This report uses data submitted through annual parochial returns and government statistics. As we do not receive returns for all parishes and churches we have to do some estimation. An estimation methodology has been used at parish/church level. In 2013 for around 20% of churches it was necessary to do some estimation. 2012 estimates have been revised where 2013 data makes a more accurate estimate possible.

Estimation introduces error into the data, so for all figures presented in this paper it is likely that the true value lies either a little bit higher or a little bit lower than the stated figure. Where the trend for previous or surrounding years is very stable then it is likely that the estimate is fairly close. However, where the figures for a church are very volatile then the estimate may be a little more variable. We have therefore included a measure of the error in our estimation. To illustrate how much higher or lower than the stated figure the true figure could be, we have used “error bars” on some graphs. The upper and lower bounds are calculated by looking at the standard deviation of the data.

If we add together all these likely errors for each church/parish that we have estimated for, then we can get an idea of how far above or below the stated diocesan and national figures the true figure could be. For dioceses where there has been a substantial amount of estimation, the potential for error is greater.

Average weekly and average Sunday figures are calculated from counts supplied for the first 4 weeks of October. However, since some churches do not have services every week and it is likely that at least some of the time those individuals may attend another church, if their church does not have a service an average figure over the four weeks that data are collected is calculated. This tells us “given not all churches are open every week, on average how many people are attending each week”.

It is helpful to also consider the worshipping community figure to gain an understanding of how many people are in the community even if they do not worship at the church every week. Worshipping Community estimates are relatively new and as such there is no clear way to predict worshipping community from attendance figures. Therefore it is not wise for us to do any kind of church/parish level estimation, as we have no previous information to base this on. Instead, a bulk estimate was done at Diocesan level using the electoral roll. Based on the electoral roll of the whole diocese and the aggregated electoral roll of those churches that gave a worshipping community figure, we could estimate what proportion was missing. No estimation was done for joiners or leavers, as this cannot be extrapolated.

Additionally no estimation was conducted for advent attendance, attendance at school services or the one off question.

In this report we have given statistics on the proportion of churches that are growing or declining. We have used a similar process to that used in the National Church Growth Research Programme (see www.churchgrowthresearch.org.uk for further information), by looking at the standard deviation of the data over a 6 year period to look at what sort of increase or decrease we would need to see to be sure that the church was in growth or decline, and not just experiencing variation in their figures. We have then compared the recent period (2011 to 2013) with the earlier years (2008 to 2010).

While many figures in this publication have been rounded, totals, percentages and averages were calculated before rounding hence row and column totals will not always agree exactly with the sum of the stated amounts.

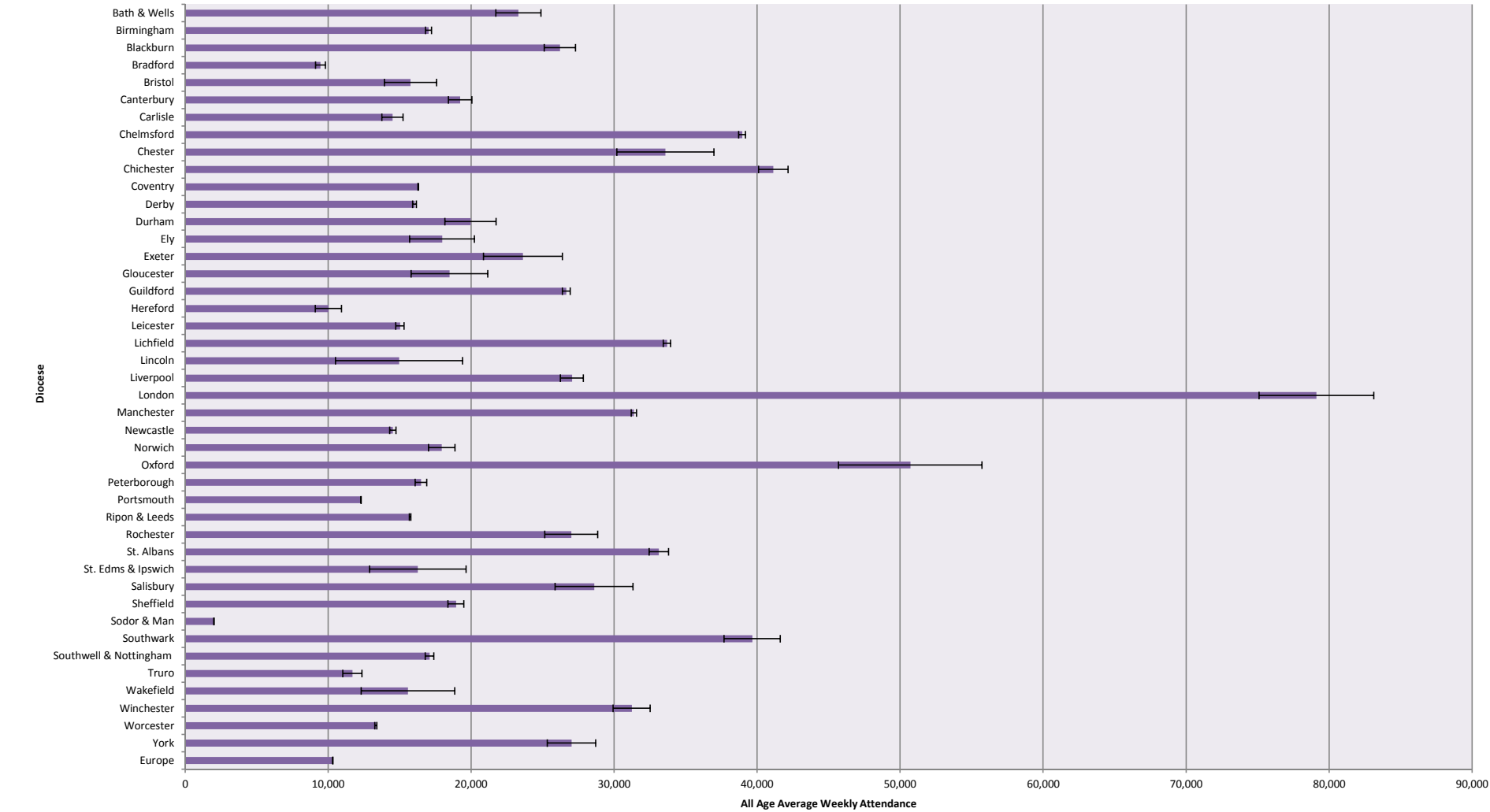

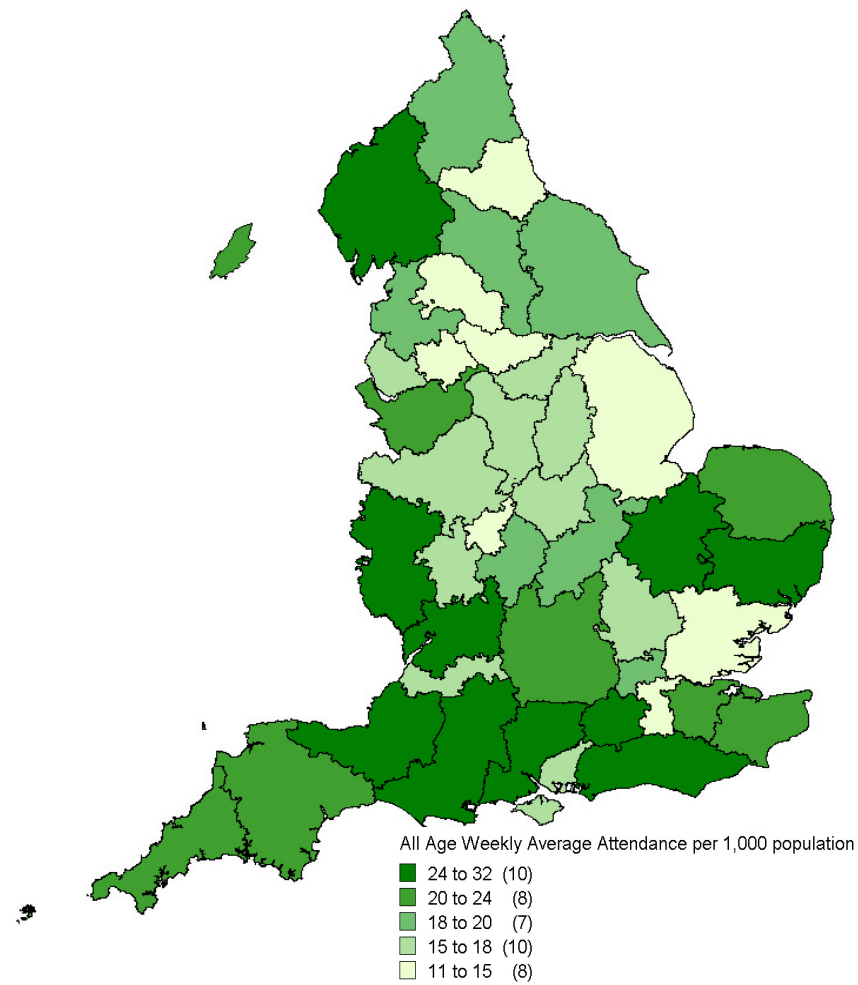
Figure 1: Diocesan All Age Average Weekly Attendance October Count 2013

For the first time in 2013 the form separated out attendance at school services from attendance at church and fresh expressions. This was in response to feedback about some variation in how people were counting attendance in October, and in particular child midweek attendance. This means that the midweek child component of All Age Average Weekly Attendance is likely changed as a result of this clarification. Combining the attendance from AWA in church and school services gives us some idea of the reach of churches in their parishes. However, it is not advisable to compare this aggregated figure with previous years since we cannot know what proportion of churches previously did include school services in their October Count. For trend analysis other measures such as Average and Usual Sunday and Adult weekly counts should be used.

1,500 churches reported a count for school services, totalling around 100k children and 22k adults on average each week. The maximum figures given for churches suggested a maximum reach in the month of October to potentially 280k children and 79k adults.

The median church, in terms of All Age Average Weekly Attendance, welcomed just over 40 people each week in October 2013

Figure 3: Total Church of England All Age Average Weekly Attendance October Count 2004 - 2013

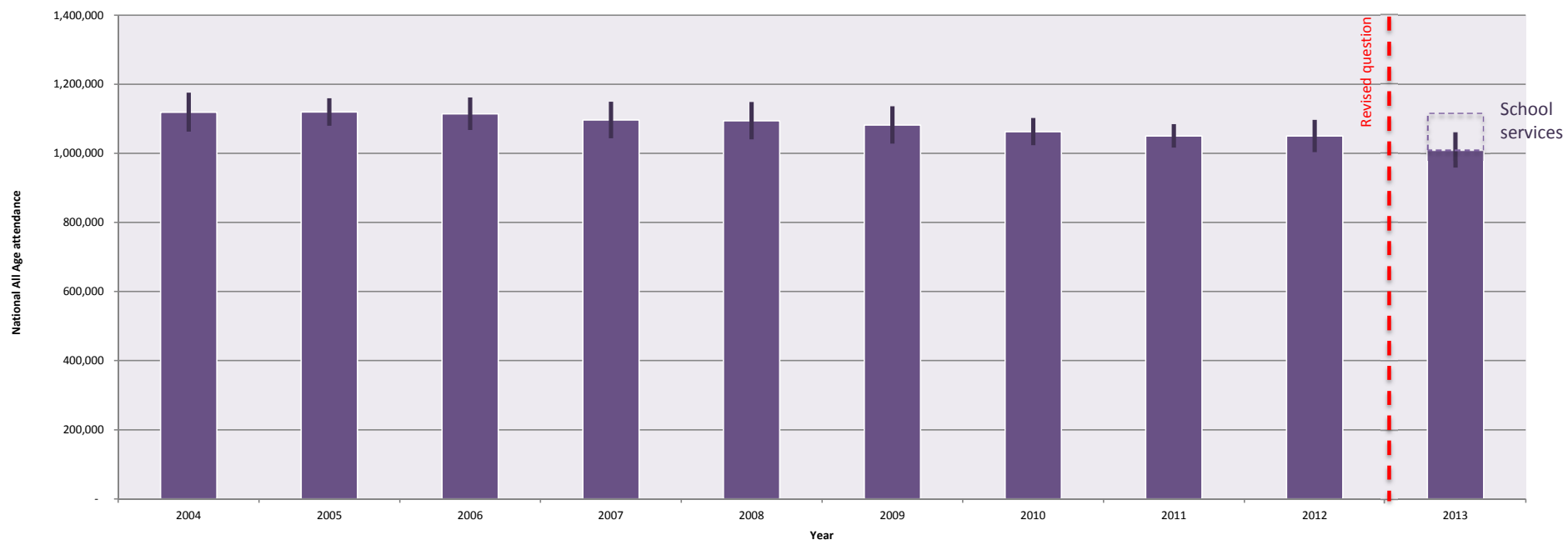
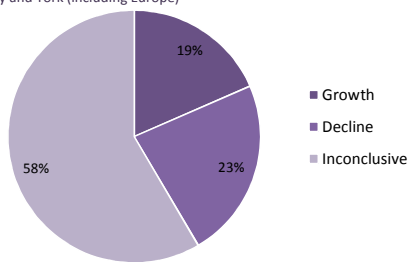


Figure 4: Proportion of Churches in All Age Average Weekly Attendance Growth and Decline October Count 2013

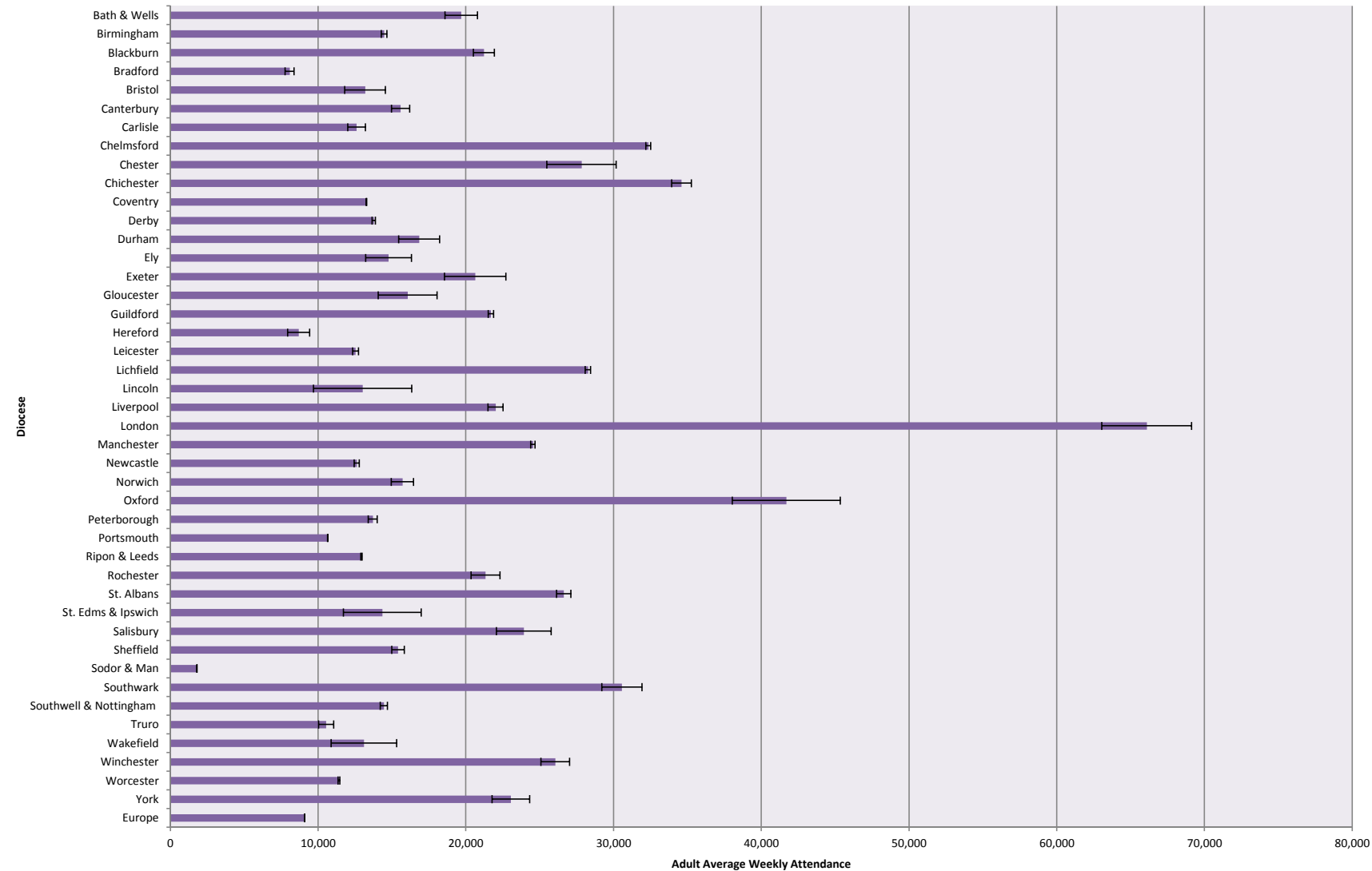

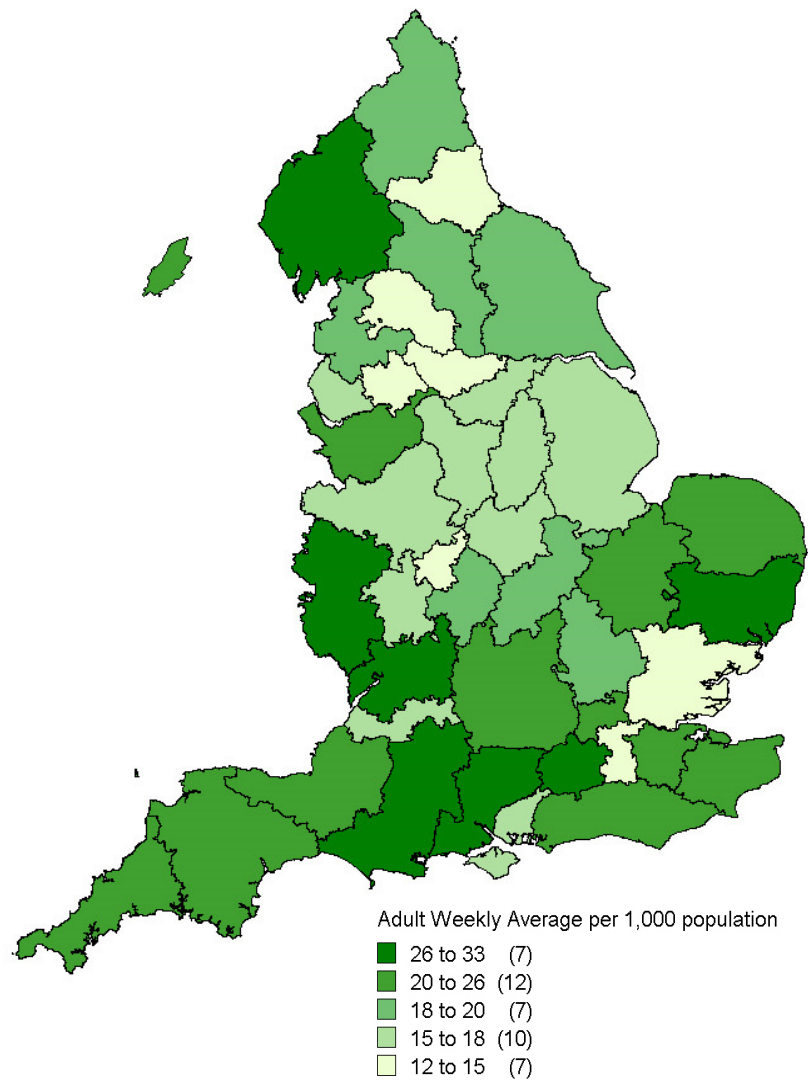
Figure 5: Diocesan Adult Average Weekly Attendance October Count 2013

Figure 7: Total Church of England Adult Average Weekly Attendance October Count 2004 - 2013

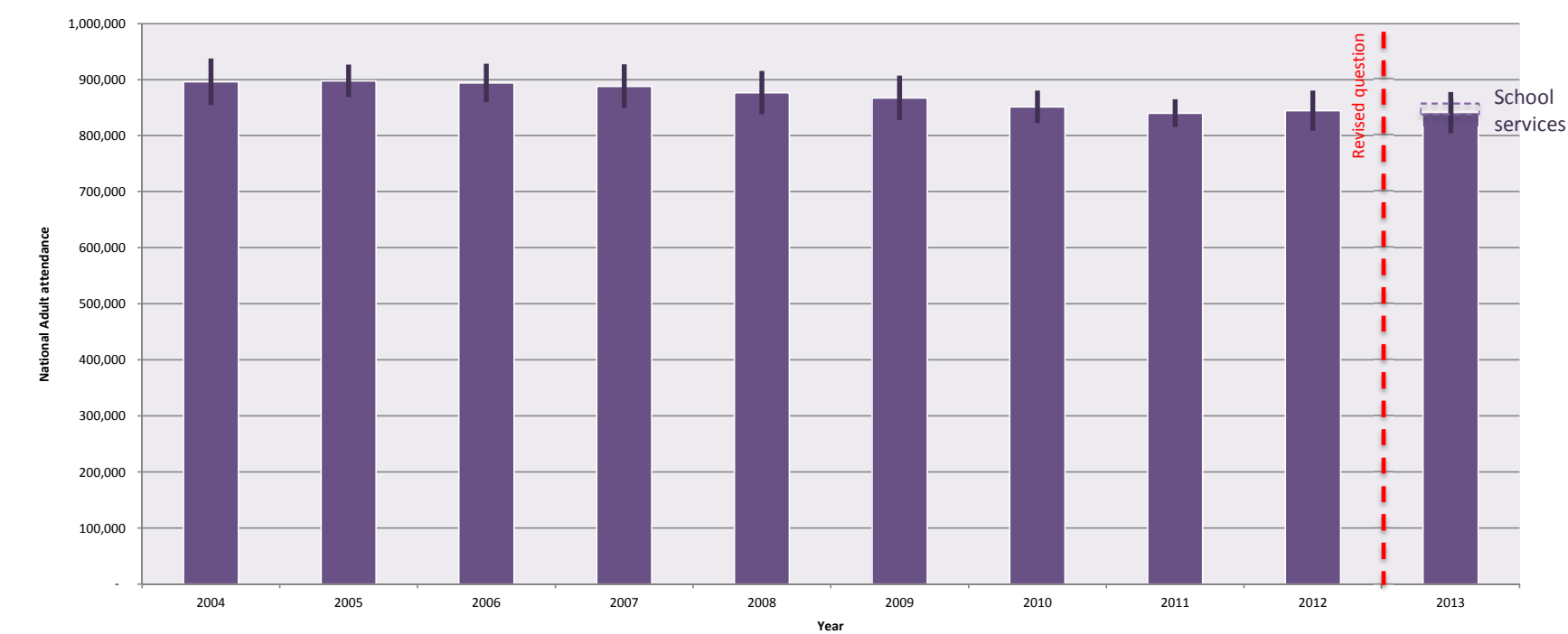
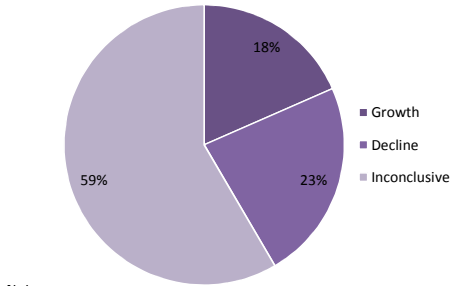


Figure 8: Proportion of Churches in Adult Average Weekly Attendance Growth and Decline October Count 2013

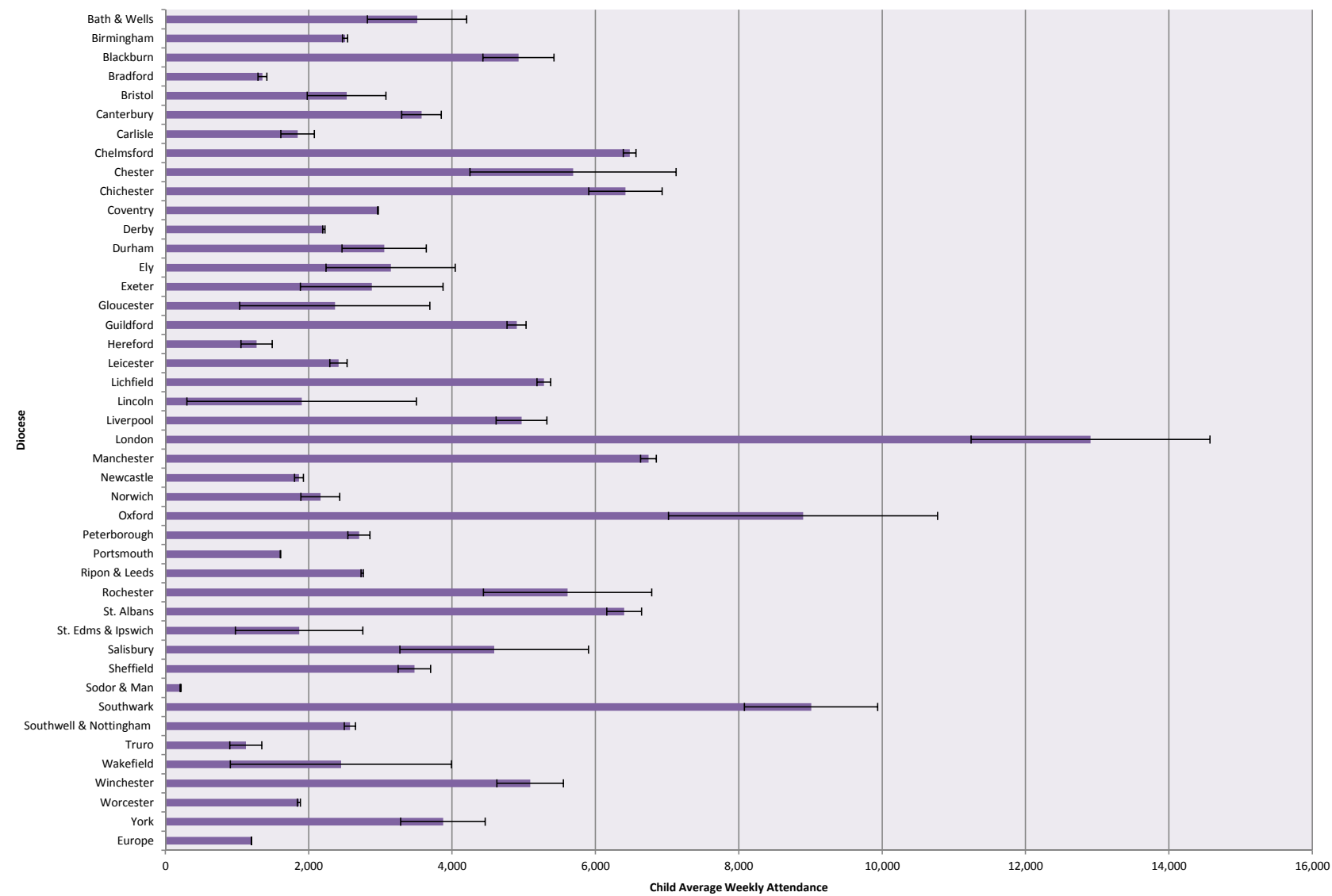

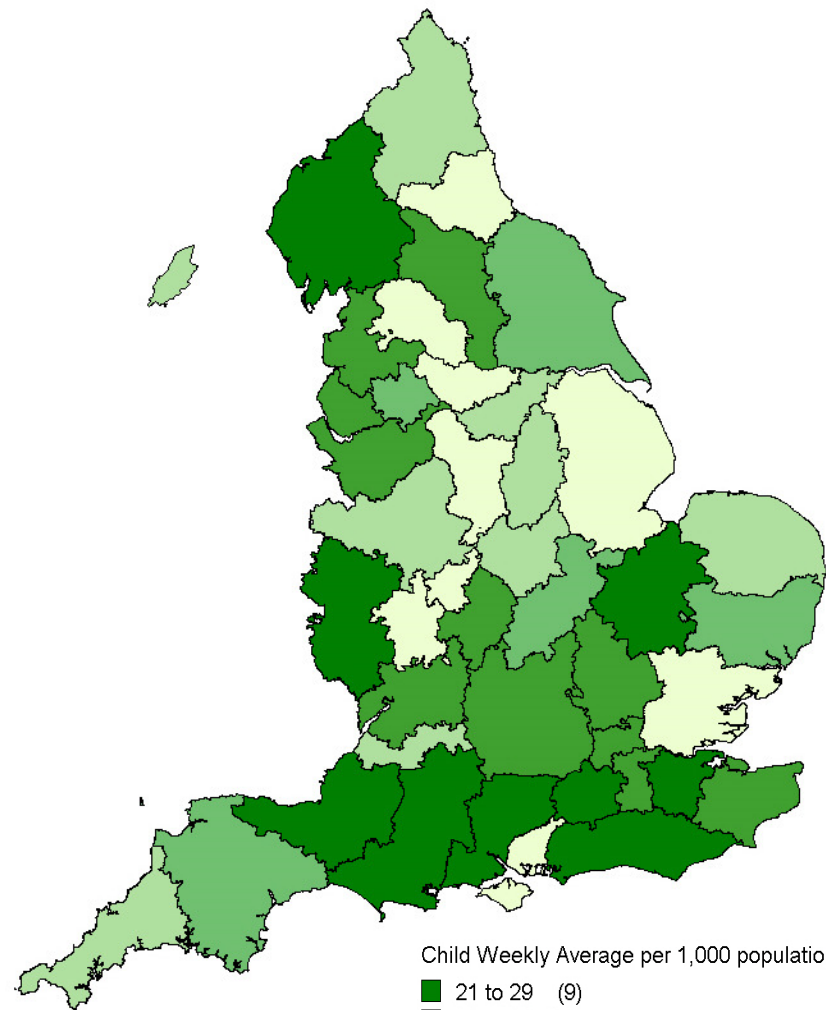
Figure 9: Diocesan Child Average Weekly Attendance October Count 2013

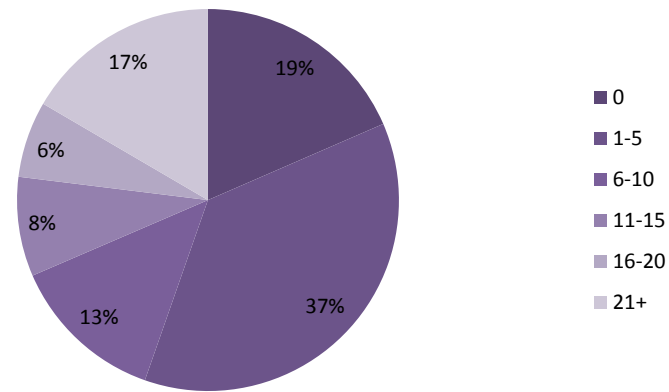

Figure 11: Total Church of England Child Average Weekly attendance October Count 2004 - 2013

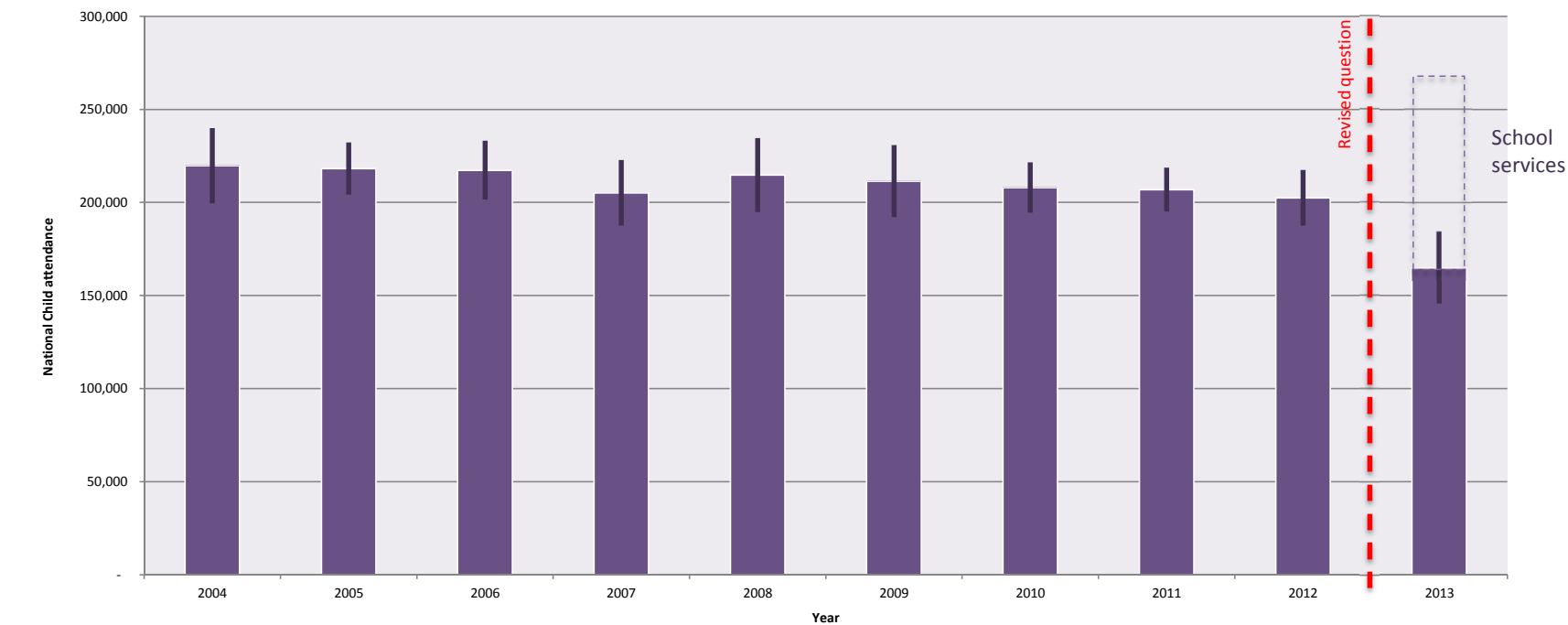
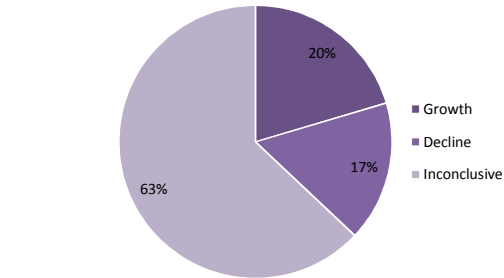


Figure 12: Proportion of Churches in Child Average Weekly Attendance Growth and Decline October Count 2013

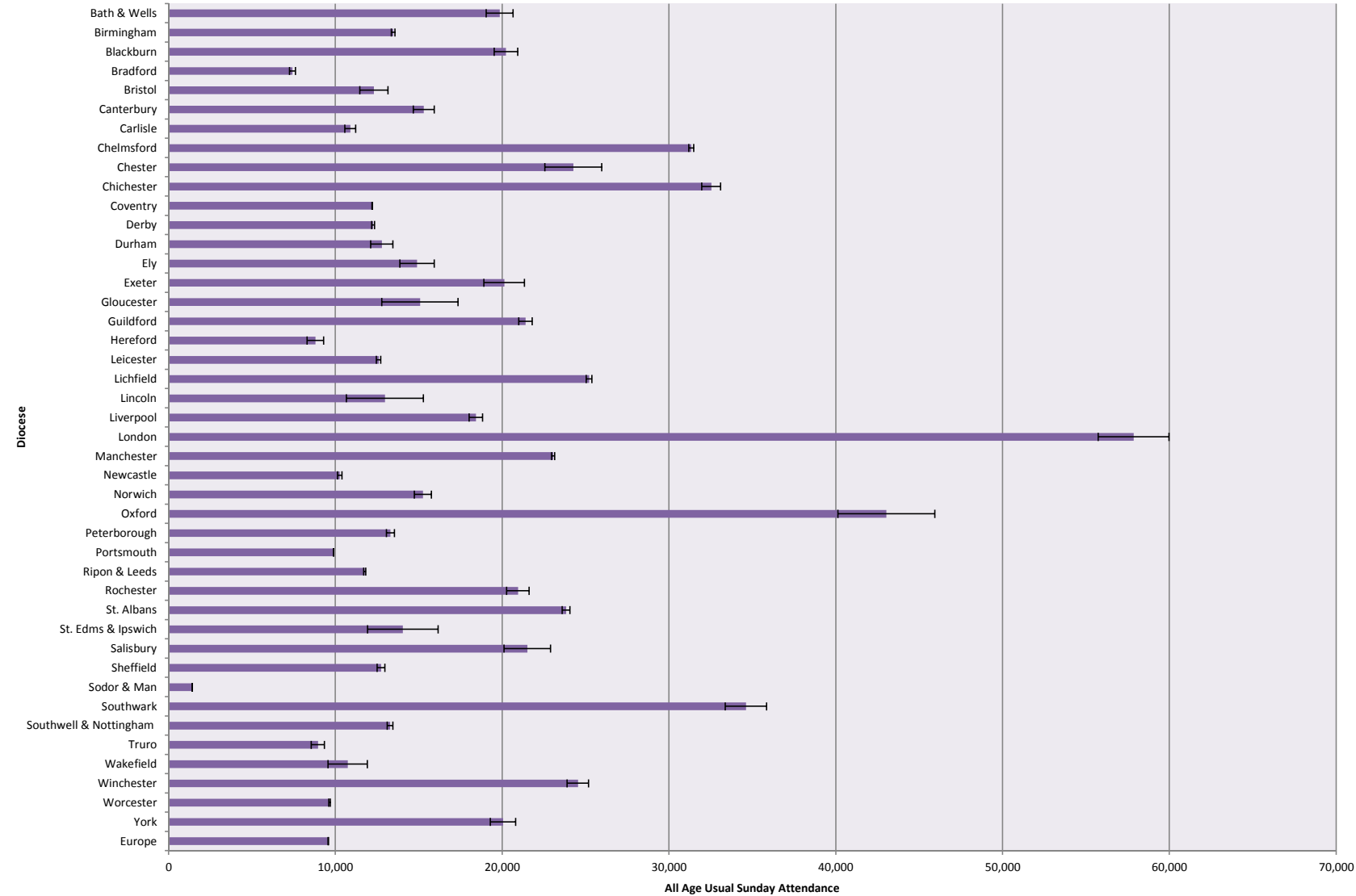


Figure 14: Total Church of England Adult and Child Usual Sunday Attendance 2004 - 2013

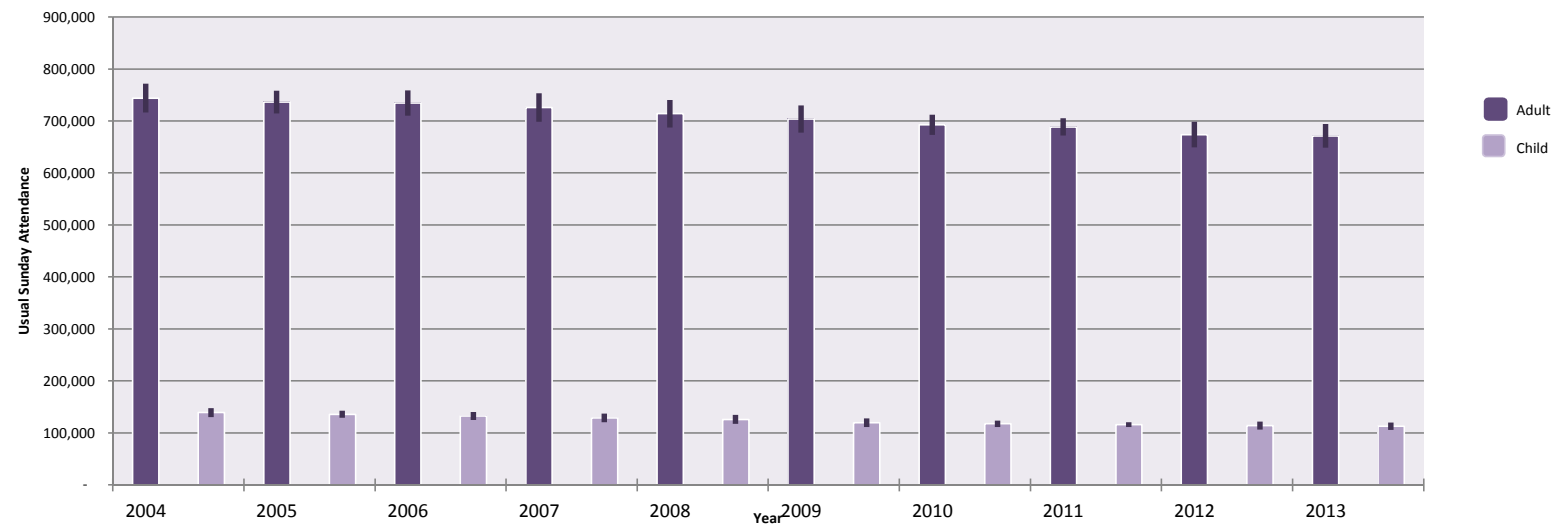
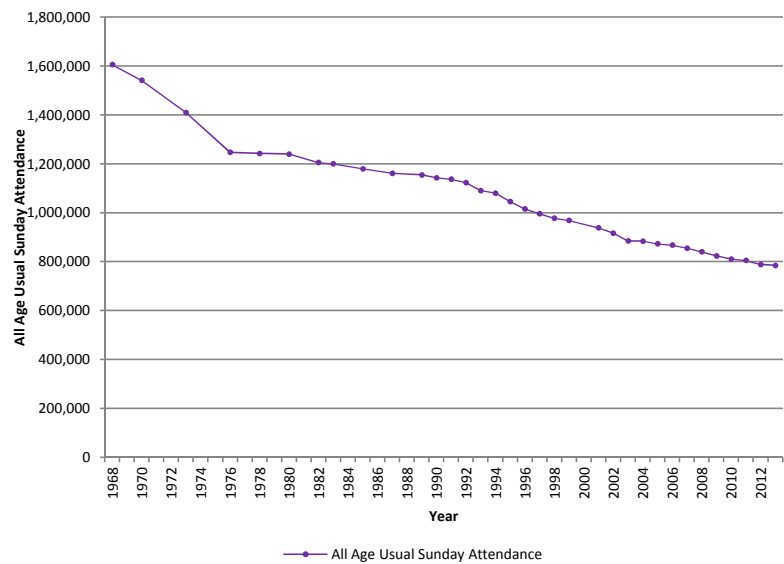


Figure 15: Total Church of England All Age Usual Sunday Attendance 1960 - 2012

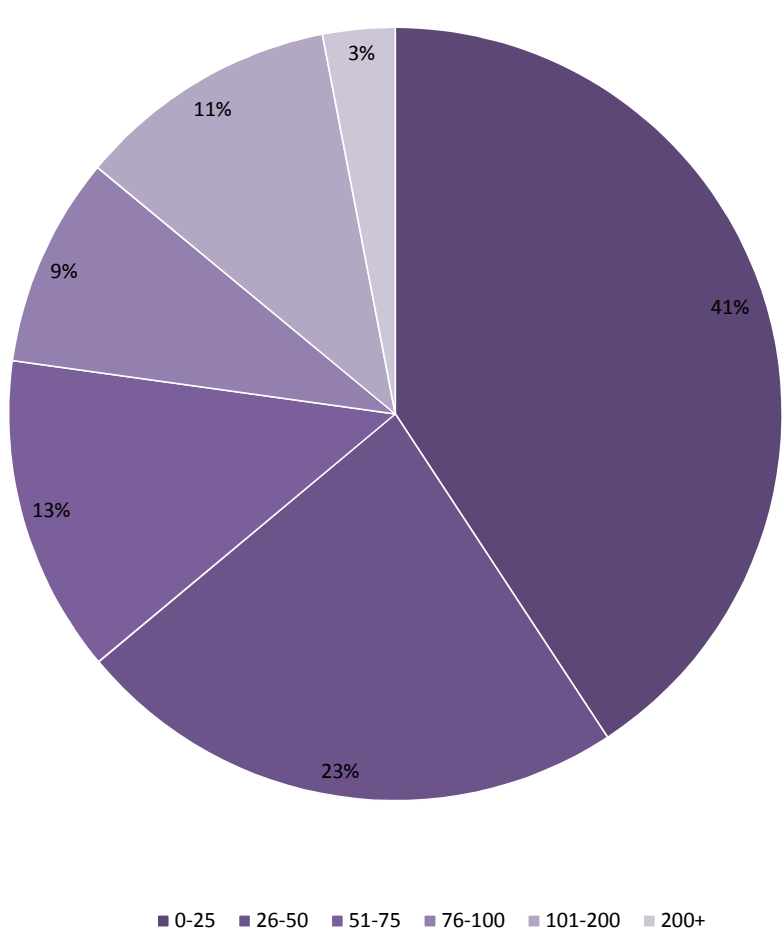
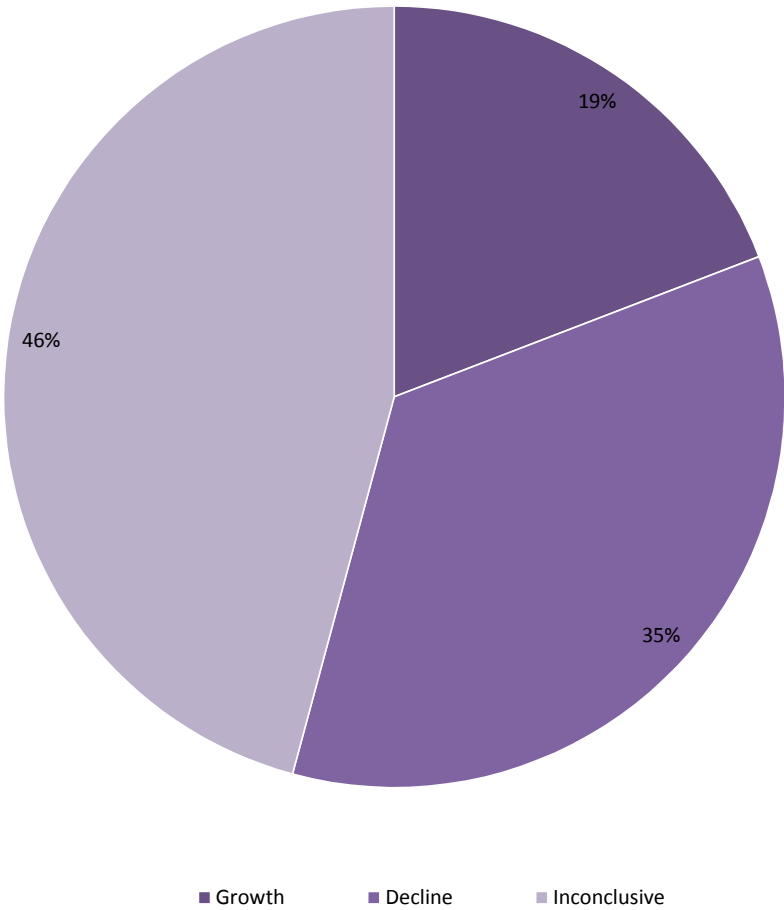


Figure 17: Proportion of Churches in All Age Usual Sunday Attendance Growth and Decline

Figure 18: Worshipping Community per 1000 Christians 2013

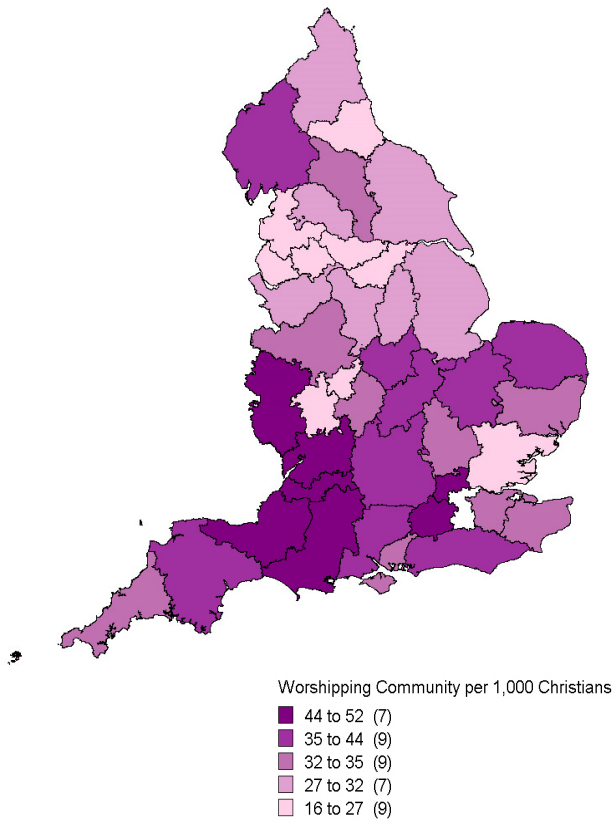


Figure 19: Total Church of England Worshipping Community by age 2013

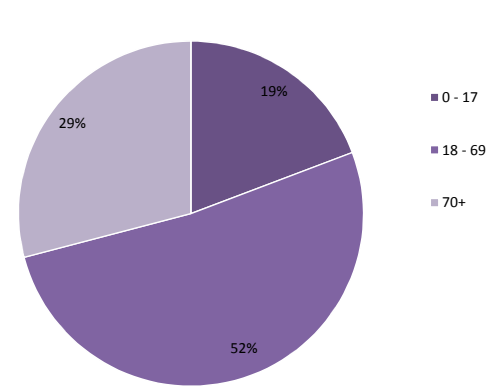
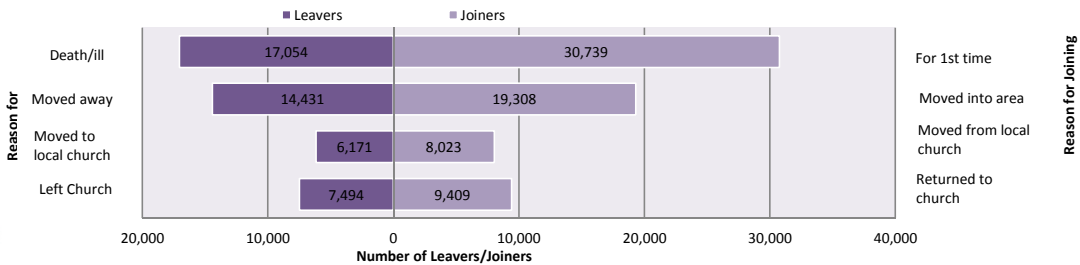

The Worshipping Community measure is in its second year of running and the total Worshipping Community in the Church of England in 2013 was reported to be 1.06m. One in five people in the worshipping community are 17 or under and 29% are 70 or over.

For the first time in 2013 a new split was introduced in the joiners and leavers part of the question to measure those moving to or from other local churches. Whilst there does seem to be a fair amount of local churn, nearly half of joiners (46%) reported by churches were coming for the first time.

The total Church of England worshipping community exceeded the average Sunday attendance, most notably for children. As in 2012, on average in 2013, All Age Average Sunday Attendance was 80% of the size of the worshipping community. This shows that on average people continue to attend worship just over three times each month.

The number of people on the Electoral Roll for the Total Church of England (excluding Europe) represented 2% of the adult population in 2013

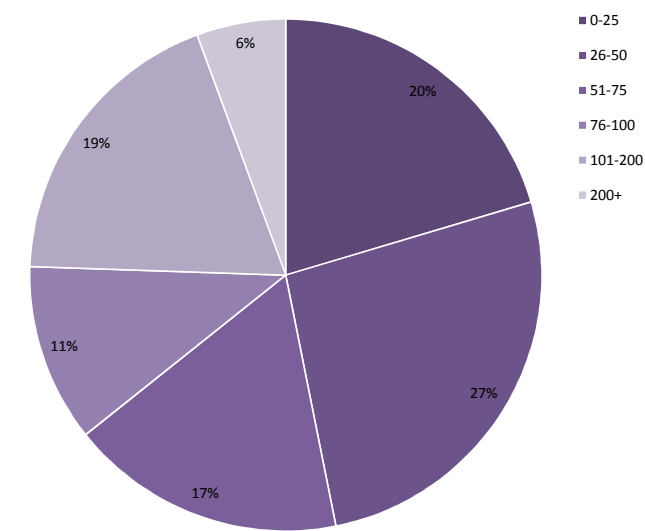


Figure 22: Total Church of England Electoral Roll Numbers 2004 - 2013

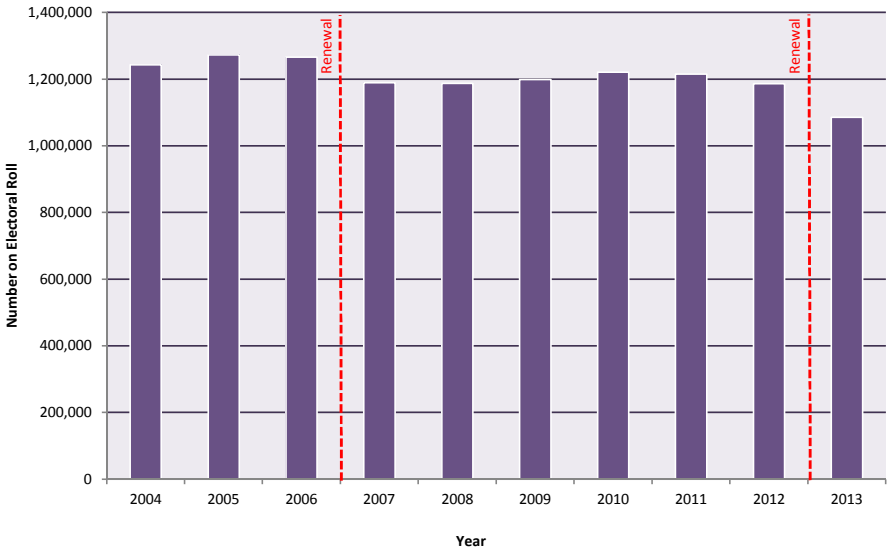
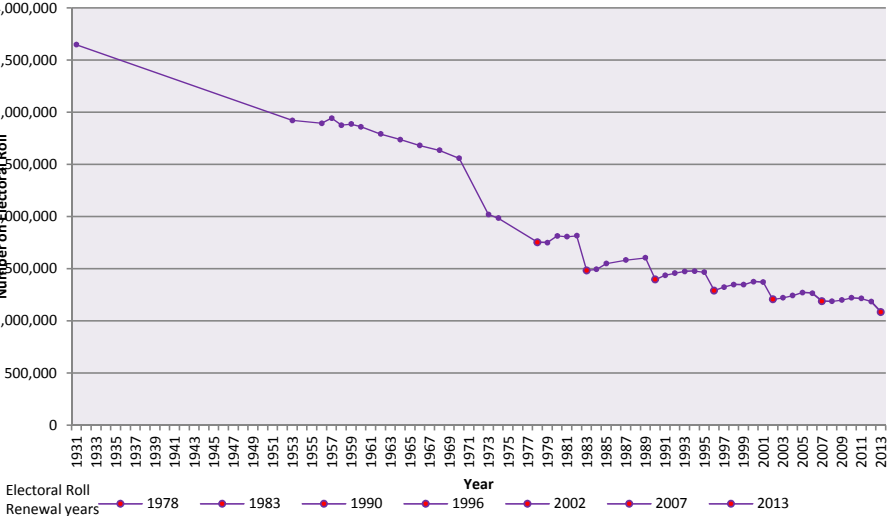

Figure 24: Easter Attendance per 1000 Christians 2013

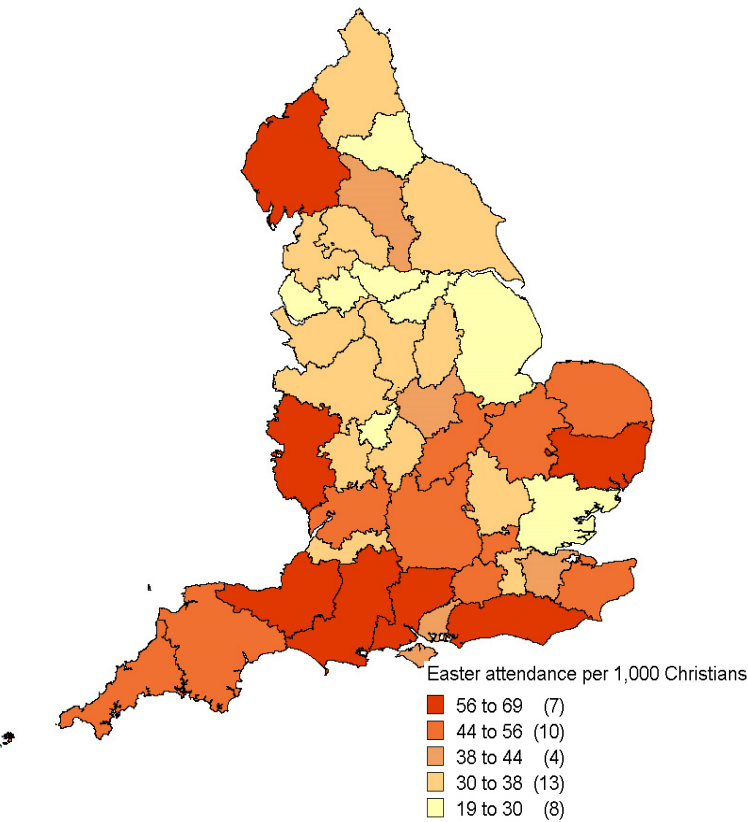


Figure 25: Total Church of England Easter Attendance and Communicants 2004 - 2013

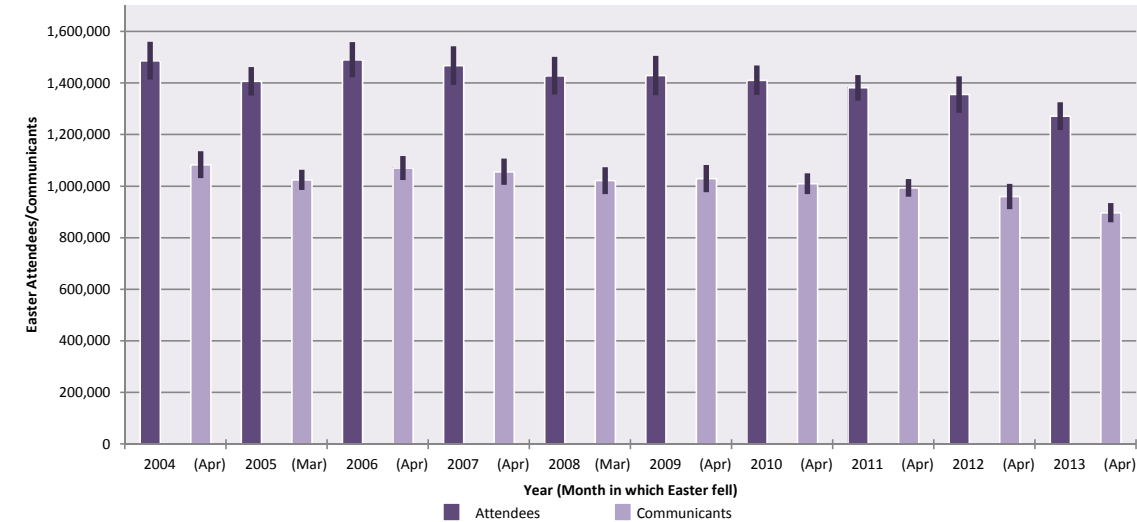
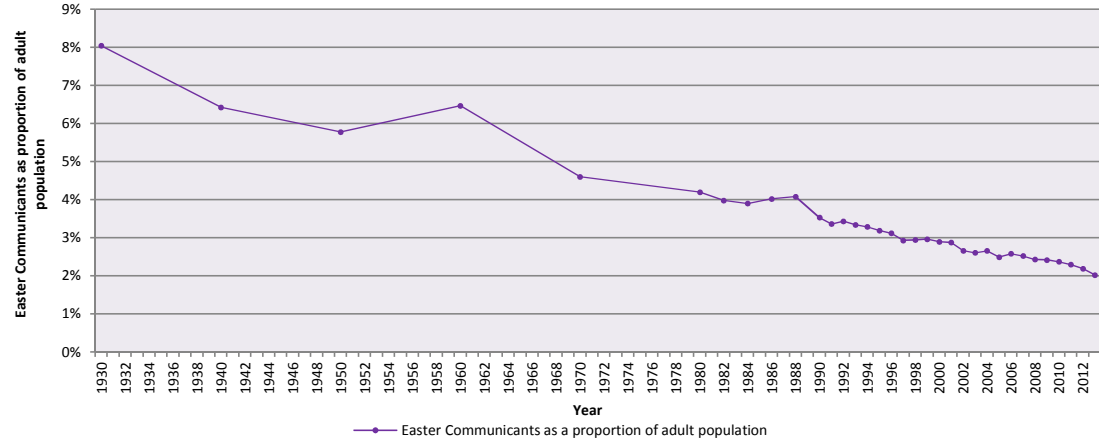


Figure 26: Total Church of England Easter Communicants in a Population context 1930 - 2013

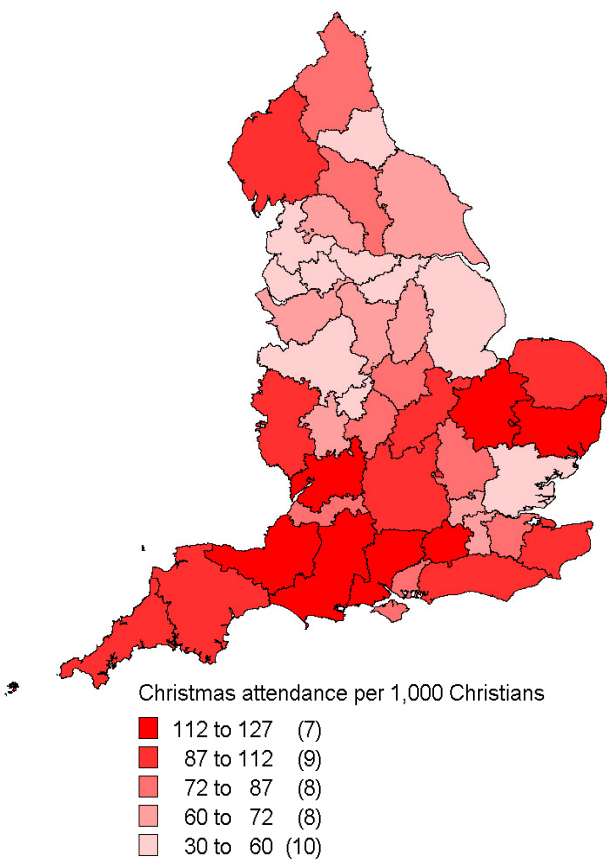

Figure 28: Total Church of England Christmas Attendance and Communicants 2004 - 2013

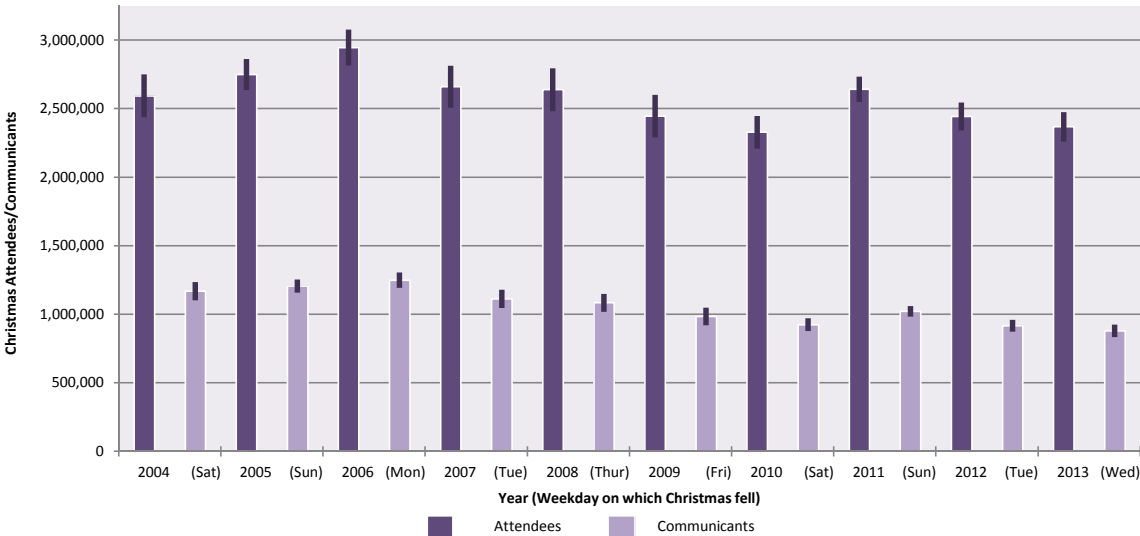
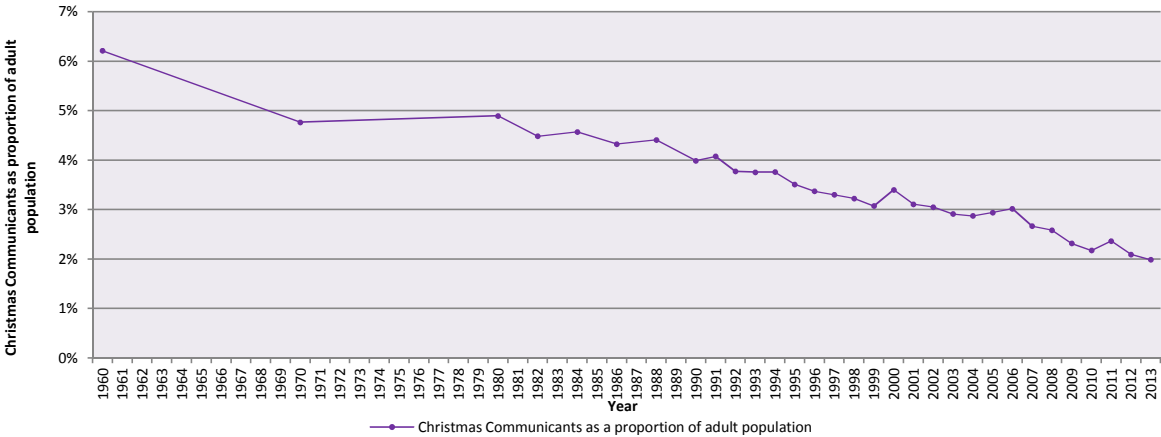


Figure 29: Total Church of England Christmas Communicants in a Population context 1960 - 2013

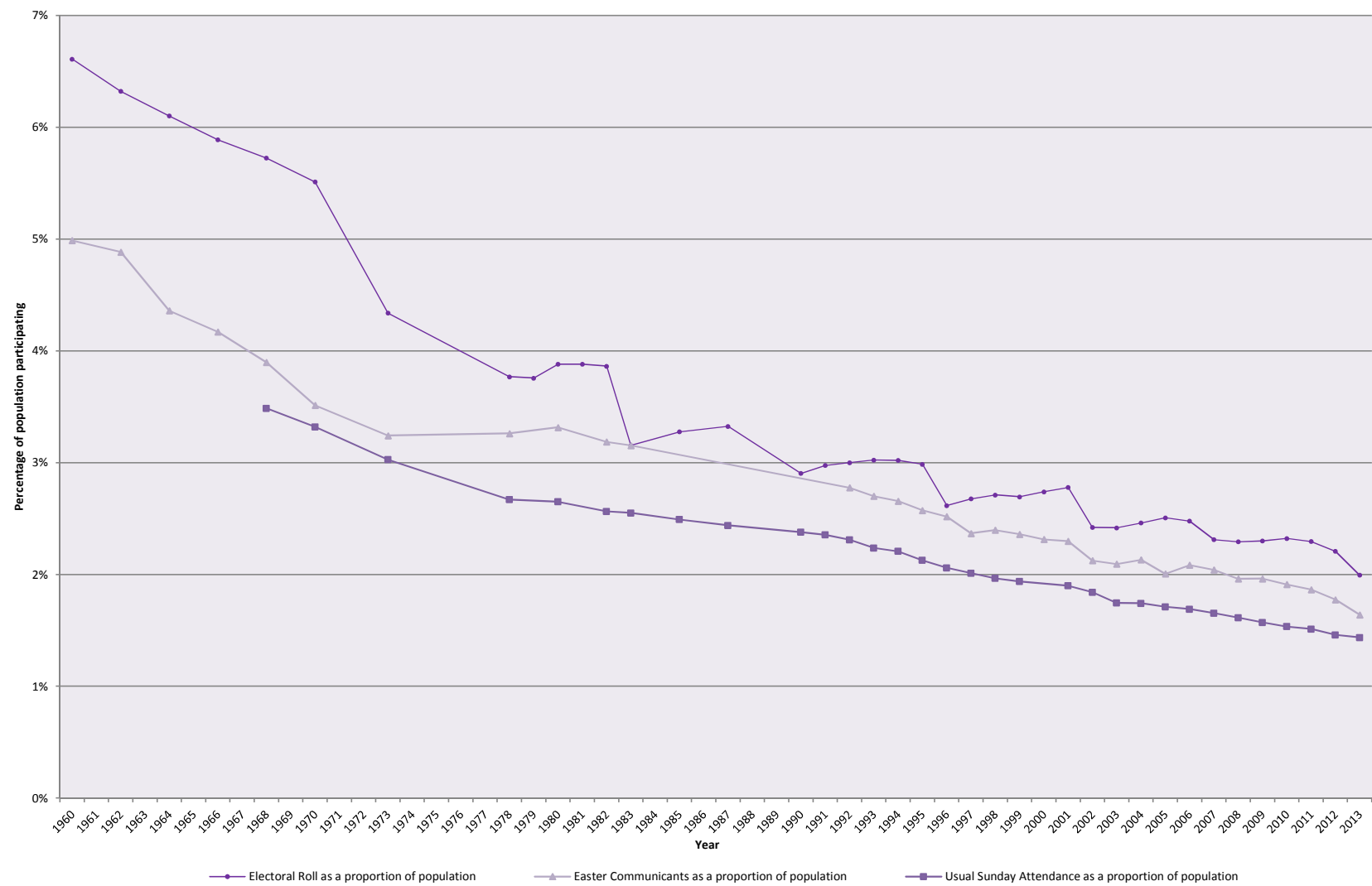

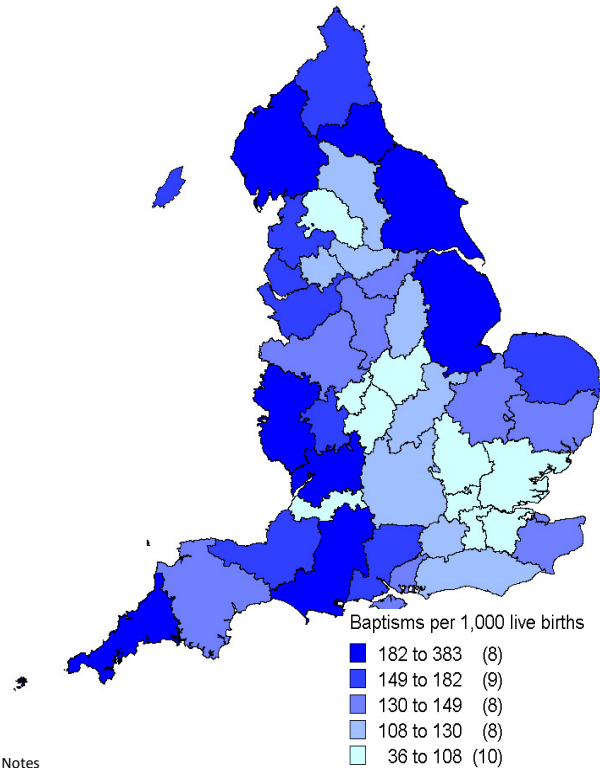

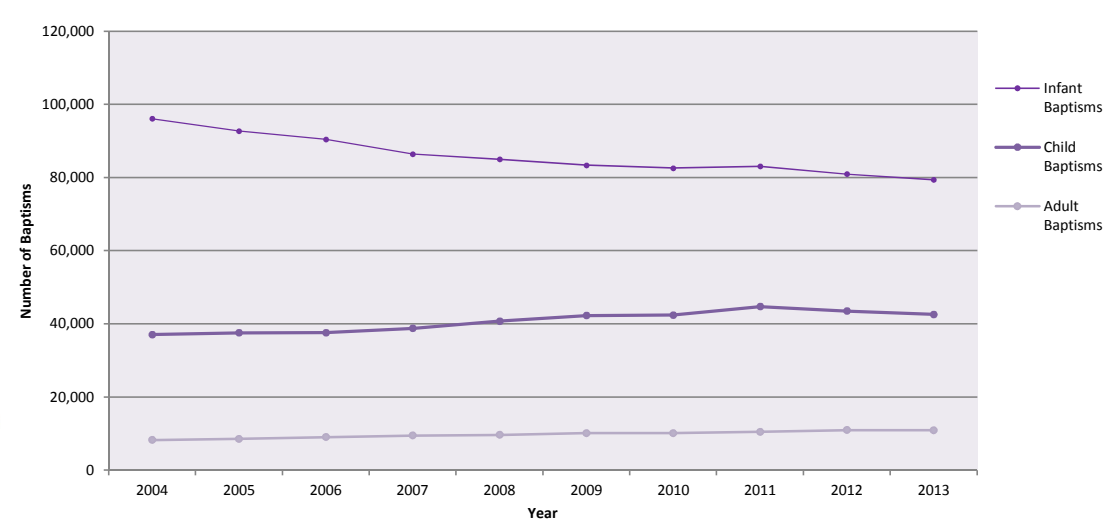

For the first time in 2013 churches were able to split their juvenile baptism figures into two age groups: 1-4 and 5-12. Where churches could do this, 77% of juvenile baptisms were of children aged 1-4.

There are signs that for the Church of England as a whole, the relative popularity of baptism at different ages has changed over the decade 2004 to 2013. Infant baptisms have fallen from 96,000 to 79,000 (a 17% decrease) while child baptisms have increased from 37,000 to 43,000 (15% increase) and adult baptisms have increased from 8,000 to 11,000 (32%). Overall, infant and child baptisms combined have decreased from 133,000 in 2004 to 122,000 in 2013.

The Church of England performed around 50,000 marriages in 2013 or nearly 1000 per week

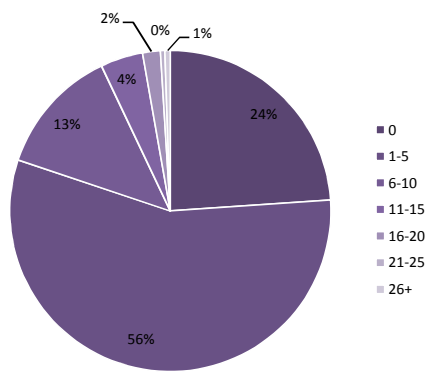
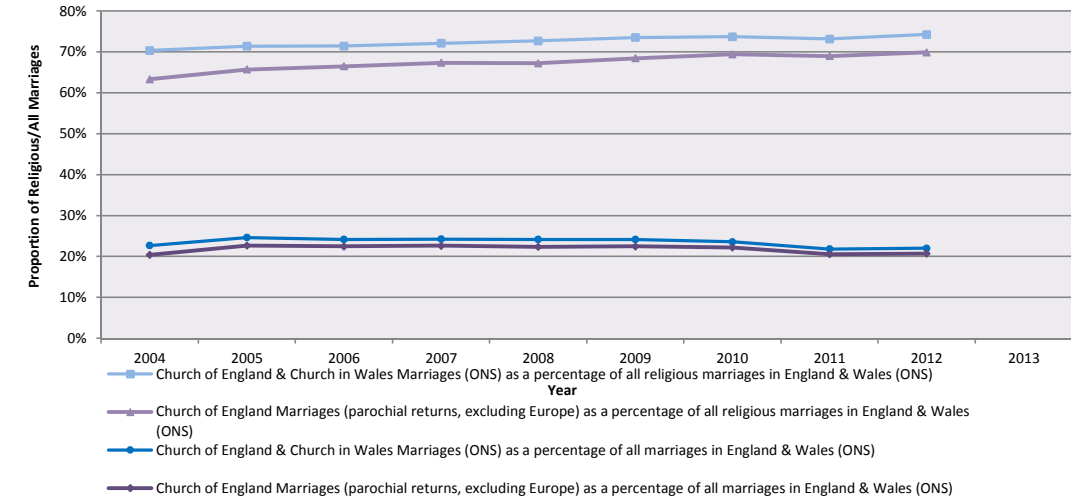
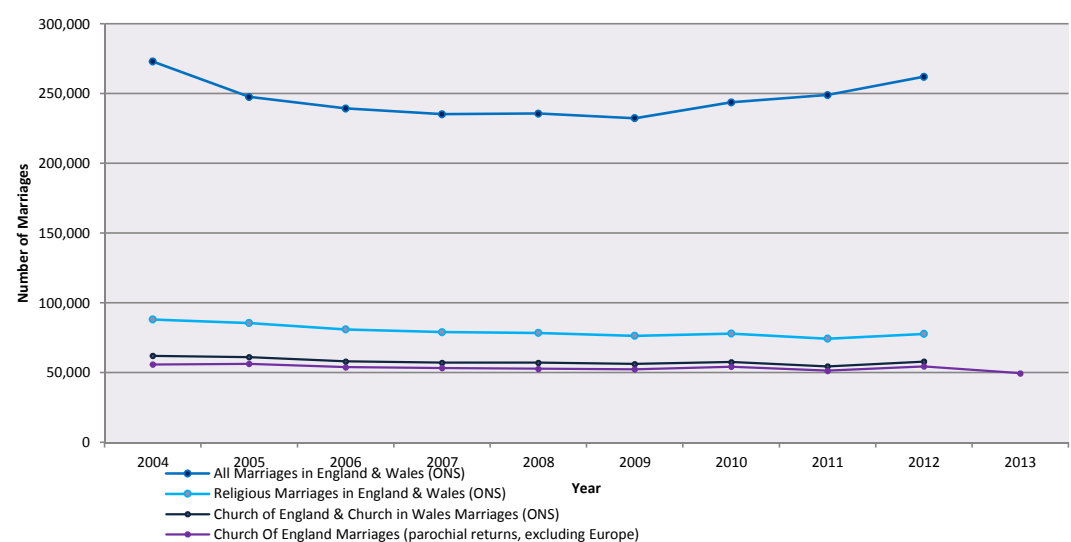


Figure 34: Total Church of England Marriages as a percentage of all Marriages 2004 - 2012

Figure 36: Church of England Funerals/services per 1000 Deaths 2013

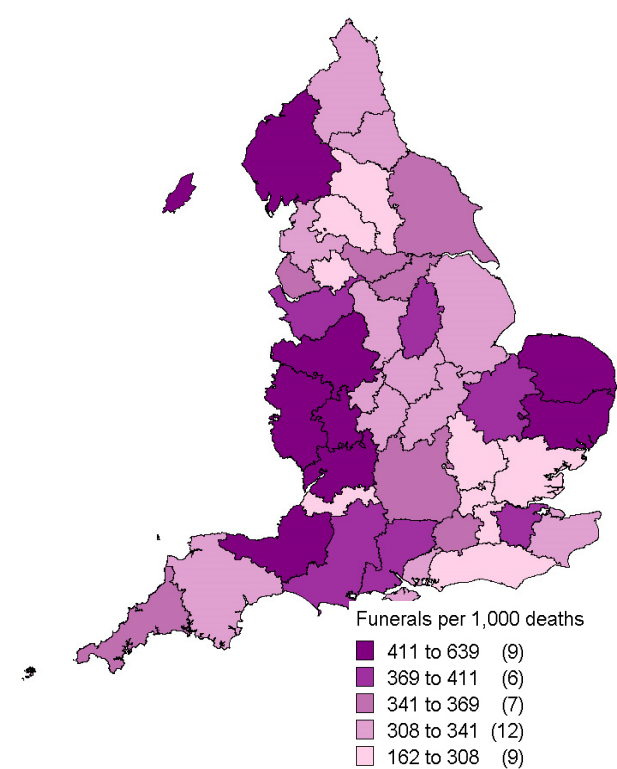
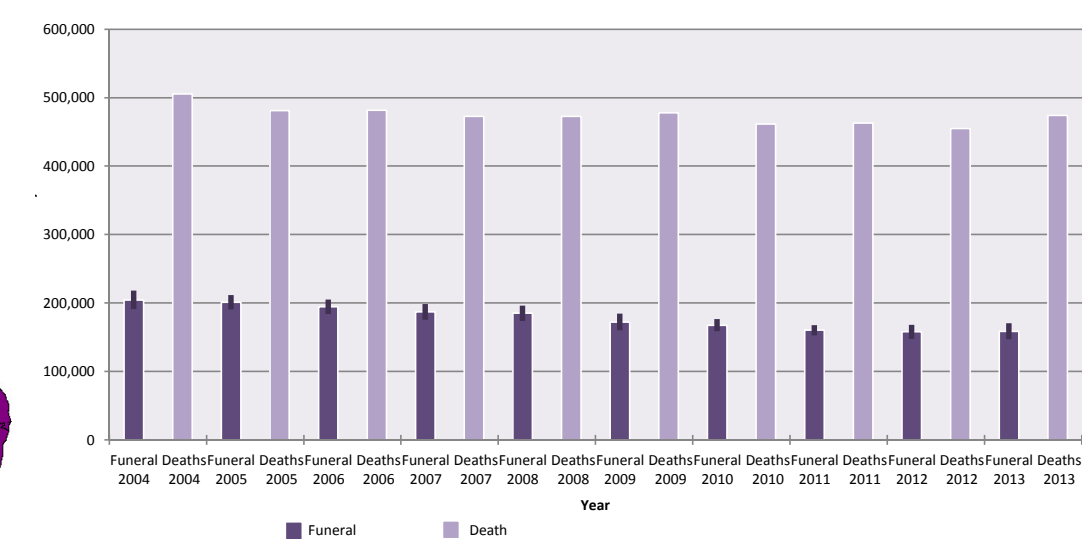


Figure 37: Total Church of England Funerals 2004 - 2013

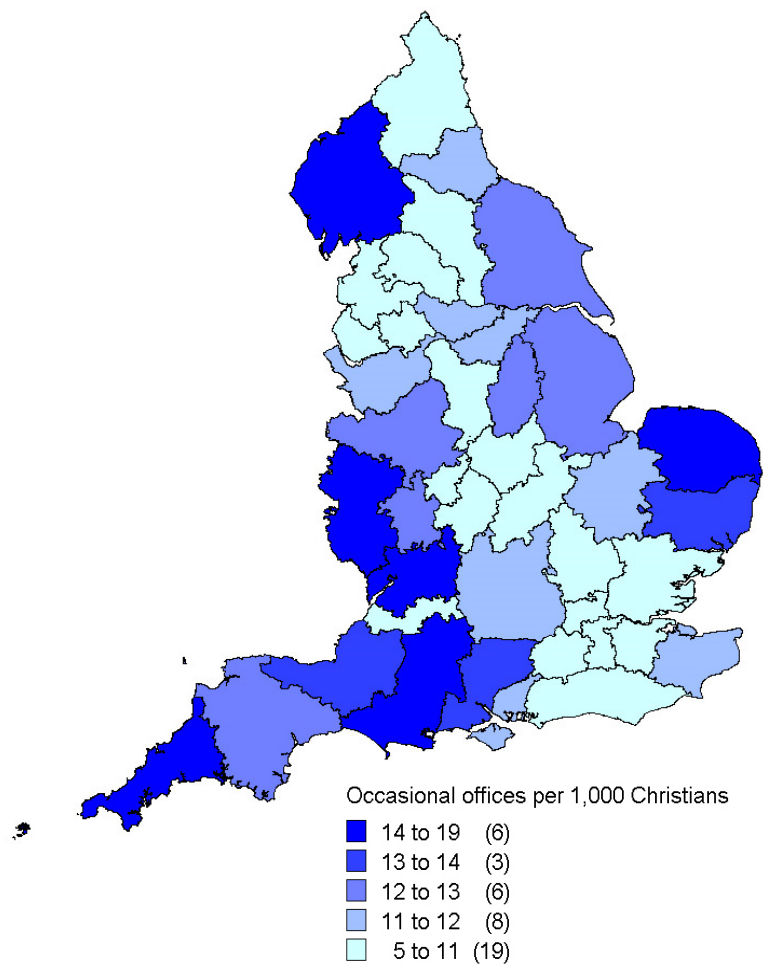

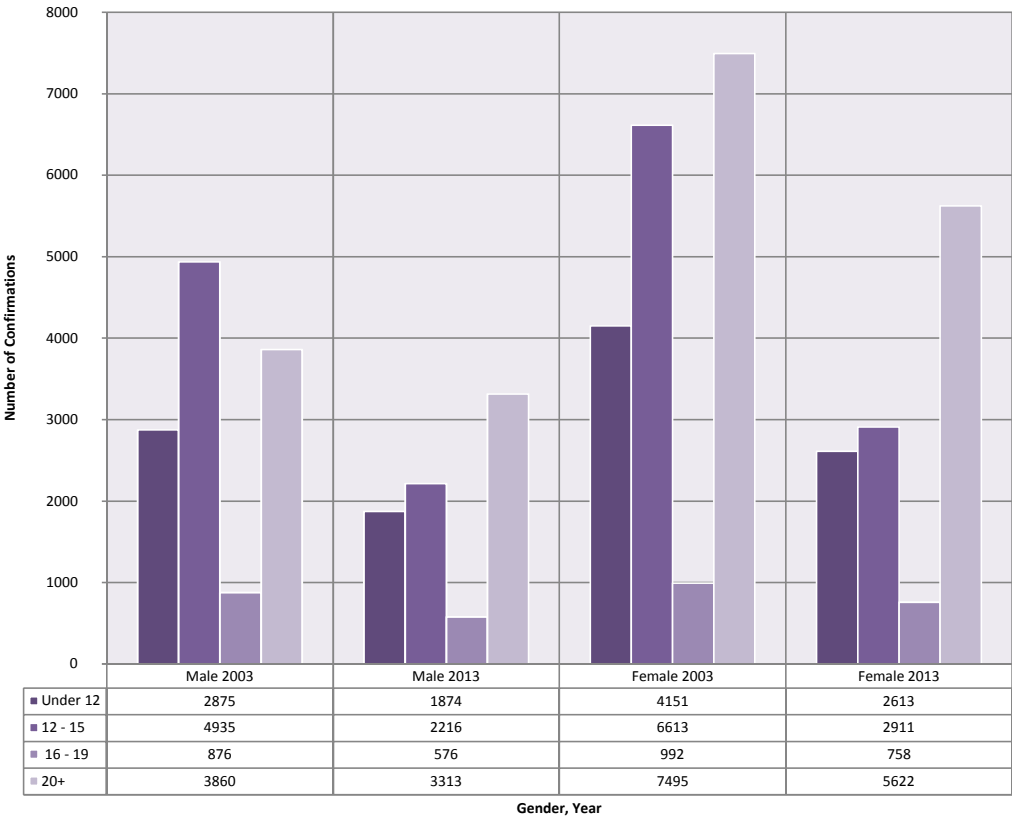

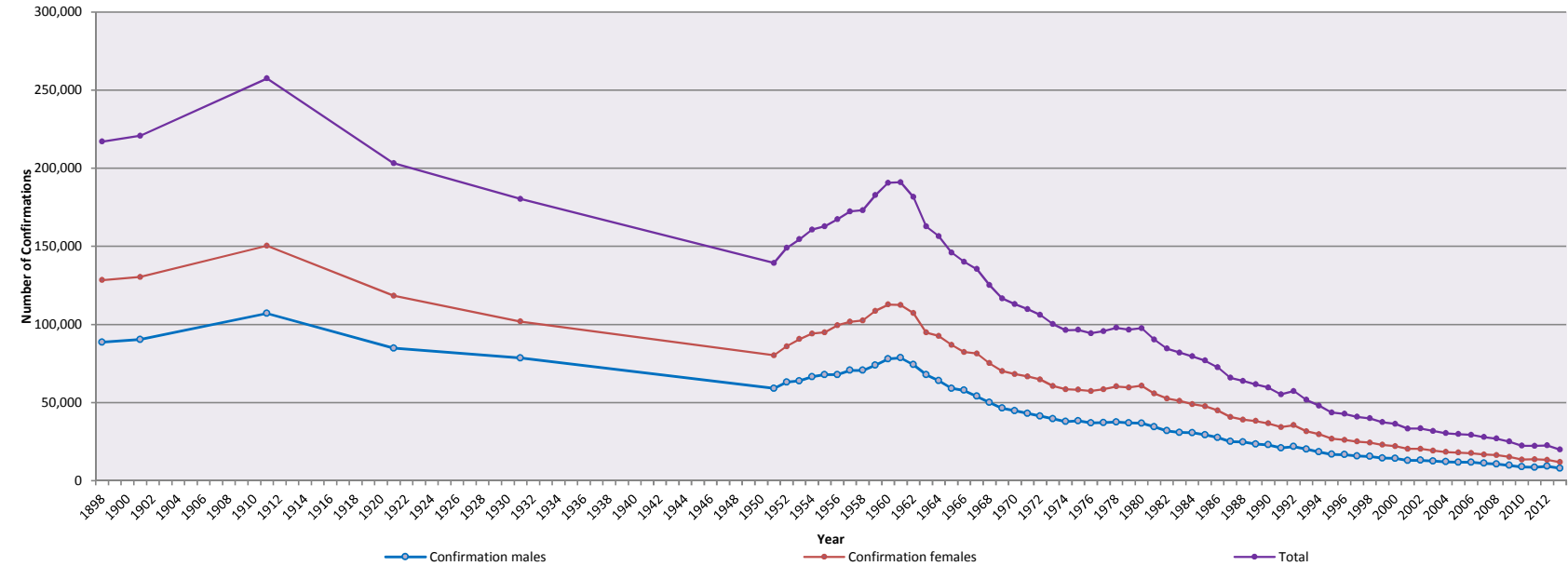
Figure 39: Total Church of England Confirmations by age and gender 2003 and 2013

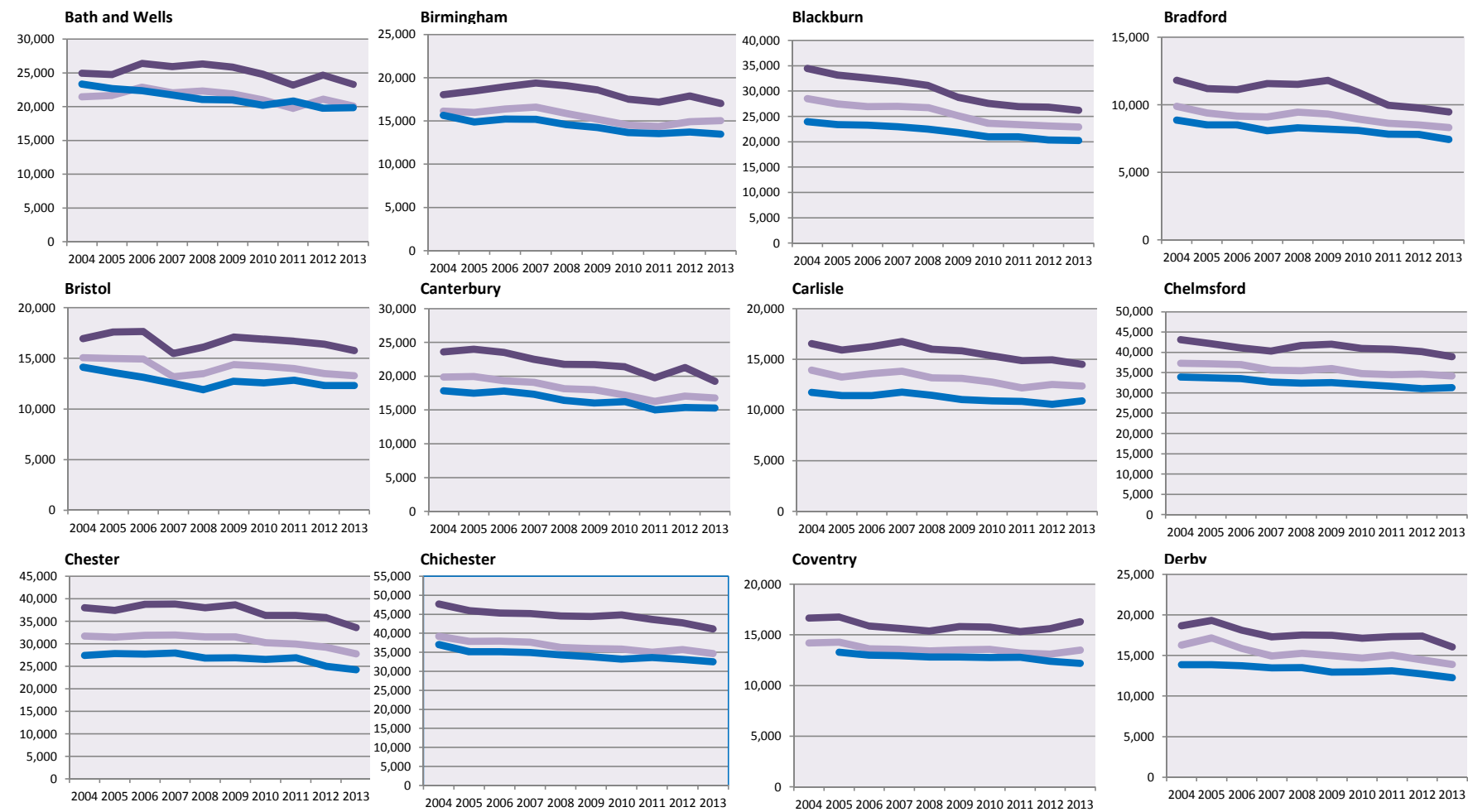
7,500 or 47% of churches responded to this question. The vast majority (85%) of individuals reported to be working with children and young people were volunteers, with 80,000 volunteers and 2,700 paid staff reported. Volunteers were most likely to spend their time at parent/care and toddler groups, church led children's activity groups and Sunday primary school groups. Paid staff were most likely to spend their time at Church led youth groups.

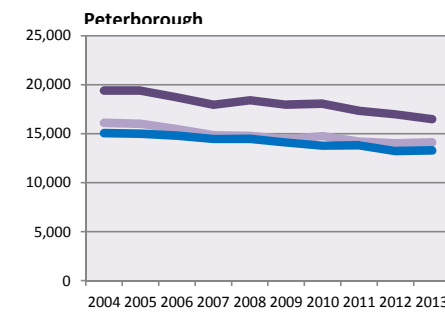
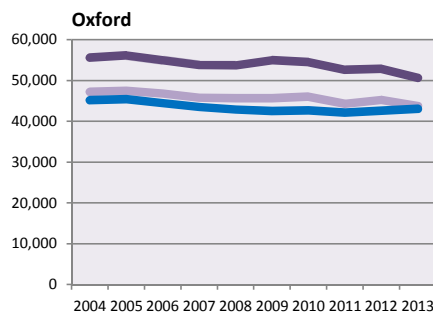
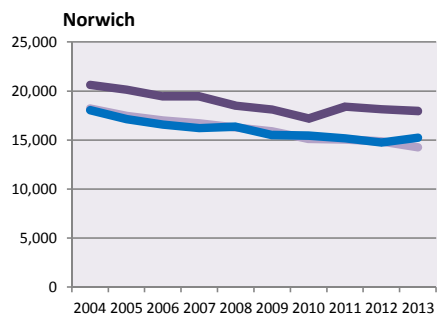
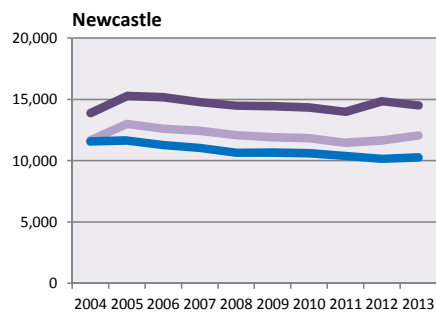
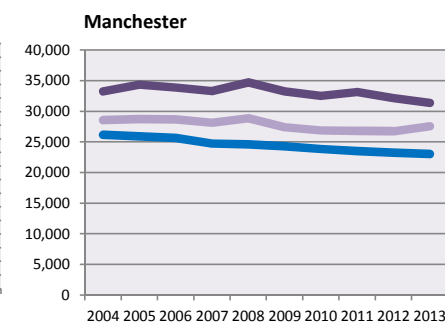
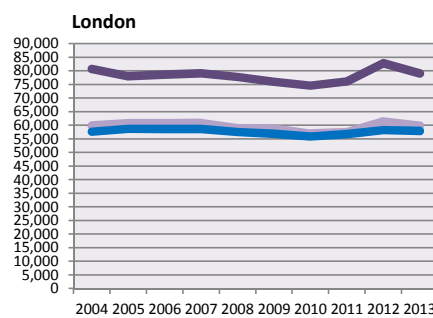
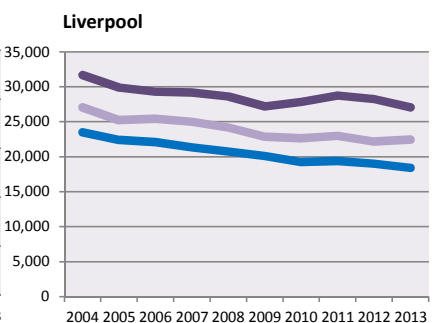
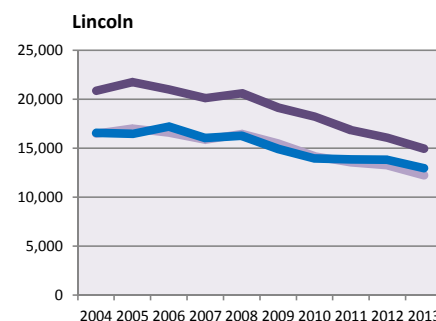
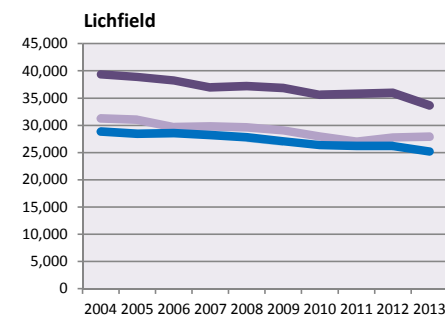
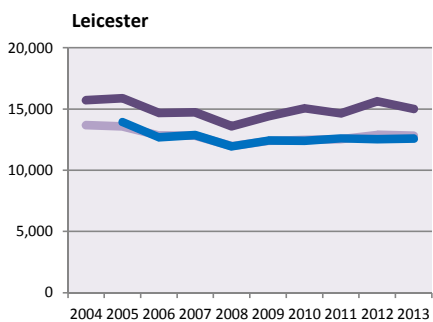
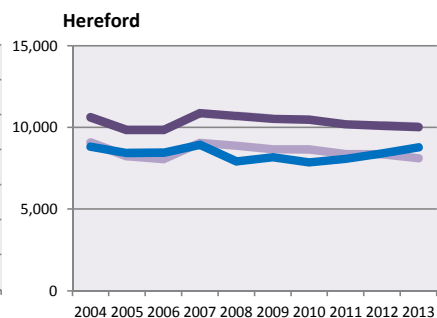
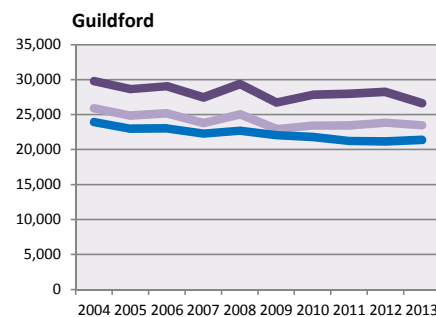
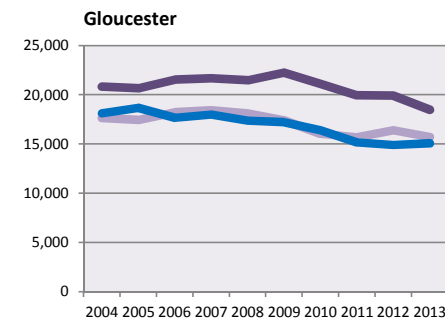
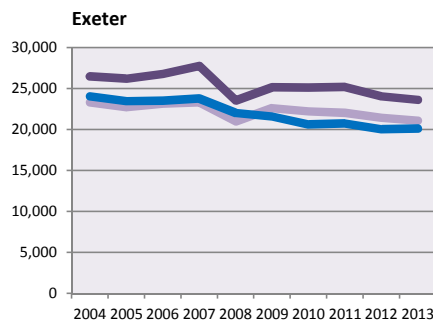
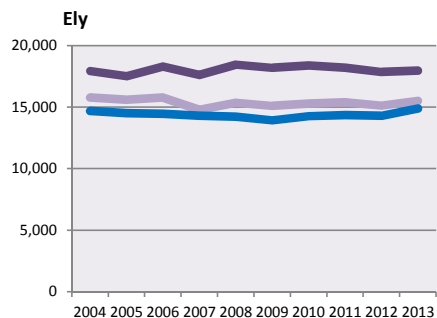
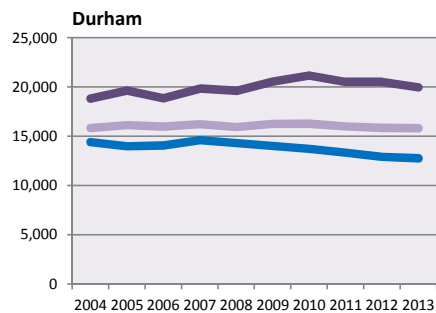

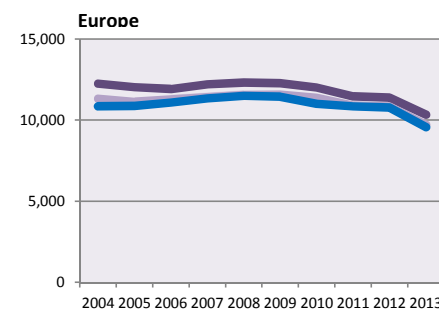
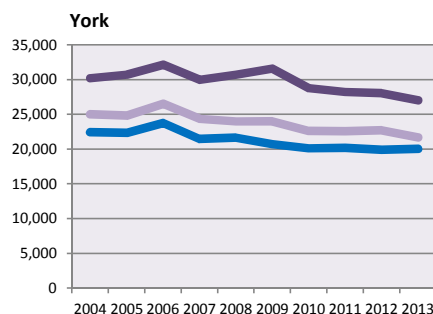
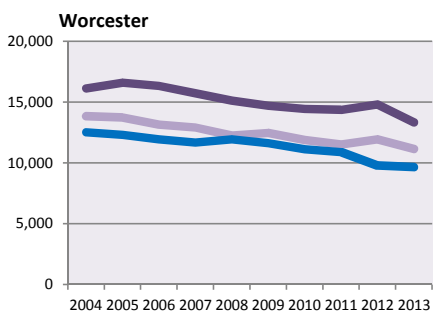
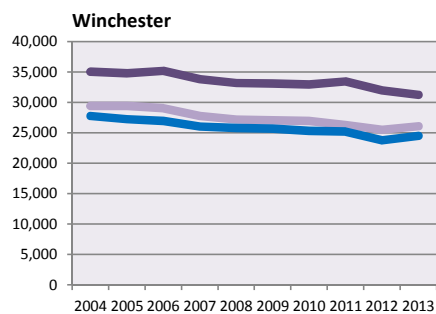
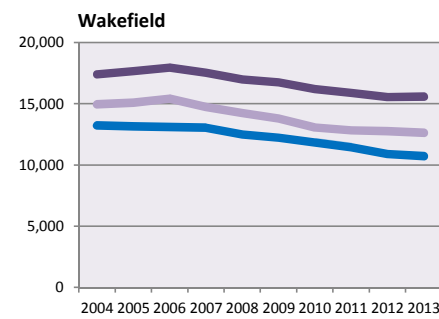
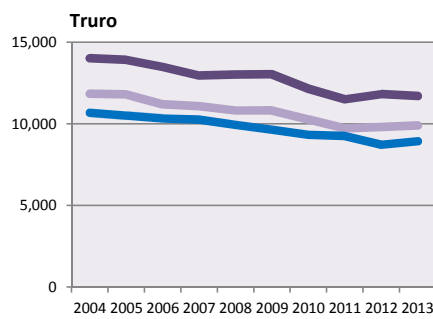
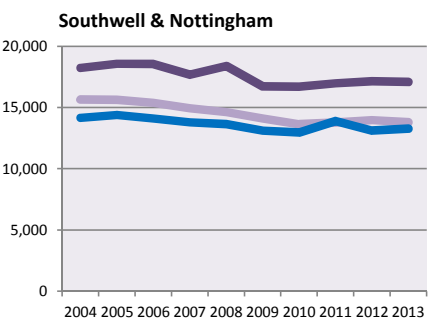
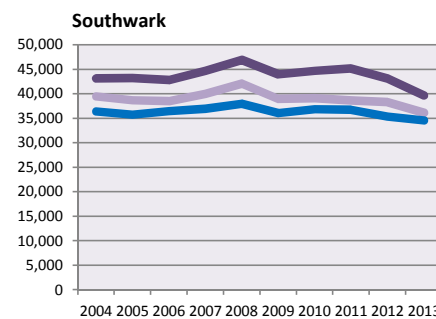
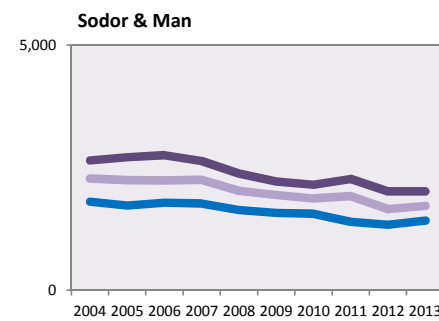
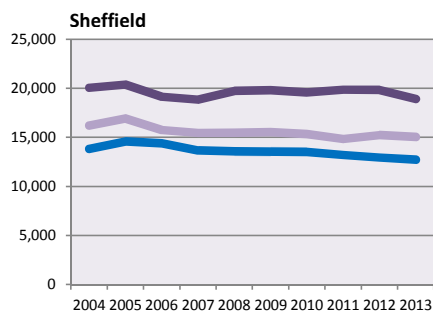
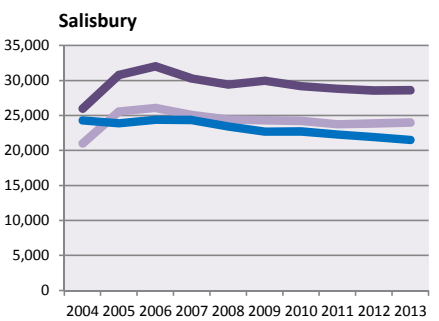
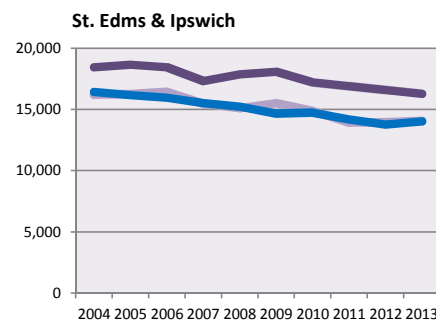
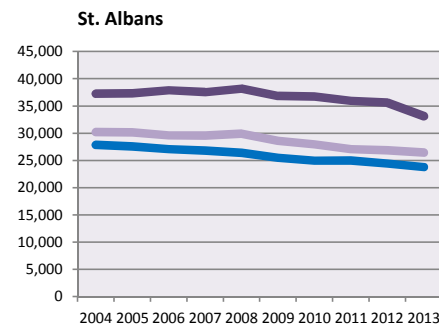
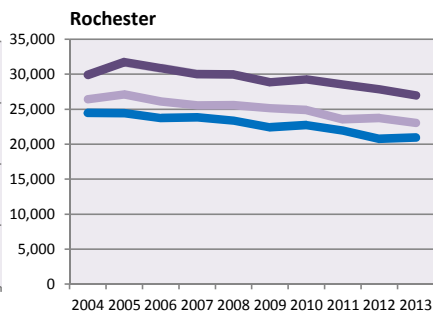
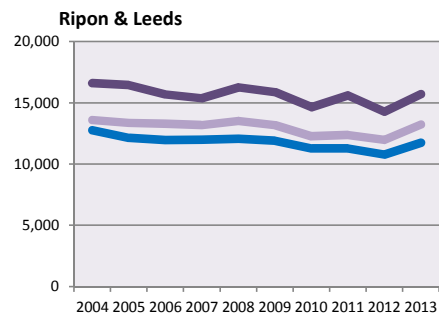
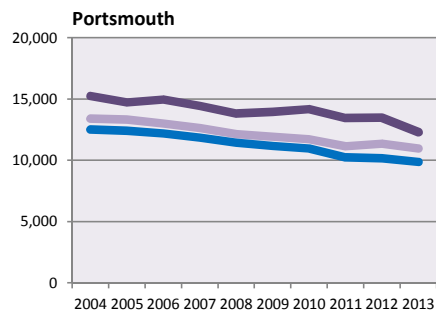
People are generally keen to know whether a particular diocese is growing or declining. The graphs below (Figure 32) enable us to visualise the changes in key attendance figures over the last decade. For the majority of dioceses, any changes are small and often inconsistent in magnitude and direction. In some cases, large increases or decreases in a single year could be more indicative of a data anomaly than of real growth or decline over the period. Gridlines are positioned in increments of 5,000 attendees in order to allow some comparison across dioceses

Calculating Average Weekly Attendance (AWA)

Average weekly and average Sunday figures are calculated from counts from the first 4 weeks of October, however some churches do not have services every week. Up to 2011 AWA was calculated to reflect an average figure for when there was a service. Imagine a church that has 3 services a month, each where 40 people attend. Their AWA figure would be calculated as $(40 + 40 + 40)/3 = \text{AWA } 40$. However, it is likely that at least some of the time those individuals may attend another church on that 4th Sunday. Therefore if we added together the AWA for both churches, we may be double counting individuals. This is particularly true in areas where there is rotation between churches. To reflect this, the calculation is $(40 + 40 + 40)/4 = \text{AWA } 30$. This gives a more accurate picture of how many people go to church on an average Sunday across the country, and all previous years have been revised to reflect this new method.

Highest weekly attendance takes the maximum of the 4 weeks in October for each church/parish and adds them together. Lowest weekly attendance takes the minimum of the 4 weeks in October (where there was a service) for each church/parish and adds them together. This gives an idea of the variation in attendance across the month. “Midweek attendance” reflects a count of those who attend during the week but would not have been counted on a Sunday. This avoids double counting of individuals who may have attended multiple services through the week.

Introducing Estimation and Error

In 2013 for around 20% of churches/parishes it was necessary to do some estimation for missing data. Estimation introduces error into the data, so for all figures presented in this report it is likely that the true value lies either a little bit higher or a little bit lower than the stated figure. To illustrate how much higher or lower than the stated figure the true figure could be, we have used “error bars” on graphs, and given a +- figure in the table. Following is an explanation of how the estimates were calculated and some illustrations of how error can help to interpret the figures.

Estimation

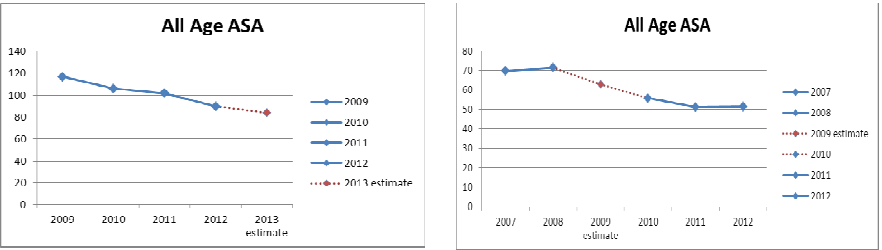
Estimation of core annual data is conducted for each individual churches/parishes. The first challenge with estimation is to know when to estimate. If a church or parish hasn’t submitted a return at all and it is still an open church, then it is clear that there needs to be some estimation. Where a church/parish has submitted some figures and left other blank, we need to discern whether the fields they have left empty are because, for example, they didn’t have any services at Christmas so no estimation is required, or because they were unable to find the figures, in which case we do need to estimate.

The following assumptions were made:

- 1. If there is no return, but the church is open, then we will estimate for all fields
- 2. Occasional offices: If the church has reported any occasional offices then we assume that any blank fields for other occasional offices indicate that none occurred, so no estimation is conducted.
- 3. Easter: If the Easter attendance/communicants figures are blank/zero and the church had reported Easter figures in more than half of the previous 6 years, then we assume a service did happen and an estimate is made. This aims to recognise where service rotation may be occurring.
- 4. Christmas: If the Christmas attendance/communicants figures are blank/zero and the church had reported Christmas figures in more than half of the previous 6 years, then we assume a service did happen and an estimate is made. This also aims to recognise where service rotation may be occurring.
- 5. October Count: it is assumed that all churches will have at least one service in October, so if the October Count is zero, an estimate will be made. This will create estimates in error in a small minority of cases, but again, this is far less likely than zeros indicating missing data.
- 6. Usual Sunday Attendance: it is assumed that all churches will give some Usual Sunday Attendance figure, so if there are zeros, this is then estimated.

Once a need to estimate has been established, the second challenge is to use the data we have for previous or surrounding years to create an estimate. If there is a gap in 2013 data, then data from the previous 4 years are used to create a trend line to project a likely growth or decline. If data are missing for an earlier year, then the data for surrounding years are used to join the dots for the middle years. Estimates for 2012 have been revised where 2013 data have made a better estimate possible.

The figures below are examples of 2 churches, one where there was no return for 2013 and the second where there was no return in 2009.



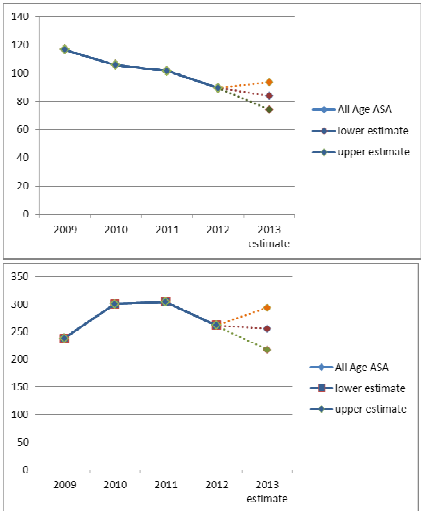

Worshipping Community estimates

The Worshipping Community measure, introduced in 2012, aims to measure the size of the community who attend worship at least once a month or would do so if not prevented by ill health. The data for this measure are new and as such there is no clean relationship between worshipping community figures and attendance figures or electoral roll. Therefore it is not wise to do any kind of church/parish level estimation. A bulk estimate was done at Diocesan level using the electoral roll. Based on the electoral roll of the whole diocese and the aggregated electoral roll of those diocese that gave a worshipping community figure, what proportion is missing? No estimation was done for joiners or leavers as this cannot be extrapolated.

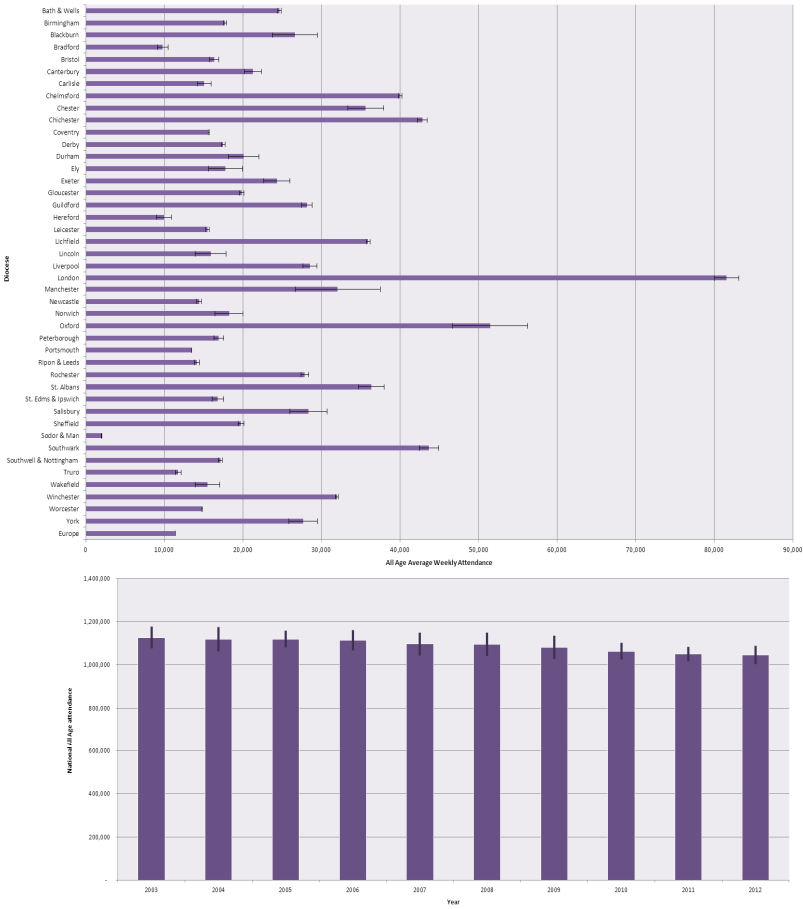
Error Bars

Where an estimate is calculated, it is possible that the true figure is actually a little higher or a little lower than the estimate. Where the trend for previous or surrounding years is very stable then it is likely that the estimate is fairly close. However, where the figures for a church are very volatile then the estimate may be a little more wild. The upper and lower bounds are calculated by looking at the standard deviation of the data which we have. The figures below give two examples. The lines show the estimate we have calculated, alongside an upper and lower estimate. It is likely that the true figures lies somewhere between that upper and lower estimate. The second example illustrates that these upper and lower estimates become further apart for data that are more variable.



If we add together all these likely errors for each church/parish that we have estimated for, then we can get an idea of how far above or below the stated diocesan and national figures the true figure could be. For dioceses where there has been a substantial amount of estimation, the potential for error is greater.

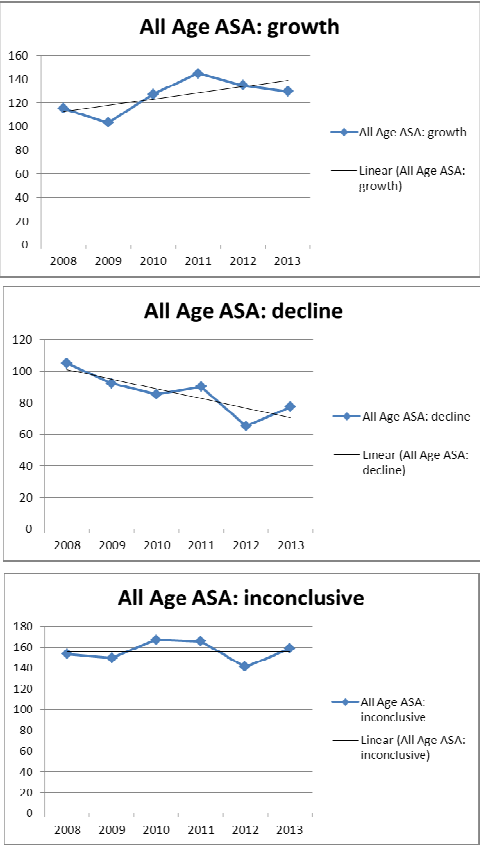
In the report \pm (read "plus or minus") figures are given for each field. A national figure of All Age ASA of 859,200 with an error of $\pm 4\%$ means that the true value of All age ASA is most likely between 825,000 and 894,000. Lines are given on graphs to illustrate these upper and lower bounds.



Methodological annex

Calculating Growth

Throughout the report we have given a figure of the proportion of churches that are growing or declining. As the graphs below illustrate, the trend for churches isn't always a beautifully straight line. We have used a similar process to that used in the National Church Growth Research Programme (see www.churchgrowthresearch.org.uk for further information), by looking at the standard deviation of the data over a 6 year period to look at what sort of increase or decrease we'd need to see to be sure that the church was in growth or decline, and not just experiencing wobbles in their figures. We have then compared the recent part of the period (2011 to 2013) with the earlier part (2008 to 2010).



Population statistics

All population statistics relating to England and Wales (total population, adult and child populations, Christian affiliation, live births and deaths) come from the Office for National Statistics, published on government boundaries. These data are modelled to translate them onto Diocesan boundaries.

It is not always possible to produce statistics for Sodor and Man and elements of Winchester (namely Jersey and Guernsey) since data come from other sources and aren't always available.

Population statistics are not given for the Diocese in Europe due to its unique nature.

Local Ecumenical Partnerships

Among the 12,500 parishes of the Church of England there are around 700 Local Ecumenical Partnerships in roughly half of which there is a congregation and a ministry shared between the Church of England and certain other churches. In such circumstances it is not always possible (or indeed desirable) to isolate the Anglican component of the congregation. The parochial statistics will therefore include a small element which may appear also in the statistics of other churches.

Cathedrals

Figures for cathedrals are included as far as possible.

Europe

Figures for the Diocese in Europe are included as far as possible. The Diocese in Europe is part of the Province of Canterbury.

Adults and Children

For attendance statistics from the October count or Usual Sunday, children are those under 16 and adults are aged 16 or over.
