

Details regarding proposed pastoral reorganisation affecting all the parishes in the deanery of Wigan in the diocese of Liverpool.

The proposals provide for the creation of 7 new parishes from the existing 29 parishes which comprise the deanery of Wigan and the creation of a new benefice called "The Benefice of Wigan" comprising the 7 new parishes.
