

Report by the Business Committee

Introduction

1. This is a short group of sessions which comprises only two days of Synod business. However, members of the Synod will continue to meet for the purpose of the Shared Conversations from the afternoon of Sunday 10 July until lunchtime on Tuesday 12 July. Information regarding the Shared Conversations will be provided separately.
2. This report falls into three parts:
 - Part I introduces the Agenda for the July group of sessions and highlights distinctive features;
 - Part II comments on individual items of business;
 - Part III reports on other work and recent decisions of the Business Committee.

I: The July 2016 Group of Sessions

3. The Synod will meet at the University of York from 2.30 p.m. on Friday 8 July until 10 p.m. on Saturday 9 July.
4. The House of Laity will meet from 1 p.m. to 2 p.m. on Friday 8 July.
5. The following Anglican and ecumenical guests will be present as observers on this occasion:
 - Mr Andreas H Aarflot, Adviser of the National Council, Department of Church Order, Church of Norway
 - Mr David Ritchie, Secretary General, Representative Church Body, Church of Ireland
 - Landesbischof Ralf Meister, Evangelische Kirche in Deutschland, and co-chair of the Meissen Commission
6. Landesbischof Ralf Meister, Evangelische Kirche in Deutschland, will deliver a brief greeting to the Synod on behalf of the ecumenical guests on Friday afternoon.

Synod Worship

7. The group of sessions will begin with an act of worship in the Central Hall. On the morning of Sunday 10 July, there will be a celebration of Holy Communion at York Minster at which the Archbishop of Canterbury will preside and the Archbishop of York will preach. The Shared Conversations will conclude with an act of worship in the Central Hall.
8. The Continuous Praying Presence will be based in the Berrick Saul Building and Synod members are welcome to join this where possible. All services, apart from those in the Central Hall and those taking place in group work groups, will take place in the Berrick Saul Building. Please refer to the Agenda for a list of services for the period Friday to Saturday.

Shape of the Agenda

9. The Agenda includes the following types of business:
 - Formal business and presentations
 - Brief address to Synod on behalf of the ecumenical guests
 - Regular items such as the debate on the Business Committee Report, Synod Question Time and the Archbishops' Council's Annual Budget
 - Legislative Business
 - Two 'take-note' debates: one on a report from the Education Office, one on the Church Commissioners' Annual Report
 - Debate on a motion on Renewal and Reform
10. In putting together the Agenda for this Synod, the Business Committee was aware that it had only 1.5 days for formal Synodical business prior to the start of the Shared Conversations. Most of the Friday is taken up with the usual formal and other Synodical business. The Take Note debate from the Development and Appointments Group is returning to Synod at the request of an earlier Synodical decision in 2014.
11. Priority is being given on Saturday to legislative and financial business, leaving only 45 minutes for other items. Within these constraints, the Business Committee has done its best to ensure that a variety of items are being considered by Synod this July.
12. Legislative business will be taken on the morning of Saturday 9 July and will continue after the lunch break. On Saturday afternoon, there will be a debate on a motion on the Renewal and Reform initiative, and a 'take note' debate on a report from the Education Office. On Saturday evening, the Synod will be asked to approve the Archbishops' Council's Budget for 2017.
13. The Synod will be prorogued on Saturday evening. The Shared Conversations will take place from Sunday afternoon to Monday lunchtime. Details of the Shared Conversations will be provided separately. All Synod members are encouraged to participate in the Shared Conversations.

Order of Business

14. Members are reminded that if at any time within the group of sessions an unexpected gap opens in the Synod's Agenda, business earlier in the Agenda which has not been reached or completed within the period allotted can be called by the Chair, unless other provision has already been made for it.
15. Synod members will note that the Synod timetable was published with indicative timings for items of business to help Synod members plan their time. It should be emphasised that these are purely indicative timings, and the length of time taken by any item is in the hands of the Synod.

Legislative Business

16. Owing to the short length of this group of sessions, legislative business will comprise the greater part of the Synod's Agenda. Special Agenda I contains 11 items of legislative business. Each new item of legislative business is accompanied by an explanatory memorandum which provides a detailed explanation of the provisions it contains.
17. Details of the individual items of legislative business are given below at the point where they are to be taken.

Private Members' Motions and Diocesan Synod Motions

18. Private Members' Motions ('PMMs') are listed in Special Agenda III. There are 5 current Private Members' Motions but none have yet reached the threshold of 100 signatures needed in order for the Business Committee to consider scheduling a debate.
19. Diocesan Synod Motions ('DSMs') are listed in Special Agenda IV. There are currently 7 DSMs awaiting debate. The 3 DSMs relating to the Anglican Communion Covenant remain 'parked', pending further discussions within the Communion.
20. The Business Committee has taken counsel from the House of Bishops who have requested a clear space in February to discuss any matters arising from the Shared Conversations. For this reason, the scheduling of the Blackburn Diocesan Synod Motion on "Welcoming Transgender People" will not be taken until July 2017.

II: Individual Items of Business

21. This section of the Report comments on individual items of business. They are discussed in chronological order.

Friday 8 July

22. The newly elected Pro Prolocutors of the Convocation of Canterbury and Deputy Prolocutors of the Convocation of York will be presented to the Archbishops.
23. By way of a response on behalf of the Ecumenical Guests, Landesbischof Ralf Meister, Evangelische Kirche in Deutschland, will address the Synod.
24. The Archbishop of York will share with the Synod his 'Pilgrimage of Prayer, Witness, and Blessing, which took place from Advent 2015 to Trinity 2016.
25. The Bishop of Chelmsford and Canon Margaret Swinson will then give an update on the meeting of the Anglican Consultative Council in Lusaka in April 2016. There will be no time for questions on this item. However, Members of General Synod are invited to write to the Clerk by close of business on Friday 1 July with any questions which they would like the Bishop of Chelmsford to speak to in his presentation.

Report by the Business Committee

26. There will be the usual debate on the Report from the Business Committee on the Agenda. This provides an opportunity for Synod members to raise points about the content and shape of the Agenda for this group of sessions, or about the Synod's business generally. Members may refer to a matter which is not in the Agenda at all but which, in their opinion, should be. However they should not get into the substance of the subject, but should confine themselves to its place in the Agenda or otherwise.

Approval of Appointments

27. Synod will be asked to approve the appointment of two members of the Archbishops' Council.

The Church Commissioners' Annual Report

28. The First Church Estates Commissioner, Sir Andreas Whittam Smith, will move that Synod do take note of the annual report of the Church Commissioners. The report reflects on the Commissioners' investment in the Church's growth and describes the various forms of statutory and discretionary support the Commissioners provide, featuring case studies which demonstrate how the funds have been deployed on the ground. The report also outlines the Commissioners' investment performance which enables them to provide these funds as well as making some additional, time-limited distributions (with Synod's encouragement) in support of the Renewal and Reform programme. It also comments on the Commissioners' policy in the area of responsible investment.

Nurturing and Discerning Senior Leaders: Report from the Development and Appointments Group of the House of Bishops

29. Synod members will recall that General Synod passed the following motion in July 2015.

“That this Synod do take note of the report of the Faith and Order Commission Senior Church Leadership: a resource for reflection and, in the light of widespread misunderstanding and concern about the new arrangements for discerning and nurturing senior leaders that have recently been introduced, following the report from the Lord Green Steering Group, invite: a) the House of Bishops to bring for scrutiny by Synod a report assessing the effectiveness of those arrangements and setting out what is intended from January 2017; and b) the Business Committee to schedule that report for debate not later than July 2016.”

30. The Bishop of Truro, Chair of the Development and Appointments Group, will present a report from the House of Bishops to Synod for a “take note” debate.

Questions

31. In accordance with the requirements of the Standing Orders, any member wishing to ask a question of any of the bodies or officers specified in Standing Order 112 must

give notice of it to the Clerk to the Synod by **12 noon on Tuesday 28 June 2016**. Questions sent by email should be addressed to questions@churchofengland.org.

32. Written answers to Questions will be available in the Questions Paper which will be emailed to Synod members at least **one clear day** before Question Time. Synod members will be able to ask supplementary questions at Question Time.

Saturday 9 July

Legislative Business

33. The morning will begin with Legislative Business. The nature and content of this business is summarised above. Any uncompleted Legislative Business from the morning will continue after lunch on Saturday.
34. The draft **Mission and Pastoral etc. (Amendment) Measure** will return to the Synod for the Revision Stage following its consideration by a Revision Committee. The Measure gives effect to the proposals recommended by the Simplification Task Group in its report GS 1980 which require primary legislation.
35. The draft **Legislative Reform Measure** is for First Consideration by the Synod. The Measure has been introduced following the motion which was passed by the Synod at the February group of sessions inviting the Archbishops' Council to initiate the legislative process to bring an 'Enabling Measure' to the General Synod for first consideration this July. The proposals which form the basis of the Measure were set out in *A New Enabling Measure* (GS 2018) in January 2016 which itself followed a consultation on proposals contained in GS Misc 1103. The Measure will facilitate removing or reducing burdens resulting from ecclesiastical legislation by making it possible, in certain cases, to amend or repeal some Acts of Parliament and Church Measures by way of orders approved by the General Synod.
36. The draft **Inspection of Churches Measure** has been introduced at the request of the Church Buildings Council. It replaces the regime for the inspection of churches provided for in the Inspection of Churches Measure 1955 with a new legislative framework. The draft Measure requires the Archbishops' Council to make regulations for the inspection of churches and the making of reports. It also requires the Church Buildings Council to issue guidance. The intention is to ensure that the inspection regime meets current needs, including by making it easier to make changes as the need for them is identified, without having to amend primary legislation.
37. Draft **Amending Canon No. 36** gives effect to two private members' motions which were passed by the Synod during the last quinquennium. It amends Canon B 8 (Of the vesture of ordained and authorized ministers during the time of divine service) in the manner sought by the Reverend Christopher Hobbs's private member's motion; namely to make the forms of vesture currently prescribed by the Canon optional rather than mandatory. A consultation of Synod members (GS Misc 1133) was carried out on this proposal from the end of January 2016 until 15 April. The majority of responses were in favour of proceeding. The Amending Canon also amends Canon B

38 (Of the burial of the dead) in the manner sought by Canon Mike Parsons' private member's motion; namely to allow those who have taken their own life, whatever the circumstances, to be buried in accordance with the normal burial service. It makes equivalent provision in relation to those who die unbaptized.

38. The draft **Statute Law (Repeals) Measure** repeals a large number of provisions contained in ecclesiastical statutes (Acts of Parliament and Measures) which are spent, obsolete, unnecessary or otherwise not now of practical utility. The proposed repeals were consulted on (in GS Misc 1128) between November 2015 and January 2016. The original list of enactments proposed for repeal has been modified in the light of responses to the consultation.
39. The draft **Pensions (Pre-consolidation) Measure** makes pre-consolidation amendments to the existing Church legislation concerning pensions. The purpose of these amendments is to make some minor changes to the existing legislation so that all of the Church legislation concerning pensions can then be consolidated.
40. As the Statute Law (Repeals) Measure and the Pensions (Pre-consolidation) Measure are unlikely to raise questions of policy or otherwise to be controversial, the Business Committee has determined that they do not need to be debated. This is subject to the usual proviso that they will nevertheless be debated if 25 members request that they should be. If the Synod is deemed to have given First Consideration to these Measures, or if they are debated and the Synod passes the motion on First Consideration, they will be considered by a Revision Committee and members may submit proposals for amendment to the Clerk by not later than Friday 12th August.
41. The draft **Ecclesiastical Jurisdiction and Care of Churches Measure** consolidates the statute law relating to the ecclesiastical courts and the care of church buildings. As a consolidation Measure it will be deemed to have received First Consideration without debate unless at least 5 members give notice not later than 5.30 pm on Friday 8th July that they wish it to be debated. It will not be committed to a Revision Committee unless the Synod expressly passes a motion to that effect.
42. **The Clergy Discipline (Amendment) Rules 2016** make amendments to the Clergy Discipline Rules 2005 principally to take account of amendments that were made to the Clergy Discipline Measure 2003 by the Safeguarding and Clergy Discipline Measure 2016.
43. **The Suspension Appeals (Churchwardens etc.) Rules 2016** set out the procedure for appeals against the suspension of churchwardens, PCC members and others. The relevant powers of suspension are concerned with addressing safeguarding issues and were conferred by amendments contained in the Safeguarding and Clergy Discipline Measure 2016.
44. **The Amending Code of Practice under the Clergy Discipline Measure 2003** amends the existing Code of Practice under that Measure, mainly to take account of the changes brought about by the Safeguarding and Clergy Discipline Measure 2016 and the Clergy Discipline (Amendment) Rules 2016.

45. **The Legal Officers (Annual Fees) Order 2016** provides for the annual retainers to be paid to diocesan and provincial registrars. **The Ecclesiastical Judges, Legal Officers and Others (Fees) Order 2016** prescribes the fees that are payable in respect of proceedings in ecclesiastical courts and tribunals and makes provision for related matters.
46. As the two sets of Rules, the amendments to the Code of Practice and the Fees Orders are unlikely to raise questions of policy or otherwise to be controversial, the Business Committee has determined that they do not need to be debated. This is subject to the usual proviso that any of these instruments will nevertheless be debated if a member requests that it should be by not later than 5.30 pm on Friday 8th July, or (in the case of those in respect of which amendments are permissible) if a member gives notice of an amendment by not later than 5.30 pm on Tuesday 5th July.
47. Special Agenda I contains detailed procedural notes in respect of each item of legislation.

Renewal and Reform

48. Legislative business will be followed by a debate on the vision and narrative for Renewal and Reform set out in GS 2038. The motion will be moved by a member of the Archbishops' Council.

'Take Note' Debate on 'A Church of England Vision for Education'

49. There will then be a 'take note' debate on a report from the Education Office on 'A Church of England Vision for Education'. The Education Office is developing a Foundation for Educational Leadership to grow and enhance the capacity of the Church's education network to promote a deeply Christian vision for education for the common good. The Foundation is underpinned by a theological vision for education. Synod is asked to take note of this vision for education and the progress being made in establishing the Foundation, within the context of recent legislation and the White Paper Educational Excellence Everywhere.

Archbishops' Council's Annual Report and Budget 2017

50. The Synod will be invited to approve the Archbishops' Council's expenditure budget for 2017 and the Council's proposals for apportionment amongst the dioceses, and the usual pooling adjustment in respect of additional maintenance grants to ordinands.
51. There are some presentational changes from earlier years. Firstly the focus of the items the Synod is invited to vote on is the total expenditure under each area of the Council's activity that is substantially funded by the diocesan apportionment rather than the expenditure net of external income. Secondly, looking to respond to Synod members' comments that the five vote system was confusing and to simplify presentation the Council has agreed to present its budget under three headings: Training for Ministry, Clergy Retirement Housing grant and "the work of the Council generally" (the latter following the language in Standing Orders). However, for the time being, the Synod will be invited to vote separately on National Church Responsibilities, Grants and Mission Agency pension contributions. Members' views on whether the budget motions should be simplified in future years by combining expenditure in these three areas into one vote

would be welcomed.

52. Proposed expenditure in 2017 is £37.7 million, £3.3 million (9.4%) above the equivalent 2016 level. The overall apportionment increase is lower at 3.5% due to funding attracted from external sources and greater use of the Council's restricted funds.
53. The increase in expenditure is driven by the following main factors:
- Increased investment in encouraging vocations, funding for an assumed 10% increase in the number of new ordinands from autumn 2017 and an inflationary increase in the costs of ordination training (£0.7m)
 - The inclusion of grants made from Ministry Division restricted funds including for the growing context based parish support scheme (£0.7m)
 - Additional provision for safeguarding compared with the level in the 2016 budget (£0.8m)
 - The pilot digital evangelism project (£0.7m)
 - An increase of 5% for the clergy retirement housing grant, the level of increase that has been agreed until 2020 (£0.2m)
 - Additional resource for the extension and expansion of the occasional offices project (£0.1 m)

Prorogation

54. Synod will be prorogued on Saturday evening. Following the Minster service on Sunday 11 July, the Shared Conversations will begin at 2.30pm.

III: Other Work of the Business Committee

Security, Fringe meetings and Displays

56. The Business Committee revised the Policy on Fringe Meetings and Displays in April 2016. Synod members' attention is drawn to point 5. of the Policy which states as follows:

“By allowing a particular fringe event or display, the Business Committee is not to be viewed as showing support for the organisation arranging it, or for any views expressed or presented at or through the fringe event or display. These are entirely the responsibility of the organisers.”

57. Synod members are reminded of their responsibility to be vigilant at all times to ensure the security of Synod members, visitors and staff. As stated in point 5 of the security policy, Synod members are requested not to leave any items unattended around the Central Hall or its environs.

Pattern of General Synod meetings

58. The Committee launched a consultation on the “Pattern and Dates of Synod meetings” in Annex 2 of GS 2013. The consultation exercise closed on Friday 4 March. Following responses received, the Business Committee is now considering trialling scheduling a London group of sessions to include a Saturday in February 2018.
