## FIFTIETH REPORT OF THE STANDING ORDERS COMMITTEE (GS 1984)

*Mr Geoffrey Tattersall QC (Manchester)* to move in respect of items 19 to 77 'That this amendment be made with effect from 13th February 2015.':

## Standing Order 10 (length of notice for amendments to legislative business etc.)

- 19 In Standing Order 10, in paragraph (c), for "one clear day" *substitute* "three clear days".
- 20 In Standing Order 10, in paragraph (c), *omit* the words from "or if no such day" to the end.
- 21 In Standing Order 10, in paragraph (d), *omit* the words from "or if no such day" to the end.

#### Standing Order 16 (right to speak)

22 In Standing Order 16, in paragraph (a), for "to indicate" substitute "or (if unable to do so) indicate by some other means".

#### **Standing Order 24 (reconsideration)**

23 In Standing Order 24, in paragraph (a)(i), for "substantially similar form" *substitute* "form which is substantially to the same effect".

## Standing Order 25 (amendments: when permitted / not permitted)

24 In Standing Order 25, in paragraph (a), after "which has been duly moved", *insert* "(including to a motion which was also

included in the agenda of an earlier group of sessions but which was adjourned or not considered, or to an amendment of which notice was given at an earlier group of sessions but which was not reached)".

## Standing Order 26 (amendments: delivery)

In Standing Order 26, in paragraph (a), for "in writing and signed by the mover" *substitute* ", either in writing signed by the mover or by facsimile or e-mail sent from an address previously notified by the mover to the Clerk to the Synod,".

### Standing Order 37 (procedure on voting)

"(ea) All Schedules and the Preamble and Title of the Measure shall be in like manner considered, but the consideration of the Preamble and of the Title shall be postponed until all the Clauses and Schedules have been disposed of, and the Title shall be considered after the Preamble."

- 45 In Standing Order 59, in paragraph (g)(ii), after "an amendment" *insert* "(other than a Drafting Amendment)".
- 46 In Standing Order 59, in paragraph (g)(ii), for the words from "because the Measure" to the end *substitute* "and which does not reopen an issue which has been decided by the Synod or any Revision Committee in relation to the Measure".

## Standing Order 61 (Final Approval Stage)

47 In Standing Order 61, in paragraph (d), for "it shall not be considered again on the First Consideration Stage in the same form" *substitute* ", a Measure containing provisions which in the opinion of the Presidents, the Prolocutors and the Chairman and the Vice-Chairman of the House of Laity are to the same or substantially the same effect shall not be considered again on the First Consideration Stage".

59 In Standing Order 79, in paragraph (e), after "stand in their places" *insert* "or (if unable to do so) indicate by some other means that they wish the debate to continue".

### Standing Order 79B (minor adjustments to forms of service)

### **"ARCHBISHOPS' COUNCIL**

#### **119.** Membership of Committees

No member of the Synod shall, except with the consent of the Business Committee—

- (i) serve concurrently on more than one committee of the Archbishops' Council to which members of the Synod are elected or appointed, or
- (ii) stand for election to more than one committee of the Archbishops' Council to which members of the Synod are elected."

## Standing Order 128 (representation of the Synod on other bodies)

75 In Standing Order 128, in paragraph (a), for "not being a body referred to in SO 119(a)" *substitute* "other than a committee of the Archbishops' Council".

## Standing Order 129 (press and public: admission, right to address Synod, etc.)

76 In Standing Order 129, in paragraph (b), after "Subject to SOs 97," *insert* "108,".

#### Standing Order 130 (procedural defects)

77 In Standing Order 130, in paragraph (a), *omit* "or a meeting of any body referred to in SO 119(a),".
