## Church Buildings

*From recent circulars from the Church Buildings Council*

### **[Tailored review of the Heritage Lottery Fund and National Heritage Memorial Fund](#)**

The Tailored Review of the NHMF and HLF is now published on the [government website](#). In the New Year the HLF will be consulting widely on its next strategic framework and I shall let you know when this consultation is launched.

Reading the Tailored Review in advance of this will help raise thoughts that will assist you when the consultation on the strategic framework is launched.

December 2017 will see the announcement first round of church grants of over £100,000 since the closure of GPOW. During 2018 we will be asking about the impact of the changes in HLF funding for churches. This is a reminder to look out for any impacts in your diocese and note what you see.

With immediate effect grants for Parks, Townscapes and Landscape Partnerships will need to apply to the main grant programmes.

- There will be no Heritage Grants over £5m in 2019. Applications which have already been submitted for major grants will be considered in April 2018 as usual, but no new applications in 2018.
- There will be no new awards of grants of over £100k from January to March 2019. Round two applications will be accepted as normal.
- Other funding streams – such as Young Roots and First World War Then and Now - continue, but some will draw to a close in 2018.

These changes reflect that the HLF has a far lower budget for the financial year 2018/19. As ever, please [contact your regional team](#) with specific questions about applications.

The **Home Officer** has published its [review of the Scrap Metal Dealers' Act 2013](#). The review has confirmed that the legislation will remain in place and shows that the headline figures across all types of metal theft are good.

It acknowledges the particular impact on churches and that there are ongoing problems here. I have already responded to the offer of engagement with the church that is in the report. You may hear more.

### **Launch of [new small grants programme](#) for church repair**

The Churches Conservation Foundation has opened its new small grants programme. Grants of **£250 - £2,000** are available for conservation work to the fabric and contents of historic listed churches, which would not normally be undertaken in the regular cycle of repair and maintenance. Examples include work to listed headstones and monuments, wall paintings, rood screens, fonts, carved stonework, stained glass and altar cloths. [More information here](#).
