(c) Should such notice as is mentioned in paragraph (a)(ii) have been received, when the item on the agenda is reached the Chairman shall call upon a member of the Steering Committee to move *‘That the Measure entitled (Short Title) be considered’* and paragraphs (b) and (c) of Standing Order 51 shall apply in relation to that motion as they apply to the motion set out in paragraph (a) of Standing Order 51.

(d) If paragraph (c) applies and the motion set out in that paragraph is carried, a member of the Steering Committee may, if he thinks fit, immediately move *‘That the Measure be committed to the Steering Committee in respect of its final drafting’* in which case the Chairman may allow such debate upon that motion as he thinks fit before putting the question on that motion.
