# SCHEME AMENDING THE DIOCESE IN EUROPE CONSTITUTION 1995 (GS 1912)

# Scheme for approval

- The Bishop of Gibraltar in Europe has laid the Scheme before the General Synod in accordance with paragraph 48(a) of the Constitution of the Diocese in Europe 1995.
- 2. Under paragraph 48(b) of the Constitution if a member of the General Synod gives notice of a desire that the Scheme be debated the Scheme will not come into operation unless it is approved by the General Synod.
- 3. Any member who wishes the Scheme to be debated must give notice in writing to the Clerk to the Synod **not later than 5.30 p.m. on Friday 5th July 2013**.
- 4. Amendments to the Scheme are not permissible.

### PUBLIC DOCTRINE OF CHRISTIAN MARRIAGE

Mrs Andrea Minichiello Williams (Chichester) to move:

'That this Synod affirm the public doctrine of Christian marriage, between a man and a woman, as set out in the Book of Common Prayer, as the only basis for engagement with public policy on marriage and family life.'

### REGISTRATION OF CIVIL PARTNERSHIPS

Mr John Ward (London) to move:

'That this Synod:

- (a) give its general consent, pursuant to regulation 2D of the Marriages and Civil Partnerships (Approved Premises) Regulations 2005, to any application made in respect of a church or chapel of the Church of England for approval as a place at which two people may register as civil partners of each other; and
- (b) require the Clerk to the Synod forthwith to publish evidence of this consent in writing.'

THE MODEL OF PERMANENCE TO WHICH MARRIAGE ASPIRES

Mr Tom Sutcliffe (Southwark) to move:

'That this Synod believe that the aspiration to permanence, counting on grace, in a relationship of love is the defining mark of Christian marriage, and that an analogous aspiration to permanent relationships among people not constituted by nature for heterosexual marriage is equally dependent on grace (and the support of Christians), if such relationships are to conform to the model of true marriage that Jesus specifically taught.'

#### **CANON B 8**

The Revd Christopher Hobbs (London) to move:

'That this Synod call on the Business Committee to introduce draft legislation to amend the law relating to the vesture of ministers so that, without altering the principles set out in paragraphs 1 and 2 of Canon B 8, the wearing of the forms of vesture referred to in paragraphs 3, 4 and 5 of that Canon becomes optional rather than mandatory.'

#### **BURIALS IN CLOSED CHURCHYARDS**

The Revd Andrew Dotchin (St Edmundsbury and Ipswich) to move:

'That this Synod call on the Archbishops' Council to:

- (a) consider the position in relation to further burials in churchyards which have been closed by Order in Council; and
- (b) make representations to Her Majesty's Government on the matter with a view to primary legislation being brought forward (whether by way of Measure or Act of Parliament) to facilitate such burials in appropriate cases.'

### **GENERAL SYNOD HOUSE OF LAITY**

*Mr Philip French (Rochester)* to move:

'That this Synod call for the Church Representation Rules to be amended, in time for the 2015 General Synod elections, to provide that:

(a) the diocesan electors for the House of Laity of the General Synod become all those lay persons entered on the church electoral rolls of parishes in the relevant diocese;

- (b) election addresses be provided online in a standard form, to include clear disclosure of candidates' positions on such matters as the House of Laity may by resolution direct; and
- (c) nomination and voting be conducted electronically.'

### **BISHOPS IN CIVIL PARTNERSHIPS**

The Revd Dr Robert Munro (Chester) to move:

'That this Synod call on the House of Bishops to re-instate the moratorium on the consecration as bishops of clergy in civil partnerships and, having done so, to seek the approval of the General Synod before it is lifted again.'

### **UNSAFE FOOD AND POST-2015 SUSTAINABLE DEVELOPMENT GOALS**

The Revd Canon Richard Hibbert (St Albans) to move:

'That this Synod:

- (a) note the serious public health implications of chronic aflatoxin exposure, which affects an estimated 4.5 billion people living in developing countries, is responsible for over a quarter of the world's liver cancer and contributes to childhood stunting and immunosuppressive disorders;
- (b) acknowledge the economic impact of aflatoxin contamination on smallholder farmers in developing countries, both in terms of long-term health problems and export losses due to unsafe levels of the toxin; and
- (c) call on Her Majesty's Government to ensure the issue is addressed in the post-2015 Sustainable Development Goals through funding for household, private sector and national crop drying, storage and primary processing to improve food safety and food security.'
