In section 1 (interpretation), omit the definition of "Custodian trustee". In section 2 (property to which the Measure applies), in subsection (2), for paragraph (e) substitute -15 being a short lease (within the meaning of section 6 of the Parochial Church Councils (Powers) Measure 1956);" In section 3 (vesting of property in diocesan authority), in subsection (2), omit "as custodian trustee". (5) In that section, after subsection (5) insert – 20 "(5A) Where any interest is vested in the diocesan authority under this section, the authority shall be indemnified in respect of – all liabilities subject to which the interest is vested or which may at any time affect the property; all rates, taxes, insurance premiums and other outgoings of 25 whatever nature which may from time to time be payable in respect of the interest; all costs, charges and expenses incurred by the authority in relation to the acquisition or insurance of the interest or as trustee of the interest; and 30 all costs, proceedings, claims and demands in respect of any of the matters mentioned in paragraphs (a) to (c) of this subsection." In section 5 (disposal of property vested in diocesan authority) – for "whereof the diocesan authority is the custodian trustee" 35 substitute "vested in the diocesan authority", for "charge or take any legal proceedings in relation thereto" substitute "or charge the property", and omit "or, in the case of legal proceedings, of the agent of the diocesan authority authorised in that behalf". 40 After that section insert – "5A Consent not required if consideration below specified amount

(1)	This Measure may be cited as the Church of England (Ecclesiastical Property) Measure 20		
(2)	the of Archb	ection comes into force on the day on which this Measure is passed and ther provisions of this Measure comes into force on such day as the pishops of Canterbury and York may by order jointly appoint; and ent days may be appointed for different provisions or for different poses.	4

This Measure extends to the whole of the provinces of Canterbury and York, except the Channel Islands and the Isle of Man, except that, if an Act of Tynwald or an instrument made under an Act of Tynwald so provides, this

- Measure extends to the Isle of Man subject to such exceptions, adaptations or modifications as are specified in the Act of Tynwald or instrument.
- (4) The power to make an order under subsection (2) is exercisable by statutory instrument and the Statutory Instruments Act 1946 applies to any such order as if it had been made by a Minister of the Crown and as if this Measure were an Act.
