A DRAFT OF A MEASURE to extend until 31 December 2025 the period within which the Church Commissioners may make capital payments towards the cost of lump sums and pensions due to be paid or payable under certain pension and superannuation schemes; and for connected purposes.

1 Extension of period of capital payments

In section 7(2) of the Pensions Measure 1997, for "2018" substitute "2025".

2 Citation, extent and commencement

- (1) This Measure may be cited as the Church of England (Pensions) (Amendment) Measure 20-.
- (2) This Measure may be cited with the Church of England (Pensions) Measures 1961 to 2009 as the Church of England (Pensions) Measures 1961 to 20-; and in consequence of that—
 - (a) in section 14(1) of the Incumbents (Vacation of Benefices) Measure 1977, for "1988" substitute "20-", and
 - (b) in section 5(1) of the Diocese in Europe Measure 1980, for "2009" substitute "20-"
- (3) This Measure extends to the whole of the Provinces of Canterbury and York.
- (4) This Measure comes into force on the day on which it is passed.
