All those provisions of the Clergy Discipline (Amendment) Measure 2013 which were not previously in force had come into force on 1st February 2014.

The Clergy Discipline (Amendment) Rules 2013 had been laid before Parliament and had come into force on 1st February 2014.

The Clergy Discipline Appeal (Amendment) Rules 2013 had been laid before Parliament and had come into force on 1st February 2014, save that Rules 2 to 9 and 17 to 19 had no effect in relation to any complaint made before that date.

The Ecclesiastical Judges, Legal Officers and Others (Fees) Order 2013, the Legal Officers (Annual Fees) Order 2013 and the Faculty Jurisdiction Rules 2013 had been laid before Parliament and had come into force on 1st January 2014.
