Items are listed in alphabetical, not chronological, order, and words such as 'A', 'An' and 'The' are ignored in the alphabetical order. The classification used is listed on pages 6-8.

There is also a complete list, in three parts, of General Synod papers issued during the five years, and detailed subject index to the main classified listing.
