5. Nominations Committee of the Ethical Investment Advisory Group – APPC(18)30

A newly constituted EIAG Nominations Committee is being set up for the purposes of making appointments to the EIAG itself. Its principal task is to select an independent or episcopal Chair and non-National Investing Bodies representatives by open competition. [It will also need to ensure that one member of the EIAG is a member of the General Synod; and that at least one member is a bishop.] Relevant skills and experience include but are not limited to the fields of investment, finance, business, theology, ethics, missional activity and public policy. The Appointments Committee has been invited to appoint one member to the Committee, in addition to appointments made by the National Investing Bodies, the Archbishops' Council, the Archbishops, the MPA Council, and the Church Investors Group. 6. Faith and Order Commission – APPC(18)XX

Two casual vacancies have arisen among the non-episcopal membership of FAOC (FAOC has up to six episcopal members and up to ten non-episcopal members). Ideally the person appointed would already work and/or advocate on issues related to social protection systems and public services.
