Schedule – Repeals

A DRAFT OF A MEASURE

To make provision for the consecration of women bishops and to repeal Part II of the Priests (Ordination of Women) Measure 1993.

1 Provision for consecration of women bishops

- (1) It shall be lawful for the General Synod to make provision by Canon for enabling a woman to be consecrated to the office of bishop if she otherwise satisfies the requirements of Canon Law as to the persons who may be consecrated as bishops.

2 Repeals

- (1) Part II of the Priests (Ordination of Women) Measure 1993 (1993 No.1) is repealed.
- (2) The enactments mentioned in the Schedule are repealed to the extent specified in the second column of the Schedule.

3 Citation, commencement and extent

- (1) This Measure may be cited as the Bishops and Priests (Consecration of Women) Measure 20.....
- (2) This Measure shall come into force on such day as the Archbishops of Canterbury and York may jointly appoint and different days may be appointed for different provisions.
- (3) This Measure shall extend to the whole of the provinces of Canterbury and York.
