TAKE NOTICE that the Chapter of the Cathedral Church of Holy and Undivided Trinity, Ely applied on 23rd August 2019 for approval of the following proposal

<u>Summary of the proposals</u>

On 9th April 2019 Ely Cathedral applied for permission to re-order St. Catherine's Chapel to include the removal of the existing altar, dais and step.

The proposals are to carefully dismantle and remove the existing marble and alabaster altar, and put aside for future re-use by others as appropriate. This is to be followed by the lifting and removal of the white marble slabs and tiles of the altar platform, the white marble tiles and Purbeck Marble steps of the dais beyond and the rubble infill of all of these. Lifting of one of the Purbeck Marble treads of the dais step has revealed that the infill beneath is of rubble, and that the Minton tiles of the existing floor surface to the west continue beneath. Once the original scheme (with the lower Minton-tiled dais and platform) is revealed, full recording is to be undertaken, and any necessary cleaning, consolidation and repair work carried out. This will include conservation of the decorative inlaid Portland stone borders. Further to these works, new portable furnishings for the Chapel are proposed, plus hangings.

At a meeting of the Cathedrals Fabric Commission held on 30th May 2019 the above proposal was deferred pending receipt of the following additional information:

- 1. Further analysis of the significance of the altar in the context of Thicknesse's work and as an example of its type and period;
- 2. An exploration of alternative options for the storage or disposal of the altar; and
- 3. A method statement for how the altar would be dismantled and moved.

Decision

At a meeting of the Cathedrals Fabric Commission on **19th September 2019** the above proposals and representation were considered and the Commission decided to **approve** the application subject to the following conditions:

- 1. That the final design for the new liturgical furniture in St Catherine's Chapel be approved by the FAC.
- 2. That further details on the conservation of Scott's floor are sent to the CFCE's Head of Conservation for comment and the FAC for approval.
- 3. That a buyer or loan recipient of the altar shall first be sought, and that this shall be subject to the approval of the FAC.

- 4. That the destruction of the altar (in default of a new home being found for it elsewhere) shall require a further application to the FAC.
- 5. That the altar shall remain in situ until a new home for it is found or until further approval for its destruction is given.
- 6. That a method statement for moving the altar be approved by the FAC in advance of it being dismantled for relocation or disposal.

<u>Summary of the proposals</u>

On 9th April 2019 Ely Cathedral applied for permission to relocate the font from the northern end of the South-West Transept to the southern end, adjacent to St. Catherine's Chapel, and associated works.

The font is to be carefully lifted and moved to the southern side of the Transept. The font with its integral base (but without the current stone steps) it is to be set upon a new foundation in line with the entrance to St. Catherine's Chapel. Once moved, the former foundation and footprint is to be made good with floor stones to match the existing, to in-fill the floor pattern in this area. In advance of repositioning, floor stones beneath the new footprint are to be lifted, and the subfloor strengthened and consolidated. The condition of the font is also to be recorded and the stonework to be cleaned, consolidated and conserved. The proposals also include the installation of two new ramps; one positioned at the north-west corner of the transept giving access to the west tower floor area, the other at the north-east corner giving access to the south nave aisle. Please see attached documents for full details of the proposal.

These works are pertinent to the re-ordering of St. Catherine's Chapel, proposals for which are detailed in a separate application to the CFCE.

At a meeting of the Cathedrals Fabric Commission held on 30th May 2019 the above proposal was deferred pending receipt of the following additional information:

1. Analysis of the significance of the steps surrounding the font and the impact of their removal.

 - 1. That the font shall not be moved to its new location whilst the creation of a new entrance via the south-west transept remains under consideration, or until further submissions have been made to satisfy the Commission as to the acceptability of the impact of the creation of such an entrance upon the font's use, condition and setting in its new location.
- To **delegate** the final design and details of the new permanent ramps in the South West transept and choir aisles to the FAC.
