**SEE OF CANTERBURY CROWN NOMINATIONS
COMMISSION (GS 2260)**

Note:

The Revd Che Seabourne (Leeds) has indicated that he no longer wishes to move the amendments in his name on the Eleventh Notice Paper.

Dr Jamie Harrison (Durham) to move in respect of each of the following propositions:

‘That this Synod request that the necessary amendments be moved to the Standing Orders to ...’

- 8** *‘reduce from six to three the number of members elected by the Diocese of Canterbury to the CNC for consideration of a vacancy in the see of Canterbury’*

The Revd Andrew Atherstone (Oxford) to move as an amendment:

- 62** *‘After “see of Canterbury” insert “, the number removed to be replaced by an equivalent number of members from the wider Church of England, in accordance with a scheme to be proposed to General Synod by the Archbishops’ Council”.’*

- 9** *‘increase from one to five the number of representatives of other churches of the Anglican Communion who are members of the CNC for consideration of a vacancy in the see of Canterbury.’*

The Revd Mae Christie (Southwark) to move as an amendment:

- 63** ‘*Leave out* “increase from one to five” and *insert* “adjust” and at the end *insert* “in accordance with a scheme to be proposed to General Synod by the Archbishops’ Council following a comprehensive review with our Anglican Communion partners of the current role of the Archbishop of Canterbury within the Anglican Communion, and the likely direction of the relationships with the Communion over the next 30 years”.’

If Item 63 is not carried

The Revd Canon Simon Butler (Southwark) to move as an amendment:

- 64** ‘*Leave out* “five” and *insert* “three”.’
- 10** ‘provide that one such representative is to be chosen by the Joint Standing Committee of the Primates Meeting of the Anglican Communion and the Anglican Consultative Council from each of the five regions of the Anglican Communion (the Europe region to include the provinces of the British Isles other than England).’

The Revd Canon Simon Butler (Southwark) to move as an amendment:

- 65** ‘*Leave out* “one such representative is”, and *insert* “such representatives are” and *leave out* “from each of the five regions” and *insert* “from different regions”.’
- 11** ‘provide that of those so chosen, at least one must be a primate, one a deacon or priest and one a lay person who is an actual communicant.’

Mr Nic Tall (Bath & Wells) to move as an amendment:

- 66** ‘At the end *insert* “and that at least half rounded down shall be male and at least half rounded down shall be female”.’

The Reverend Canon Andrew Cornes (Chichester) to move as an amendment:

- 67** 'At the end *insert* "and that a majority of them must be of Global Majority Heritage".'
- 12** 'provide for vacancies in the see of Dover to be considered by the CNC as if it were a diocesan see.'

c) welcome the focused investment to support previously agreed commitments to a 2030 net zero carbon target and to address racial justice.'
