



- review commissioned October 2020 Archbishop's Council
- July 2021 GS2222
- February 2022 GS1312
- February 2023 draft proposals to Synod for debate
- July 2023 draft legislation (if approved)
- synodical process 2023-2024






- protection of heritage assets

#### Mission & Pastoral Measure 2011 (MPM)

- administrative geography changes pastoral reorganisation
- close a church for regular public worship
- dispose of a church for an alternative use
- establish new mission initiatives

Church Commissioners – regulatory/appellate role
Mission, Pastoral and Church Property Committee
right of appeal to the Judicial Committee of the Privy Council



# legal history

- roots in the 19<sup>th</sup> century
- post war heritage policy development
- 1968 Pastoral Measure
- Toyne review 2004
- amended 2011, consolidated 2018



## purpose of the review

- legal modernisation and simplification agenda
- alignment with Emerging church agenda post-Covid challenges
- updating for net zero and social housing policy agendas
- more inclusive and accessible consultation processes
- risk mitigation




## modernisation and simplification

- a new Measure
- split between primary and secondary legislation
- governance changes duty of pastoral care, alignment with governance review
- requirements on training and monitoring and evaluation



## modernisation and simplification cont...

- streamlining legal instruments 8 to 4
- consultation mission & church building policies
- deemed consent
- temporary and trial changes
- staff delegation framework for faster decision making
- provisions for when there is no PCC
- patronage recommendations
- replace concept of 'sequestration' with a more modern approach



# church buildings

#### aims

- move away from closure more about options and transition
- earlier/easier conversations about options/early use seeking
- help communities have more say about the future of their buildings
- greater scope to retain the buildings in CoE ownership – extend leasing options
- grow the trust system for preservation uses



# church buildings cont....

- extend worship/community use leasing options e.g. full worship use
- amend provisions around the Churches Conservation Trust
- give dioceses powers to create "mini-CCTs" temp/permanent vesting
- easier disposal to trusts for preservation purposes
- ability for non-PCC groups to manage fabric
