Conservation of the North Transept, North Elevation Exterior Clock Face

Summary of the nature of work and its extent (and materials) [or in the case of an object, a short description of it and details of the proposal]

The north elevation of the North Transept of Wells Cathedral is one of the most prominent external facades of the building. It is part of a unique exterior whose profile and significance see it recognised as one of the most magnificent and important of English cathedrals. Within this, the external clock is a focal point of major historical significance. To the upper tier, the clock is flanked by two timber strikers depicting armed knights, standing on protruding pedestals beneath a fan-vaulted canopy, which strike two bells on the quarter hour. The dial is worked by the same mechanism as the Cathedral's interior clock, the original considered to be the second oldest clock mechanism in Great Britain. The clock face, carved in a local oolitic limestone, has undergone many phases of redecoration and repair over the centuries. The painted and gilded applied decoration survives in a multitude of schemes and layers as a valuable and unique aspect of the clock's history.

The condition of the exterior clock, dating from c.1475, was noted to be a high priority issue in the most recent 2018 Quinquennial Inspection, as continuing deterioration is causing on-going loss of the decorative form and finishes, with increasing risk of irreparable decay and loss. Following the QI report, a detailed condition assessment and polychromy analysis of the clock was undertaken in 2019 to establish a programme of conservation and consolidation works.

The proposed strategy for conservation of the exterior clock involves a process of consolidation with the aim of conserving all current material, as well as subsequent repairs or decorative schemes where they are not causing damage, beneath new exterior coatings. This conservation and preservation of as much as possible of the painted layers allows for a recreation of a more original scheme than the current mid-20th Century interpretation. The conservation process ensures all surviving paint schemes remain, while returning the clock to a more original design and addressing the vulnerability of the clock in its present condition.
