### **LAND AND NATURE (GS 2319)**

*The Bishop of Norwich to move:*

‘That this Synod, recognising the need to respond urgently to the ecological crisis, in line with the global scientific consensus that the climate change and biodiversity loss crises are intricately linked

- (a) welcome the work being done by the Church Commissioners, the NCIs, and many dioceses, parishes, cathedrals, and schools to manage all or part of their land for climate and nature, in urban and rural communities alike.
- (b) request Diocesan Secretaries to task a named person / committee in their dioceses to create an action plan to achieve the ‘Land’ section of Eco Diocese at Silver level by 2026 at the latest.
- (c) request Chairs and Secretaries of all diocesan property/finance committees to incorporate nature-positive objectives into their asset management policies within the next 6 months.
- (d) call on all parishes, cathedrals, TEIs, NCIs offices with land they manage or influence to:
  - i. create a simple land management plan, with reference to the guidance and examples from Caring for Gods Acre,
  - ii. work towards an increasing level of Eco Church, including the actions in the ‘Land’ section, and
  - iii. record the biodiversity of their green spaces, through taking part in Churches Count On Nature each year.

- (e) call on all Diocesan Boards of Education to work in accordance with the Department for Education Sustainability Strategy.

### **FUTURE OF WORK (GS 2320A AND GS 2320B)**

... to move on behalf of the Oxford Diocesan Synod:

‘That this Synod:

mindful of the deep economic effects of the pandemic, the impacts of new technology, and the global rise of new forms of working—

- (a) affirm the dignity and value of purposeful work as a significant component of human flourishing
- (b) endorse and commend the five principles used for evaluating fair and dignified platform work in the gig economy by Fair.work and
- (c) call for the Faith and Order Commission (FAOC) together with Mission and Public Affairs Committee to advise on what is essential to purposeful, dignified, and fair work in the context of the fourth industrial revolution now in progress.’

- (i) ensure that a sufficient budget is made available to support the work of the Youth Synod; and
- (j) ensure that the Youth Synod has representation on the Archbishops' Council by co-opting a member of the Youth Synod as a member of Archbishops' Council.'

- (d) urge all parts of the Church of England to seek to support, through prayer, advocacy and practical action, the poorest in the world who are suffering the most from the impacts of climate change, in the awareness that our nation has been among those who have benefited most from the emissions that have caused the crisis;
- (e) commit earnestly and regularly to pray - and to promote prayer - about the climate and wider environmental crisis.
- (f) call upon all institutions of the Church of England to make urgent practical preparations for the delivery of substantial reduction of the Church's carbon footprint, including, but not restricted to, the following immediate actions in respect of Church buildings:
  - i. ensuring that the NCIs are adequately resourced to provide DACs, Buildings Departments, Education Departments and others with authoritative national guidance notes, advice and training on key technical and procedural questions relating to adaptation of buildings for the net zero target; and
  - ii. ensuring that Parish Buying and other national-level entities have the capacity to engage with manufacturers and suppliers of products and processes recommended for making our buildings more efficient, with a view to using the scale of the national net zero project to achieve both sympathetic design and economies of scale on cost.
- (g) request that Bishops and the Liturgical Commission to encourage confirmation services to include an additional question 'Will you strive to safeguard the integrity of creation, and sustain and renew the life of the earth?'
- (h) ask that HM Government review the weight given to the environmental public benefit in planning regulations to facilitate the installation of renewable technologies, including for buildings that are listed or in conservation areas.'

### **DAY OF PRAYER AND ACTION FOR THE PERSECUTED CHURCH**

... to move on behalf of London Diocesan Synod:

‘That this Synod, in the light of the motion passed at the February 2022 Group of Sessions relating to the persecuted Church (i.e. item 18 on the Agenda, as amended), request the Archbishops’ Council to work ecumenically with other churches to establish a national day of prayer and action for the persecuted Church around the world.’

### **FOOD BANKS AND INADEQUACIES IN SOCIAL SECURITY**

... to move on behalf of Sheffield Diocesan Synod:

‘That this Synod, mindful that the fourth Mark of Mission of the Anglican Communion is to “transform unjust structures of society”,

- (a) note the major contribution to social welfare being made by the churches and others in the provision of food banks
- (b) note with concern that levels of dependence on food banks have been increasing and that inflation is making the situation even worse
- (c) believe that this dependence reflects serious inadequacies in the social security system
- (d) note that the Trussell Trust has said: ‘we stand on the edge of a precipice with a clear decision to make: either we accept food banks as a ‘new normal’ or we work to create a more dignified, compassionate and humane society where everyone has enough money for essentials’
- (e) welcome the Chancellor’s intervention to help the least well-off households with their energy bills but note this will not remove the problem of increased dependency on foodbanks
- (f) call on the House of Bishops to urgently engage with HM Government, in particular the Secretary of State, to press it to review the adequacy of current social security provision.’

### **REST PERIODS FOR OFFICE HOLDERS**

.... to move on behalf of Winchester Diocesan Synod

‘That this Synod request that the Archbishops’ Council lay before it for approval draft Regulations amending the Ecclesiastical Offices (Terms of Service) Regulations 2009 so that an office holder is entitled to not less than 36 hours (a day and a half) of rest in any period of seven days, to include an uninterrupted rest period of not less than 24 hours, but so that the statement of particulars of office may continue to specify that any rest period may not be taken on or include a Sunday or any or all of the principal Feasts of the Church of England or Ash Wednesday or Good Friday.’
