# CHANCEL REPAIR (CHURCH COMMISSIONERS' LIABILITY) MEASURE EXPLANATORY NOTES

The draft Chancel Repair (Church Commissioners' Liability) Measure provides for the liability of the Church Commissioners to repair the chancel of a church which currently takes the form of an interest in land or a contractual obligation to take the form of a statutory duty instead.

## **Background**

- 1. Chancel repair liability is an enforceable liability to repair, or to contribute to the cost of repairing, the chancel of a parish church (usually its eastern part).
- 2. In some cases, chancel repair liability is attached to the ownership of land. That could be because the land concerned had been glebe and had formed part of the endowment of a rectory or because the land now represents the right to tithes that had originally belonged to a rectory.
- 3. During the Middle Ages, monasteries acquired many rectories. After the dissolution of the monasteries in the 1530s, some of their property went to cathedrals, which inherited the liability to repair the chancel of the relevant parish church. Some former monastic property was used to endow the new bishoprics founded by Henry VIII, with each new bishop inheriting the chancel repair liability.
- 4. After its foundation in 1704, Queen Anne's Bounty inherited former rectorial property. In the nineteenth and twentieth centuries, the then Ecclesiastical Commissioners inherited all episcopal estates and a lot of cathedral property. In each case, chancel repair liability was also inherited.
- 5. In 1947, the Church Commissioners took over the property that had belonged to Queen Anne's Bounty or to the Ecclesiastical Commissioners as well as all chancel repair liability attached to that property. The land which the Commissioners took on carried liability for around 350 parish churches. In some cases, the Commissioners have the whole liability; in others, they share it. In 2022, they incurred net expenditure of around £608,000 on chancel repair.
- 6. The Commissioners also have power under section 25 of the Cathedrals Measure 1999 (being replaced by section 28(6) of the Cathedrals Measure 2021) to make grants to cathedral Chapters towards the cost of chancel repairs (covering about 200 parish churches). Grants currently stand at 100% of the cost and, in 2022, the Commissioners made net grants of around £97,000.

- 7. Chancel repair liability was classified in land law as an overriding interest, which is an interest to which a registered title is subject, even though it does not appear on the register of title. It binds the registered proprietor and anybody who acquires an interest in the title. Before the Land Registration Act 2002, chancel repair liability would pass to the purchaser when land was sold, whether or not the purchaser knew about it. But from 13<sup>th</sup> October 2013, at the end of the applicable transitional period under the 2002 Act, chancel repair liability passed (except in very limited circumstances) to the purchaser only if it had been registered against the title or (in the case of unregistered land) protected by a caution against first registration. In general, therefore, if the liability was not registered, a person buying the land without knowledge of the liability would obtain the land free from that liability.
- 8. If a parochial church council ("PCC") wished to retain the benefit of chancel repair liability, it had to (ideally before 13<sup>h</sup> October 2013) have the liability registered. In 2009, the Church Commissioners decided to relieve PCCs of this task in the case of land which the Commissioners owned and, where the land was registered, themselves took on the task of registering notice of the liability.
- 9. By 2016, though, it had become clear that the process of registering chancel repair liability was creating technical legal issues and adversely affecting the value of the land concerned. The process damaged the relationships between the public, PCCs and the Commissioners and led to Parliamentary Questions and unfavourable publicity. In 2015, following a campaign by the National Secular Society, Lord Avebury introduced a private peer's bill in the House of Lords to abolish chancel repair liability entirely (HL Bill 21 in the 2015-16 Session). The Bill made little progress, largely because of the compensation the Church of England required from the government to put chancels into repair.
- 10. The Commissioners abandoned the policy of registration and sought to have their chancel repair liability removed from the register. But that policy too proved unsatisfactory, with various legal and practical difficulties arising.
- 11. The Commissioners propose now that their chancel repair liability should be detached from land of theirs that is affected by it and instead become a free-standing statutory duty, whether or not the Commissioners continue to own the land. The Commissioners would then be able to sell their land free from chancel repair liability and its associated difficulties. The interest of PCCs would still be protected because the Commissioners would have a continuing statutory duty to repair the chancel of the relevant parish church.
- 12. In the Annex, Table 1 sets out each chancel for which the Commissioners have land-based liability to repair and the percentage used to represent their share of liability. Table 2 sets out each chancel for which the Chapter of a cathedral has liability to repair and the percentage used to represent its share liability; under the Measure the Commissioners will take on those liabilities.

## **Procedural stages**

- 13. Standing Order 48(1) provides for Measures and Canons to be considered by the General Synod on the following successive stages—
  - First Consideration (see SOs 51 and 52).
  - Revision Committee (see SOs 54 to 57)
  - Revision (see SOs 53 and 58 to 60)
  - Final Drafting (see SO 61)
  - Final Approval (see SO 64).
- 14. The draft Measure is being considered by the General Synod at the February 2024 group of sessions on the First Consideration Stage.
- 15. The next stage will be the Revision Committee Stage. Members who wish to send proposals for amendment for consideration by the Revision Committee must do so in writing to <a href="mailto:revisioncommittee@churchofengland.org">revisioncommittee@churchofengland.org</a> no later than 5.30 p.m. on 8<sup>th</sup> April 2024.
- 16. The Measure is expected to return to Synod for the Revision Stage in July 2024, with the Final Drafting and Final Approval Stages being taken in February 2025.

#### The Measure

- 17. This Measure would provide for the liability of the Church Commissioners to repair the chancel of a church which currently has effect as an interest in land or as a contractual obligation to have effect instead as a statutory duty. Land owned by the Commissioners would therefore be relieved of the burden of the liability and could be dealt with free from it and its blighting effect.
- 18. This Measure would not abolish chancel repair liability. Nor would it change the liability of third parties to pay contributions to chancel repair.
- 19.HM Land Registry has been consulted on the text of this Measure and is content.

## **Notes on Clauses**

## Clause 1 – Existing liabilities on title or under contract

- 20. Subsection (1) provides for the conversion to a statutory duty of the Church Commissioners' current chancel repair liability, whether it operates as an interest in land or as a contractual obligation (including under an indemnity).
- 21. Subsection (2) provides that the extent of the Commissioners' share of chancel repair liability in each case would crystallise immediately before the Measure comes into force.

- 22. Subsection (3) provides that the change made by this clause would supersede all previous deeds and agreements relating to the Commissioners' chancel repair liability. But a deed or agreement would cease to have effect only in so far as it relates to chancel repair liability; it would continue to have effect where it also, for example, grants or reserves rights or creates covenants.
- 23. Subsection (4) provides that notices and other entries at HM Land Registry relating to chancel repair liability would cease to have effect.
- 24. Subsection (5) provides for references in this clause to liability of the Commissioners to include liability of any of their subsidiaries. This clause will therefore apply where the Commissioners have an indirect liability through a subsidiary. The term "subsidiary" is defined by clause 5(4) to have the standard meaning given in the Companies Act 2006.

## Clause 2 – Existing statutory liabilities

- 25. Subsections (1) and (2) provide for the continuation of certain existing statutory liabilities of the Commissioners for chancel repairs. Each of the local Acts listed imposes chancel repair liability on the Commissioners; accordingly, in each of those cases, the liability is already statutory rather than land-based or contractual. Clause 1 would not therefore impact on those cases and it is appropriate for the liability under each Act to continue as it is.
- 26. Subsection (3) provides for those existing statutory liabilities of the Commissioners to remain with them even if the land that is subject to one of the local Acts mentioned in this clause is transferred to another person.
- 27. Subsection (4) qualifies clause 1(3) so that the reference there to an "instrument" does not include any of the local Acts mentioned in this clause. There might otherwise be a conflict between the operation of the two clauses.

## Clause 3 – Future liabilities

- 28. Subsection (1) is concerned with the future liability of the Commissioners following their acquisition of land to which chancel repair liability is attached. The liability would, on the acquisition, take effect instead as a statutory duty.
- 29. Subsection (2) provides for the extent of the chancel repair liability in such a case to crystallise immediately before the acquisition.
- 30. Subsection (3) provides that any notices or other entries at HM Land Registry relating to chancel repair liability that would otherwise have taken effect as an interest in or over the land being acquired will cease to have effect on the acquisition of the land.
- 31. Subsection (4) provides that the clause also applies to an acquisition of land by a subsidiary of the Commissioners.

## Clause 4 - Liabilities on cathedrals

- 32. As things stand under section 28(6) of the Cathedrals Measure 2021 (or, where it is not yet in force, section 25 of the Cathedrals Measure 1999), the Chapter of each cathedral has a statutory duty in respect of chancel repair liability. But each Chapter is supported in carrying out that duty by the Commissioners who have a discretion to make grants to Chapters from their general fund.
- 33. Subsection (1) provides for the conversion of the current statutory liability of a Chapter into a statutory duty of the Commissioners. It refers only to the Cathedrals Measure 2021 because, by the time this Measure comes into force, that Measure is likely to apply to most, if not all, cathedrals. (The 2021 Measure has a phased implementation diocese-by-diocese.)
- 34. Subsection (2) provides that the extent of the chancel repair liability in each such case will crystallise immediately before its conversion into a statutory duty of the Commissioners under subsection (1).
- 35. Subsection (3) provides that any notices or other entries at HM Land Registry relating to chancel repair liability which would otherwise have taken effect as an interest in or over the land concerned would cease to have effect on the conversion of the liability into a statutory duty of the Commissioners.
- 36. Subsection (4) is a transitional provision. It ensures that if, when this Measure comes into force, the Cathedrals Measure 1999 still applies to any cathedral, subsection (1) of this clause as it applies to that cathedral is to be read as referring to the 1999 Measure (and not to the Cathedrals Measure 2021).
- 37. Subsection (5) makes a consequential repeal of section 28(6) of the Cathedrals Measure 2021, as it will have been superseded by this clause.

## Clause 5 – Supplementary matters

- 38. Subsection (1) provides for chancel repair liability under this Measure to be enforced under the Chancel Repairs Act 1932. That Act entitles a PCC to serve a notice of repair and, if the notice is not complied with, to bring proceedings in the county court.
- 39. Subsection (2) provides for disputes about the extent of chancel repair liability under this Measure to be resolved by arbitration. The reference to "arbitration" has the effect of applying the Arbitration Act 1996. Three principles underlie that Act first, achieving a fair resolution by an impartial tribunal without unnecessary delay or cost; second, giving the parties freedom to agree how the dispute should be resolved; third, keeping the court's involvement to a minimum. Flexibility is a key feature, so the parties can adopt procedures suitable to the particular case and avoid unnecessary delay or expense (for example, whether to have legal representation and, if so, at what level).

- 40. Subsection (3) defines the label of "Land Registry entry", used throughout this Measure, as an entry in either of the registers maintained by the Land Registry.
- 41. Subsection (4) defines other expressions used in this Measure. It supplements the standard definition of "land" in Schedule 1 to the Interpretation Act 1978 (which includes "buildings and other structures, land covered with water, and any estate, interest, servitude or right in or over land") by adding an express reference to "mines and minerals". That expression is itself defined by reference to the standard definition in the Law of Property Act 1925. Subsection (4) also defines "subsidiary" as mentioned in paragraph 24 of these Notes.

## Clause 6 – Short title, commencement and extent

- 42. Subsection (3) provides for the main provisions of this Measure to be brought into force by way of commencement order.
- 43. *Subsection (5)* provides that the Measure does not form part of the law of the Channel Islands or the Isle of Man.
