It should be noted that Questions form a substantial section of each Report of Proceedings and may contain important information on many subjects.

The subject categories of the taxonomic index are listed on pages 2–3, and the index itself appears on pages 4–32. The location of each document on the General Synod website² is noted, as well as the page numbers of the relevant *Report of Proceedings* (indicated by the abbreviation RP). For example, the entry:

Pattern of Meetings of General Synod GS 2113 2019 (Feb.); 2019 (Feb.) RP 17-43

means that document GS 2113 can be found among the papers for the February 2019 Group of Sessions, and the debate on the document is reported on pages 17–43 of the February 2019 Report of Proceedings.

The subject index that appears on pages 33–35 lists the main topics of the documents and debates in alphabetical order. It notes the page numbers of *this document* where the names and locations of the relevant papers can be found.

Finally, a complete list of the names and GS/GS Misc numbers of the Synod documents appears on pages 36–46, along with a note of the relevant subject category under which more details can be found in the taxonomic index.
