

## WITHDRAWAL OF *VALUING ALL GOD'S CHILDREN*

*Mrs Rebecca Hunt (Portsmouth)* to move:

'That this Synod:

Recognising widespread criticism and concerns raised at the content and use of *Valuing All God's Children* and following the publication of the Cass Review:

- a. Oppose the use of *Valuing All God's Children* by Church of England schools to justify inappropriate relationships and sex education and harmful pastoral practice towards gender questioning children.
- b. Regret the use of *Valuing All God's Children* against Christians in court to undermine the Church of England's teaching on marriage.
- c. Lament the lack of leadership from the Church of England in not speaking into our schools and culture about issues of identity.
- d. Call for the immediate withdrawal of *Valuing All God's Children* and an apology from the Archbishop of Canterbury and the National Society for the harm it has caused.'
