'GROWING YOUNGER AND MORE DIVERSE' - HEARING AND RESPONDING TO THE VOICES OF YOUNG ADULTS (18-25) (GS 2385)

'That this Synod:

- a) welcome the voice of young adults (aged 18-25) as part of the church of today and commit to intentionally hearing and responding to their voices on a range of items of business in each subsequent group of sessions, employing a range of presentational activities, including surveys, reports, live presentations and videos
- b) invite the formation of a group of up to 200 young adults drawn from across all dioceses to support the leadership development, faith journey and advocacy of young adults
- c) request at least three and up to five young adults as representatives of this group at each session of Synod under Standing Order 122.1 recognising that this group to be the successor to the Church of England Youth Council
- d) welcome the work being done across the whole church to become 'younger and more diverse' ensuring young adults are at the centre of this mission, through implementing a development and advocacy programme for young adults in each diocese to feed into Synod business, and encourage more young adults to consider standing for election in subsequent quinquennia.'

- d) welcome the work being done across the whole church to become 'younger and more diverse' ensuring young adults are at the centre of this mission, through implementing a development and advocacy programme for young adults in each diocese to feed into Synod business, and encourage more young adults to consider standing for election in subsequent quinquennia.'
